Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Humphrey Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Plan Description

The following description of Humphrey Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of HAI Management, Inc. and BHH, Inc. (collectively, the Employer), who are at least twenty-one years of age and have at least two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan adopted certain optional provisions under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) that was signed into law on March 27, 2020. The provisions adopted included coronavirus-related distributions, coronavirus-related loans, suspended loan payments, increased loan limits, and waivers or required minimum distributions for impacted participants. The CARES Act has an amendment deadline of December 31, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a portion of their compensation, as defined, each year to the Plan, up to the maximum allowed by law. Additionally, participants may make after-tax Roth contributions. The Plan provides for automatic enrollment of eligible participants at 5% of eligible compensation, increasing 1% per year on the first day of the subsequent Plan year until the participant reaches 10%. Participants may elect to change contribution levels at any time. Participants who have attained age 50 during the year may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer may make a discretionary matching contribution and a discretionary profit sharing contribution to the Plan each year which will be allocated in accordance with the Plan document. For the year ended December 31, 2024, there were discretionary matching contributions of 50% of the participants' contributions up to 5% of the participants' total compensation deferred. There were no discretionary profit sharing contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Employer's contributions. Participant's accounts may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, compensation, or account balances, as defined. The Plan's investments are participant-directed and allocations of Plan earnings are based upon the performance of the investment funds chosen by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. A participant's rights in the value of their account derived from the Employer contributions are fully vested upon completion of two years of service.

Plan Description (continued)

Forfeitures

Forfeitures of nonvested Employer contributions may be used to pay administrative expenses with any remaining forfeitures used to reduce any Employer contribution. During 2024 and 2023, approximately \$41,000 and \$38,000 of forfeited participant accounts were used to reduce Plan administrative expenses, respectively. At December 31, 2024 and 2023, forfeited nonvested account balances were approximately \$29,000 and \$34,000, respectively. Participants forfeited approximately \$42,000 of unvested Employer contributions during 2024.

Participant Notes Receivable

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. Notes to participants are secured by the respective participant's vested account balance and are subject to interest charges. Interest rates applicable to new notes are determined by the Plan Administrator at a reasonable fixed rate with reference to the economic conditions and interest rates being charged by financial institutions for loans which would be made under similar circumstances. Notes are repaid ratably through periodic payroll deductions over a term not exceeding five years, unless the note is for the purchase of a primary residence.

Payment of Benefits

In accordance with the Plan, a participant may receive the vested value of his or her account upon normal retirement at age 65, early retirement age at 55 (if the participant also has 10 years of service credited), attainment of age 59½, total disability, or termination. Upon the death of a participant, the beneficiary shall be entitled to the full value of the account. Payments shall be made in lump sum.

Before a participant attains the normal or early retirement age or age 59½, he or she may elect to withdraw any or all of his or her pre-tax contributions only in the event of a financial hardship, as defined in the Plan. The Plan Administrator must approve all hardship withdrawals and such distribution shall be limited solely to the participant's contributions.

Administrative Expenses

Certain expenses are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of participant notes receivable or other participant directed transactions are charged directly to the participant's account and are included in these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Notes to Financial Statements

December 31, 2024 and 2023

Summary of Significant Accounting Principles

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Fair Value Measurements footnote for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Upon default, as defined, the Plan Administrator treats the default as a distribution and offsets the outstanding balance of the note against the participant's vested account balance.

Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurement) and the lowest priority to unobservable inputs (Level 3 Measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Fair Value Measurements (continued)

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Party-In-Interest Transactions

Related party transactions include those with fiduciaries or employees of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan invests in various funds of the Plan recordkeeper and Custodians. The fees for investment and management services paid by the Plan to the recordkeeper were \$65,661 for the year ended December 31, 2024. The Employer provides certain administrative services at no cost to the Plan.

Tax Status

The Plan has elected to adopt the prototype plan issued by Ascensus Trust Company. The Internal Revenue Service (IRS) issued an opinion letter on June 30, 2020. In that opinion letter, the IRS stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed in compliance with the applicable requirements of the IRC.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of any Plan termination, participants would become 100% vested in their Employer contributions.

Excess Contribution Liability

During 2024, the Company failed discrimination testing. Management recorded a refund of excess contributions in the amount of \$2,720 on the statements of net assets available for benefits for 2024. Participant excess contributions were refunded in 2025.

Subsequent Events

The Plan evaluated subsequent events through August 12, 2025, the date the financial statements were issued.

During 2025, the Plan was amended to change the Custodian and Trustee of the Plan assets from Ascensus Trust Company to Fidelity Management Trust Company.
