Dear Sir or Madam,


We are writing to respectfully request penalty relief for the late filing of our Form 5500 for the plan year ending 2024. The delay was not due to willful neglect, but rather the result of circumstances beyond our control.

Our Third Party Administrator (TPA), Mykplan ADP, did not notify us of the filing deadline and failed to submit a timely extension on our behalf. We relied on their expertise and assumed all necessary filings were being handled appropriately. Upon discovering the oversight, we made immediate efforts to contact the ADP 401(k) help desk and locate the individual responsible for Form 5500 submissions. Unfortunately, we have been unable to reach the appropriate party despite repeated attempts.

As soon as we became aware of the issue, we began taking corrective action to ensure compliance and prevent future occurrences. We are committed to maintaining the integrity of our retirement plan and have implemented internal safeguards to monitor filing deadlines more closely going forward.

We respectfully request that the IRS and/or DOL consider this explanation as reasonable cause and waive any associated penalties. We appreciate your understanding and remain committed to full compliance with all regulatory requirements.
