Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ACR Homes, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the ACR Homes, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a defined contribution plan which was established on May 1, 1981 and was last amended and restated effective August 26, 2021. The Plan covers substantially all employees of ACR Homes, Inc. (the Company) who have attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Participation

All employees other than nonresident aliens and collectively bargained employees over age 21 are eligible to make salary deferral contributions to the Plan. Eligible employees can enroll on the first day of the next calendar month after meeting eligibility requirements. Once employees are admitted to the Plan, they remain in the Plan until termination of employment and/or withdrawal of their individual account balance from the Plan. An employee's initial eligibility carries over to when the employee is rehired, if applicable (thus rehired employees may be eligible for participation immediately).

Contributions

Each year, participants may contribute on a pre-tax basis up to 60% of compensation or 100% of post-tax compensation into a Roth account. Contributions may not exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

Each year the Company may make discretionary matching and/or profit sharing contributions. All employees enrolled in the Plan are eligible for employer contributions after 1,000 hours of service, provided they are employed on the last day of the plan year. Participants direct the investment of employer contributions allocated to them into various investment options offered by the Plan. The employer elected to make a profit sharing contribution of \$275,000 for the year ended December 31, 2024. There were no employer contributions for the year ended December 31, 2023.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Participant Accounts

Each participant's account is credited with the participant elective deferrals, discretionary matching and elective profit sharing contributions (if any) and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may be up to five years for general purpose loans or more for loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a reasonable rate as determined by the Company based on prevailing interest rates. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document. Interest rates on loans outstanding as of December 31, 2024 ranged from 3.25% to 8.50%. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested in their account after 6 years of service, upon reaching age 65, upon death or upon permanent disability. Termination of employment before any of the above occurs activates the following vesting schedule for the profit sharing portions of their accounts:

Forfeited Accounts

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are used by the employer to reduce discretionary contributions, or to pay certain plan expenses. Forfeitures totaled \$11,033 and \$7,645 for the years ended December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$11,144 and \$3,033 were used to reduce plan administrative expenses in 2024 and 2023, respectively.

At December 31, 2024 and 2023, there were unallocated forfeitures of \$12,157 and \$11,929, respectively, available to be used to reduce employer contributions and/or plan expenses.

Payment of Benefits

Upon termination of employment, death, disability or reaching normal retirement age (65), participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment; or if the balance exceeds \$5,000, may elect to defer the distribution in accordance with Plan guidelines. If the participants' vested account balance is less than \$5,000, the Plan will distribute the participant's vested account balance in a lump-sum payment.

The Plan allows for in-service distributions from all accounts when a participant reaches normal retirement age (59 ½). Distribution from the rollover portion of participants' accounts are allowed at any time. The Plan also allows for hardship withdrawals from all accounts.

Benefit payments are recorded upon distribution to participants.

Investment Valuation and Income Recognition

Investments are reported at fair value (which is equal to contract value for investment contracts in the collective trust fund). Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statements of changes in net assets available for benefits. Distribution processing fees are deducted from the benefits paid to participants and are shown as plan expenses.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through September 16, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of total assets of the Plan invested by the trustee aggregating \$14,669,080 and \$12,843,356 as of December 31, 2024 and 2023, respectively, and the related investment income of \$1,779,225 and \$1,989,208, respectively, for the years then ended. Investment income includes \$6,478 and \$6,509 of interest on notes receivable from participants for the years ended December 31, 2024 and 2023, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the trustee.

2. Certification of Investments (Continued)

Under the terms of the custodial agreement, the trustee manages investment funds on behalf of the Plan. The trustee acts at the direction of the Company and plan participants when initiating purchases and sales of the investments in the investment funds.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements (Continued)

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: The collective trust fund is valued at contract value which is determined by the net asset of units of a bank collective trust. The net asset value, as provided by the trustee, is published as the fund's fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The common collective trust fund held by the plan is determined to be actively traded.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants or their beneficiaries are entitled to a distribution of 100% of their account balances in all funds.

6. Plan Tax Status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024 and 2023, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024 and 2023, and the Plan's federal tax returns generally remain open for three years.

7. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-in-interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Fidelity is the Trustee of the Plan's assets and manages Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

8. Party-in-interest Transactions (Continued)

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
