### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Goodwill Industries of N.E. Iowa, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits - cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits - cash basis for the years then ended, and the related notes to the financial statements.

## Notes to the Financial Statements

---

### (1) Description of Plan

The following description of the Goodwill Industries of N.E. Iowa, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering employees of Goodwill Industries of Northeast Iowa, Inc. (Organization) who have completed six months of service and are age 18 or older, excluding nonresident aliens, bargaining groups (except those represented by the United Food and Commercial Workers Local 31) or program participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan adopted a prototype plan document provided by CCH Incorporated, d/b/a ftwilliam.com. The prototype plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with all applicable requirements of the Internal Revenue Code. Therefore, it believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

#### Contributions

Participants in the Plan may make pretax contributions, Roth contributions or a combination of both up to 100% of their pretax annual compensation, as defined in the plan document, subject to the amounts allowed by IRS regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Organization may elect to contribute to the Plan discretionary matching and/or profit sharing contributions as deemed appropriate by the Organization's Board of Directors. For the years ended December 31, 2024 and 2023, the Organization approved discretionary profit sharing contributions of 3% of each participant's eligible compensation. Generally, participants receive a profit sharing contribution provided they were employed at the end of the plan year. However, if the participant worked more than 500 hours during the plan year or the termination is due to death, disability or occurred after the participant attained normal retirement age, the terminated participant will still receive an employer profit sharing contribution.

Participants also direct the investment of the Organization's discretionary matching contributions and discretionary profit sharing contributions among the aforementioned investment options.

## Notes to the Financial Statements

---

### (1) Description of Plan

#### Participant Accounts

Each participant's account is credited with the participant's elective and rollover contributions and allocations of (a) the Organization's discretionary contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocation of the Organization's discretionary matching contributions is based on participant contributions while allocation of the Organization's discretionary profit sharing contributions is based on participant compensation. Because all accounts are 100% participant directed, Plan earnings are attributable to the investments selected by each participant and allocated to each participant in a manner that reflects the investment experience of each participant's directions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

As of December 31, 2024 and 2023, there were no terminated participants who had requested a distribution but had not yet been paid.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's discretionary contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service.

Forfeited balances of terminated participants' nonvested accounts are held in an unallocated account until they are used to reduce future employer contributions or pay administrative expenses. The amount of unallocated forfeitures as of December 31, 2024 and 2023 was \$70,833 and \$31,452, respectively. During 2024 and 2023, total forfeitures were \$73,528 and \$38,218, respectively. During 2024 and 2023, forfeitures of \$3,406 and \$28,760, respectively, were used to pay Plan expenses and \$37,431 and \$0, respectively, were used to reduce employer contributions.

#### Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000. Generally, the maximum loan amount is the lesser of 50% of the participant's vested account or \$50,000 (reduced by the highest loan balance, if any, during the one-year period ending on the day before the new loan is made). The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25% - 10.50%.

## Notes to the Financial Statements

---

### (1) Description of Plan

#### Payment of Benefits

In-service distributions are permitted in the event of a qualified financial hardship or upon attaining age 59-1/2. Participants may also withdraw any part of their account balance resulting from rollovers at any time.

Upon termination of service, a participant may elect to withdraw any or all of their vested account balance. Distributions of vested terminated participant account balances of \$5,000 or less can be made without the participant's consent.

#### Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statements of changes in net assets available for benefits - cash basis as administrative expenses. All administrative expenses are charged to participant accounts.

#### Third-Party Fee Agreements

In addition to the administrative expenses deducted on the face of the statements of changes in net assets available for plan benefits - cash basis, the various investment providers to the Plan retain investment earnings to help cover their costs of recordkeeping, administrative maintenance and marketing. These fees are deducted from the unit values of the investments, included in the investments' expense ratios and/or are paid by the investment funds or their affiliates. The fees, which approximated 1% of the Plan's investments for the years ended December 31, 2024 and 2023, have been netted against the Plan's investment income.

#### Subsequent Events

Management has evaluated subsequent events through August 27, 2025, the date which the financial statements were available to be issued.

### (2) Summary of Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this basis, contributions and investment income are recognized when received rather than when earned, and expenses and other deductions are recognized when paid rather than when incurred. Consequently, accrued contributions, investment income receivable and accrued expenses as of December 31, 2024 and 2023 are not included in the financial statements.

#### Use of Estimates

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities and the reported changes in net assets available for plan benefits.

## Notes to the Financial Statements

---

### (2) Summary of Accounting Policies

#### Financial Instruments and Concentration of Credit Risk

The Plan's investments subject the Plan to concentrations of credit risk in that substantially all of those investments are held by Principal Life Insurance Company, Principal Global Investors Trust Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal). Following customary practices, the Plan does not hold collateral for debt investments made through this source. The maximum potential credit loss to the Plan is limited to total Plan assets as shown on the accompanying statements of net assets available for plan benefits - cash basis.

#### Valuation of Investments

The Plan invests in the following investments from Principal:

Investments in registered investment companies which are valued using quoted market prices.

The Plan owns units of participation in the collective funds and pooled separate accounts, not underlying assets. The fair value of these investments is based on the underlying securities, which primarily have quoted market prices. Because they are valued similarly to registered investment companies, they are included as Level 1 inputs on the fair value hierarchy in Note 4.

The Plan is invested in a fully benefit-responsive investment contract with Principal Life Insurance Company that is stated at contract value. Principal maintains the contributions in an unallocated general account (GIC). Contributions are deposited into the GIC. The participants' accounts are credited daily with a contractually guaranteed interest rate of 1.55%, and no administration fees are charged unless the Plan liquidates.

Purchases and sales of securities are recorded on a trade-date basis. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Interest, dividend and capital gain income is recorded when received in cash.

#### Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance. Because participant notes receivable are 100% collateralized by the participant's vested account balance, no allowance for loan losses is deemed necessary. Participant notes receivable which are in default, including outstanding balances due upon termination, are taxed to the borrower and accounted for as a deemed distribution.

#### Payment of Benefits

Benefits are recorded when paid.

#### Income Tax Status

Plan management is required to evaluate tax positions taken by the Plan and disclose a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, as of December 31, 2024 and 2023, there were no audits for any tax periods in progress.

### (3) Certified Investment Information

The investment information and participant notes receivable presented in the accompanying statements of net assets available for plan benefits - cash basis as of December 31, 2024 and 2023, all investment income information presented in the statements of changes in net assets available for plan benefits - cash basis for the years ended December 31, 2024 and 2023, and the investment information in the supplemental schedule of assets (held at end of year) as of December 31, 2024 was provided by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the investment custodians.

### (4) Investments

The Plan's investments were held by Principal, which has provided the Plan with certifications that the information below is complete and accurate.

### (4) Investments

The Financial Accounting Standards Board Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

#### Level 1 Fair Value Measurements

The fair value of registered investment companies is based on quoted prices of the shares held by the Plan at year end.

The fair value of collective investment trusts and pooled separate accounts is based on the underlying securities, which primarily have quoted prices, and units of participation held by the Plan at year end.

#### Level 2 Fair Value Measurements

The Plan utilizes no Level 2 inputs.

#### Level 3 Fair Value Measurements

The Plan utilizes no Level 3 inputs.

Gains and losses (realized and unrealized) for the years ended December 31, 2024 and 2023 are reported in net appreciation in fair value of investments on the statements of changes in net assets available for plan benefits - cash basis.

The net appreciation in the fair value of investments is presented in the accompanying financial statements using a cost basis as required by accounting principles generally accepted in the United States of America. Because the financial statements combine realized and unrealized gains, the net results of these two methods is the same.

### **(6) Related Party and Party-In-Interest Transactions**

Goodwill Industries of Northeast Iowa, Inc., the Plan Sponsor, pays fiduciary bond fees and auditing fees for the Plan which totaled \$19,553 and \$13,750 during the years ended December 31, 2024 and 2023, respectively. In addition, the Plan Sponsor provides management and participant data services to the Plan at no charge.

The Plan directly enters into party-in-interest transactions with service providers, including third-party administrators, investment advisors and auditors and purchases and sales of investments sponsored by Principal or its affiliates. Such transactions resulted in administrative fees as reflected in the statements of changes in net assets available for plan benefits - cash basis.

Two of the participants in the Plan also serve as trustees of the Plan.

### **(7) Risks and Uncertainties**

The Plan invests in various registered investment companies, collective investment trusts, pooled separate accounts and a guaranteed interest account. These investments are exposed to various issues such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - cash basis.

### **(8) Plan Termination**

Although it has not expressed any intent to do so, Goodwill Industries of Northeast Iowa, Inc. has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
