Opinion

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of Morrison-Maierle, Inc. Employee Health Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan provides health and other benefits to eligible employees of Morrison-Maierle, Inc. and its subsidiary (the Company), and covered dependents as elected. The Plan consists of benefits sponsored by the Company and provided through the Morrison Maierle, Inc. Group Health Plan Trust (the Trust) and other benefits sponsored by and provided through the Company outside of the Trust. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

Benefits The Plan provides medical, dental, vision, and wellness benefits to the Company. Terminated employees, or their qualified beneficiaries, may elect to continue this coverage under the Consolidated Omnibus Budget Reconciliation Act of 1965 (COBRA) by paying required timely premiums. Grandfathered retired board members and their spouses are also eligible for coverage under the plan, but must pay 100% of the premium. As of December 31, 2024 and 2023, there is one individual covered under this provision.

Medical Benefits: The medical benefits under the Trust are administered by Blue Cross Blue Shield of Montana (Blue Cross) and are self-insured. For the years ended December 31, 2024 and 2023, the Trust is self-insured for medical and pharmacy claims up to an annual attachment point over the deductible of \$3,301,541 and \$3,079,524, respectively, with a maximum per participant stop loss of \$95,000 for each year. Premiums paid to the Trust are provided by the Company and its employees electing coverage under the Plan. Employees are eligible to participate in medical coverage under the Trust the first day of the month following date of hire. Participants contribute 15% of the cost of employee only coverage and 32% of the costs of employee/spouse, employee/children, and family coverage. The Company contributes the remaining 85% and 68%, respectively. Premiums are determined based on historical trends of the Trust and expected experience ratings as determined by Blue Cross.

Dental Benefits: Dental benefits under the Trust are administered by Blue Cross and are self-insured. Premiums paid to the Trust are provided by the Company and its employees electing coverage under the Trust. Eligibility is the same as for medical benefits, as noted above. Participants contribute 40% of the cost of coverage under the dental plan and the Company contributes 60%.

Vision Benefits: Vision benefits under the Trust are administered by Vision Service Plan (VSP) and are fully insured. Premiums paid to the Trust are provided by the Company and its employees electing coverage under the Trust. Eligibility is the same as under medical and dental benefits. Participants contribute 40% of the cost of coverage under the basic vision plan, and the Company contributes 60%. Participants may also elect to purchase "premium" vision coverage under the Plan. The employee contributes 79% to 92% of the cost of the premium plan that is over and above the cost of the basic vision option. The Company contributes the remaining 21% to 8%, respectively.

NOTES TO THE FINANCIAL STATEMENTS

(Continued)

Additional benefits provided to participants of the Plan are administered outside of the Trust and include the following:

Life, Accidental Death and Dismemberment, and Short-Term and Long-Term Disability Benefits: The Plan provides for life, accidental death and dismemberment, and short-term and long-term disability benefits, which are provided by the Lincoln National Life Insurance Company. The Company contributes 100% of the premiums for these benefits.

Health Savings Accounts: The Plan provides for health savings accounts (HSA) that are tax-advantaged, member-owned accounts allowing participants to save pre-tax dollars for qualified medical expenses. The Company contributes a discretionary matching contribution determined annually. Administrative services for these accounts are provided by Optum Bank, Inc. Contribution maximums are defined annually by the Internal Revenue Service (IRS).

Contributions In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections as noted above. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Payment of Benefits The third-party claims processor disburses claim payments that are determined to be due to the person or assignee entitled thereto in accordance with provisions of the Plan. The Plan pays the third-party claims processor an administrative fee for these services.

Plan Termination The Company may amend or terminate the Plan at any time subject to the provisions of the Plan and ERISA. No amendment or termination may discontinue or curtail the benefits that have accrued to any participant or beneficiary prior to the adoption of such amendment or termination. Upon termination of the Plan, all funds of the Plan shall be used to pay all benefits accrued under the Plan and to pay additional benefits for participants as determined by the Plan administrator. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Stop-Loss Coverage The Plan has entered into a stop-loss insurance agreement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as aggregate exposure for all claims).

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The accompanying financial statements of the Plan are presented on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents The Plan considers money market funds to be interest-bearing cash and included with investments.

Credit Risk Deposits with financial institutions that potentially subject the Plan to concentrations of credit risk consist principally of cash deposits. The Plan's bank accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000. As of December 31, 2024 and 2023, bank balances exceeded their insured limits by \$680,047 and \$597,630, respectively.

Investment Valuation and Income Recognition Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies and procedures. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Bank Insured Deposit Program: Valued at fair value of deposits held as reported by the banks within the program, including interest earned at the established rate and credited during the period.

Certificates of Deposit: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

See note 3 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits Premiums paid by either the Company or the trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claims payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claim administrators in the accompanying statements of net assets available for benefits.

Expenses The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators, actuaries, auditors, benefit administrators, and wellness providers. These expenses are reported on the statements of changes in net assets available for benefits as administrative, professional, and wellness expenses. All other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Stop-Loss Coverage Premiums for stop-loss insurance are included in premiums paid in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$234,605 and \$355,643 for the years ended December 31, 2024 and 2023, respectively, have been netted with claims paid to participants in the accompanying statements of changes in net assets.

Rebates Rebates are recorded as received by the Plan. They are presented with medical and dental claims expense in the accompanying statements of changes in net assets available for benefits. Rebates for the years ended December 31, 2024 and 2023, amounted to \$166,820 and \$155,654, respectively.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

4. BENEFIT OBLIGATIONS

The estimated incurred but not reported obligation includes estimates for benefit obligations associated with reported claims, which were not yet paid prior to year-end and estimates for claims incurred but not submitted to the Plan prior to year-end. These estimates are based, in part, on the Plan's experience and on claims data provided by the Plan's third-party claims administrators. Changes in the estimated cost to settle unpaid claims are charged or credited to the statements of changes in benefit obligations periodically as the estimates are revised.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As documented in note 1, the Plan is administered by Blue Cross, VSP, and OPTUM Bank. Wellness programs are administered by the Company.

The Plan pays premiums to Lincoln National Life Insurance Company, who provides fully insured benefits. Premium expense for 2024 and 2023, was \$265,158 and \$206,973, respectively.

6. TAX STATUS

The Plan received a favorable determination letter from the IRS on June 26, 2008, stating that the Plan is tax-exempt under the provisions of Section 501(c)(9) of the *Internal Revenue Code* (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. As a result of the Plan's funding policy, from time to time the trust may be subject to income taxes.

The Plan recorded \$32,180 and \$21,496 for federal and state income taxes in 2024 and 2023, respectively, for unrelated business taxable income on amounts in excess of IRC qualified reserves. The Plan's policy is to include penalties and interest associated with income taxes in miscellaneous expense.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
