***Opinion***

We have audited the accompanying financial statements of Expeditors International of Washington, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### ***1. Description of Plan***

The following description of the Expeditors International of Washington, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Expeditors International of Washington, Inc. and certain subsidiaries (collectively, the Employer) who are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer is responsible for oversight of the Plan. The Plan's Advisory Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and is comprised of members of the Employer's management. The Employer is the Plan's sponsor and administrator. The Plan's investments are held by T. Rowe Price Trust Company (the Trustee), and participant account records are maintained by T. Rowe Price Retirement Plan Services, Inc. (TRPS).

#### ***Employee Participation and Contributions***

Eligible employees are automatically enrolled in the Plan 30 days after their date of hire. Under the terms of the automatic enrollment provision, the Employer withholds 5% of each eligible employee's compensation each payroll period, increased by 1% annually, up to a maximum of 15%, unless the participant makes an affirmative election not to defer or to defer more or less than the automatic deferral percentage. Participants may contribute up to 75% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to categorize a portion or all of their contribution under the Plan's Roth deferral feature. Contributions are funded to the Plan following each pay date. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Employer Contributions***

The Employer may elect, at its discretion, to make matching contributions to the Plan. There is no service requirement to receive the Employer matching contribution. During 2024, the Employer matched 100% of each eligible participant's contributions (excluding rollovers) up to \$3,000. Matching contributions are funded to the Plan following each pay date.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, as well as the Employer's contributions and participant account earnings. Participants direct the investment of their account balances into various investment options offered by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The participant is entitled to their vested account balance.

#### ***1. Description of Plan, continued***

##### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant vests at the rate of 20% per year and is 100% vested after five years of credited service. A year of credited service is defined as completing 1,000 hours during a Plan year. In the event a participant reaches normal retirement age (59.5), death or disability, a participant's account becomes fully vested.

##### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions. Participant accounts may be charged administrative expenses for loan initiation and an annual loan maintenance fee.

##### ***Payment of Benefits***

On termination of service, a participant or their beneficiary may elect to receive a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. Distributions may also be made in installments to comply with minimum distribution rules required by the Internal Revenue Code (the Code). The Plan permits in-service withdrawals to participants meeting certain requirements, including distributions for financial hardship. Furthermore, a participant may withdraw the portion of their vested account resulting from rollover contributions at any time. Participant accounts may be charged administrative expenses for taking a distribution from the Plan.

##### ***Forfeited Accounts***

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$99,851 and \$21,596, respectively, and are included in investments at fair value. Forfeitures were used to reduce Employer matching contributions. During 2024, forfeitures totaling \$1,078,539 were used to reduce Employer matching contributions.

#### ***2. Summary of Accounting Policies***

##### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***2. Summary of Accounting Policies, continued***

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Contributions***

Contributions from plan participants and contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Loan initiation and annual loan maintenance fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as benefits paid to participants on the basis of the terms of the plan agreement.

##### ***Payment of Benefits***

Benefits are recorded when paid.

##### ***Administrative Expenses***

Expenses charged by TRPS to maintain the Plan are paid by the Employer for all active participants. For terminated participants, the recordkeeping fee is charged to the participants' account. Additionally, participant accounts are charged by TRPS for distributions, requests for payments to be sent via express delivery, Qualified Domestic Relations Orders, loan initiation, and annual loan maintenance. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

##### ***Subsequent Events***

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

#### **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trust funds: Valued at the NAV provided by the trustee of the funds. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

#### 3. Fair Value Measurements, continued

Participants may initiate redemptions in the collective trust funds on a daily basis. The redemption notice period for the retirement date funds may be up to 30 days. The redemption notice period for the stable value fund may be up to 12 months. Were the Plan to initiate a full redemption of the collective trust funds, written notice would be required and the transfer will be within twelve months following the written notice. There are no unfunded commitments.

#### 4. Related-Party and Party-In-Interest Transactions

Certain plan investments are managed by the Trustee. Therefore, transactions with the Trustee qualify as party-in-interest transactions. Notes receivable from participants held by the Plan are also party-in-interest transactions under ERISA. In addition, expenses paid by the Plan are to parties-in-interest as defined by ERISA. Fees paid by the Plan to TRPS amounted to \$179,429 for the year ended December 31, 2024 and are included in administrative expenses within the statement of changes in net assets available for benefits. TRPS charged the Plan \$67,925 for loan fees, \$76,534 for recordkeeping fees of terminated participants, and \$34,970 for participant transaction fees (express delivery fees and distribution fees). Furthermore, as described in Note 6, the Employer has adopted a TRPS pre-approved defined contribution plan.

#### ***5. Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their Employer contributions.

#### ***6. Tax Status***

The Employer has adopted a TRPS pre-approved plan document that has received an opinion letter from the IRS dated August 19, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan documents, the Plan administrator and TRPS believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ***7. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts as reported in the financial statements.
