- 23) We have no knowledge of any instances of noncompliance or suspected noncompliance with laws and regulations (including ERISA, DOL, and IRS regulations) whose effects should be considered when preparing financial statements.
- 24) We have disclosed to you the identity of the Plan's related parties and parties in interest and all the related-party and party-in-interest relationships and transactions of which we are aware.
- 25) The Plan has satisfactory title to all owned assets, which are recorded at fair value, and all liens, encumbrances, or security interests requiring disclosure in the financial statements have been properly disclosed.
- 26) We have no—
  - a) Plans or intentions that may materially affect the carrying value or classification of assets and liabilities.
  - b) Intentions to terminate the Plan.
- 27) Amendments to the Plan instrument, if any, have been properly recorded or disclosed in the financial statements.
- 28) The Plan has complied with all aspects of contractual agreements that would have a material effect on the financial statements in the event of noncompliance.
- 29) The methods and significant assumptions used to estimate fair values of financial instruments, including non-readily marketable securities, are as follows: The money market fund is valued at stated cost, which approximates fair value. The mutual funds are valued at fair value based on market-based inputs, or directly or indirectly observable inputs, that are corroborated by the market data. The methods and significant assumptions used result in a measure of fair value appropriate for financial measurement and disclosure purposes.
- 30) We are responsible for the estimation methods and assumptions used in measuring assets and liabilities reported or disclosed at fair value, including information obtained from brokers, pricing services, or other third parties. Our valuation methodologies have been consistently applied from period to period. The fair value measurements reported or disclosed represent our best estimate of fair value as of the measurement date in accordance with the requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement . In addition, our disclosures related to fair value measurements are consistent with the objectives outlined in FASB ASC 820.
- 31) All required amendments to and filings of plan documents with the appropriate agencies have been made.



- 32) The Plan is qualified under the appropriate section of the Internal Revenue Code and we intend to continue them as a qualified plan. The Plan sponsor has operated the Plan in a manner that did not jeopardize this tax status. Required nondiscrimination testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.
- 33) The Plan either complied with or has made corrective contributions using an IRS approved method and is now compliant with the DOL's regulations concerning the timely remittance of participant contributions to trusts containing assets for the Plan.
- 34) The Plan has complied with the Fidelity bonding requirements of ERISA.
- 35) We have apprised you of all communications, whether written or oral, with regulatory agencies concerning the operation of the Plan.
- 36) We have obtained appropriate fee disclosures from covered service providers and have concluded the fees are reasonable. The Plan is in compliance with DOL regulations regarding ERISA Section 408(b)(2).
- 37) We acknowledge our responsibility for presenting the Schedule H Line 4(i) and Schedule H Line 4(a), in accordance with U.S. GAAP and in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. We believe the form and content of the Schedule H Line 4(i) and Schedule H Line 4(a) are fairly presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The methods of measurement and presentation of the supplemental schedules have not changed from those used in the prior period, and we have disclosed to you any significant assumptions or interpretations underlying the measurement and presentation of the supplemental schedules.
- 38) We have obtained the SOC 1 report from our service organizations SS&C, Paylocity, and Voya Financial. We have determined a SOC report from Nationwide was not necessary given their transition to SS&C. We have reviewed such reports, including the complementary user controls. We have implemented the relevant user controls, and they were in operation for the year ended September 30, 2024.
- 39) We acknowledge our responsibility as management to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date of the financial statements are available to be issued. We have performed this analysis and represent that we believe that no such doubt exists as of the date of this report.
- 40) We have made corrections for prohibited transactions including late remittances, missed and incorrect employee and employer contributions for all affected employees using an IRS approved methodology.



- 41) We have evaluated and determined the Nationwide Fixed Select Contract asset held by the Plan is a fully benefit responsive contract and presented consistent with US GAAP.
- 42) We understand we are responsible for the timely and accurate filing of forms 5558 and 5500.
- 43) The Plan intends to liquidate the contract at Nationwide over a period of time to receive the book value and not liquidate the investment for the market value.
