Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Binswanger Enterprises, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of Binswanger Enterprises, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 401(k) retirement plan available to all employees of Binswanger Enterprises, LLC, (the "Company") with the exception of leased employees and independent contractors. Employees are eligible for salary deferrals after thirty days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to defer any percentage of their eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants are automatically enrolled thirty days after date of hire to defer three percent (3%) of their eligible compensation. The Plan also provides for a contribution accelerator which automatically increases participant contributions one percent (1%) each year on January 1 until the participant's contribution rate reaches six percent (6%). Participants who have reached the age of fifty (50) before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified retirement plans. The Company may make discretionary matching and profit sharing contributions to the Plan in amounts determined by the Company. The Company made discretionary matching contributions equal to twenty-five percent (25%) of the first six percent (6%) of eligible compensation that a participant contributed to the Plan during 2024 and 2023. There were no discretionary profit sharing contributions in 2024 or 2023.

Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options offered by Principal Trust Company (Principal) which includes mutual funds, pooled separate accounts, and common/collective trust funds.

Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Company's discretionary matching contribution, if any, and a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in their deferral contributions plus earnings thereon. Participants become fully vested in Company discretionary matching contributions and related earnings after two (2) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

Notes receivable from participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount that can be borrowed is \$1,000. A participant may borrow from the Plan twice during a rolling twelve month period but may only have one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is repaid ratably through payroll deductions.

Payment of benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive account distributions in the form of a lump sum payment or installments over a period of time as defined in the plan document. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59½.

Forfeited accounts

If an employee terminates before his or her Company discretionary matching contribution account has become fully vested, such portion of the account is forfeited. Forfeitures may be used to pay plan expenses or used to offset employer contributions.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Note 2 - Summary of significant accounting policies (continued)

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions are charged directly to the respective participant's account and are included in administrative expenses as shown on the statements of changes in net assets available for benefits. Certain investment related expenses are included in the net appreciation in fair value of investments.

Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and the schedule of assets (held at end of year) is complete and accurate.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the schedule of assets (held at end of year).

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - Fair value measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) per share and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled separate accounts: Invested in domestic stocks. Valued using observable level 1 quoted pricing inputs in determining the net asset value (NAV) of the pooled separate accounts. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP for investment companies. Most of the security prices were obtained from a pricing service, Interactive Data Corporation.

The fair value of the investments in the common/collective trust funds has been estimated using the net asset value of the investments. Such investments are redeemed on a daily basis and do not have any redemption restrictions. Additionally, there are no unfunded commitments.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments include interests in certain mutual funds, common/collective trust funds, and pooled separate accounts managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these investments and related investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of the investments as they are paid through revenue sharing, rather than a direct payment. Fees incurred by the Plan for administrative expenses totaled \$140,958 in 2024 and \$134,634 in 2023. The Company pays directly any other fees related to the Plan's operations.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Tax status

The IRS has determined that the Non-Standardized Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed Principal of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, plan management believes that the Plan and related trust is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 8 - Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 16% and 15% of the Plan's investments were invested in the Principal LifeTime Hybrid 2030 Fund and the Principal LifeTime Hybrid 2025 Fund, respectively. At December 31, 2023, approximately 16% and 18% of the Plan's investments were invested in the Principal LifeTime Hybrid 2030 Fund and the Principal LifeTime Hybrid 2025 Fund, respectively.

Note 9 - Subsequent events

Plan management has evaluated subsequent events through July 30, 2025, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
