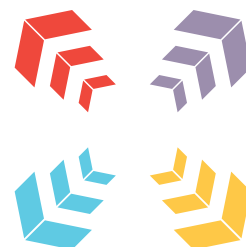

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Velocity Machine, Inc. 401(K) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Basis for Opinion

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Velocity Machine, Inc. 401(K) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established in January of 2008 by Velocity Machine, Inc. (“the Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Eligibility**

As defined by the Plan, all employees who have attained the age of 18 and completed 250 hours of service within the 3 month time period following the employee’s date of hire, or have satisfied a year of service if they do not meet the 250 hour requirement, are eligible to participate. Employees will be credited with a year of service at the end of the twelve month period, beginning on employee’s date of hire, if credited with at least 1,000 hours of service during such period. Employee’s entry date is the first day of the quarter following the date employee satisfied the eligibility requirements.

Long-term part-time employees (LTPT) are employees who have not entered the Plan as a regular participant, who are credited with at least three consecutive years beginning after December 31, 2020 with at least 500 hours of service in each and who attained age 21. Typically, that means they will not be eligible to defer prior to 2024. They will become eligible to defer on the first day of the first month or seventh month of the Plan year following or coincident with the date they meet the requirements to be a LTPT employee. Union employees and nonresident aliens are not LTPT employees. LTPT employees are subject to the same deferral rules which apply to regular participants.

**Employee Contributions**

Participant may elect to defer a specific percentage or dollar amount of compensation each pay period. Participant’s contributions (deferrals) in any tax year may not exceed the lower of a dollar limit set by law (\$23,000 and \$22,500 for 2024 and 2023, respectively) or 100% of eligible compensation. Participants who are 50 years or older before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation with no automatic increases. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one stable value option investment and twenty seven mutual funds. Participants may elect to have any portion, or all, of their contributions designated as Roth 401(k) contributions. Contributions are subject to certain limitations.

**Company Contributions**

Matching contribution – The Company will make a matching contribution equal to 100% of elective deferrals, not exceeding 3% of compensation, plus 50% of each elective deferral in excess of 3% but not in excess of 5% of compensation, for each payroll period.

**Company Contributions – continued**

Discretionary nonelective contribution – The Company may make an annual discretionary nonelective contribution in an amount to be determined by the Company, but not exceeding 4% of compensation. The Company did not make any discretionary nonelective contributions for the years ended December 31, 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions and an allocation of the Company's contribution; and Plan earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Participants who leave the Plan because of death, disability, or attainment of normal retirement age, as defined in the Plan document, are considered 100% vested. Vesting in the Company's matching and discretionary nonelective contribution portion of their account plus actual earnings thereon is based on years of continuous service based on the following schedule:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their vested account balance. Participants may only have one outstanding loan at a time. Loan terms range from one to five years, unless it is for the purchase of the participant's principal residence, in which the repayment period cannot exceed ten years. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. In the event of default, death, or termination of employment, remaining principal and all accrued, but unpaid, interest will be reported as taxable income if not repaid by the end of the grace period.

**Payments of Benefits**

The form of benefit payments depends on the participant's vested account balance. If the account balance is less than \$5,000 but more than \$1,000, it will be automatically rolled into an IRA account for the participant. Terminated employees with vested account balances of less than \$1,000 are required to take a lump-sum distribution. If the account balance exceeds \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan.

**Forfeited Accounts**

When terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to pay Plan expenses, used to reduce any nonelective contribution, or used to reduce a matching contribution. Company contributions for the years ended December 31, 2024 and 2023 were reduced by \$0 from forfeited nonvested accounts. The Plan's expenses for the years ended December 31, 2024 and 2023 were reduced by \$2,853 and \$1,310, from forfeited nonvested accounts, respectively.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions from net assets during the reported period. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Allowance for credit losses is zero as of December 31, 2024 and 2023.

**Investment Valuation and Income Recognition**

Investments are stated at fair value using methodologies described in Note D - Fair Value Measurement. The change in the difference between fair value and the cost of investments is reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. The realized gain (loss) on sale of investments is the difference between the proceeds received and the cost of investments sold. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Risks and Uncertainties**

The Plan invests in various investment securities. These securities are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain values of investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the accounting standards are described as follows:

- Level 1      Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
  
- Level 2      Inputs other than quoted prices within Level 1 that are observable for asset or liability, either directly or indirectly, such as:
  - a. Quoted prices for similar assets or liabilities in active markets
  - b. Quoted prices for identical or similar assets or liabilities in inactive markets
  - c. Inputs other than quoted prices that are observable for the asset or liability
  - d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs that are unobservable inputs for the asset or liability.

**Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualified under Section 401 of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

**Income Tax Status – continued**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. All years not closed by the statute of limitations remain open for examination by tax jurisdictions.

**NOTE C – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Transamerica Retirement Solutions, LLC, has certified that the following data included in the accompanying financial statements and supplementary schedule was complete and accurate:

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related amounts included in the financial statements and supplementary schedule.

**NOTE D – FAIR VALUE MEASUREMENT**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Stable value/Insurance company general account: A group annuity contract valued at the contract value. The guaranteed stable value account does not have specific underlying assets assigned to it and is supported by the general assets of Transamerica Retirement Solutions.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**NOTE E – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of registered investment company funds managed by Transamerica Retirement Solutions. Transamerica Retirement Solutions, is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services amounted to \$72,769 and \$56,032 for the years ended December 31, 2024 and 2023, respectively.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE G – CONCENTRATIONS**

The Plan holds certain investments that represent 10% or more of the Plan's assets available for benefits. As of December 31, 2024, the Plan held one investment totaling \$963,248 that was greater than 10% of the Plan's net assets available for benefits. As of December 31, 2023 the Plan held one investment totaling \$792,364 that were greater than 10% of the Plan's net assets available for benefits.

**NOTE H – ADMINISTRATION OF PLAN ASSETS**

The Plan's assets are administered under a contract with the trustee of the Plan. The trustee invests fund received from contributions, investments sales, interest and dividend income and makes distribution payments to participants.

**NOTE I – RISK AND UNCERTAINTIES**

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act (SECURE) of 2019, which contained the largest package of retirement system reform in over a decade. Many of the provisions of the SECURE Act were effective on January 1, 2020, and required significant changes to plan administration and recordkeeping.

The Families First Coronavirus Response Act (FFCRA) and the Coronavirus Aid, Relief and Economic Security (CARES) Act were enacted in March 2020 in response to the coronavirus outbreak, which among other things contain numerous tax, funding and other provisions that affect employee benefit plans. SECURE and CARES Acts amendments were added to the Plan in January 2023 and were effective January 1, 2020.

In December 2022, the Consolidated Appropriation Act of 2023 was signed into law. It includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into other retirement systems, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. There are several required changes that are effective for plan year beginning on or after January 1, 2024 and optional changes for sponsors to consider that are available upon enactment. The Company is in the process of implementing these and amendments to plan documents are unknown as of the date on which the financial statements were available to be issued.

**NOTE J – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 18, 2025, the date on which the financial statements were available to be issued.
