## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Laurel Lake Retirement Community, Inc. Section 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statement section:

NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following brief description of the Laurel Lake Retirement Community, Inc. Section 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, established January 1, 2014, is a defined contribution plan covering all employees of Laurel Lake Retirement Community, Inc. ("Laurel Lake"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Laurel Lake Board of Directors is responsible for oversight of the Plan. Laurel Lake's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to Laurel Lake's Board of Directors.

**Contributions**

The Plan provides for employee salary deferrals subject to limitations established by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Laurel Lake may elect to make discretionary employer matching contributions to participants' accounts as determined periodically by Laurel Lake's Board of Directors. In 2024 and 2023, Laurel Lake elected to make matching contributions of 100% of eligible contributions up to 4% of eligible wages. Discretionary matching contributions totaled \$116,563 in 2024 and \$113,376 in 2023.

Laurel Lake may elect to make additional employer discretionary contributions to participants' accounts as determined periodically by Laurel Lake's Board of Directors. Laurel Lake made a contribution of \$-0- and \$18,106 in 2024 and 2023, respectively.

**Participant Accounts**

Separate accounts for each participant are maintained by the custodian. Each account is credited with the participant's contributions, employer contributions, and earnings or losses from investments held in the account. Each account is charged with an allocation of administrative expenses based on participant earnings, account balances, or specific participant transactions as defined.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment options daily.

**Note 1. Description of Plan (Continued)**

**Vesting**

Participants are immediately vested in their contributions and earnings thereon. Employees hired prior to January 1, 2018 vested in employer contributions immediately. Employees hired on or after January 1, 2018 vest in employer contributions over a five-year period. Participants vest 25% after two years of service which increases by 25% each year until fully vested.

Forfeitures of nonvested accounts are to be used to pay administrative expenses of the Plan or reduce the employer contributions at the discretion of Laurel Lake. Forfeitures of \$16,480 and \$13,027 as of December 31, 2024 and 2023, respectively, were used to offset Plan expenses. Forfeited amounts not allocated to participant accounts totaled \$3,170 at December 31, 2024 and \$13,358 at December 31, 2023.

**Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. Repayment of a note must be made over a period not to exceed five years unless the note is used to purchase a principal residence, in which case the note is to be repaid over a reasonable period of time that may exceed five years. The note interest rate is set at the prime rate, as defined by the Plan document. Principal and interest is paid through payroll deductions.

**Payment of Benefits**

Participants who suffer serious financial hardship, as defined by the Plan, may withdraw a portion of their vested account in order to meet their financial needs. Once participants attain age 59½, they may also elect to withdraw from their account any amount not to exceed their vested portion. All accounts are subject to distribution upon the participant's termination, retirement, or death.

On termination of service, participants may elect to receive a lump sum distribution equal to the vested value of their account balance, a partial lump sum distribution not to exceed the vested value of their account balance, or installments over a period of time not to exceed the life of the participant.

**Termination Provisions**

The Company anticipates and believes that the Plan will continue indefinitely; however, the Company reserves the right to terminate the Plan at any time by an action of its Board of Directors. In the event of termination of the Plan, the participants will become 100% vested in their employer contributions and the assets then remaining in the fund will be allocated and distributed to participants in accordance with the terms of the Plan.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by Empower Annuity Insurance Company of America ("Empower"), the Custodian of the Plan. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a settlement-date basis. There is no significant difference between settlement-date basis and trade-date basis for the periods presented. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by Laurel Lake and are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the affected participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Evaluation of Subsequent Events**

The Plan has evaluated subsequent events through August 20, 2025, the date on which the financial statements were available to be issued.

**Note 3. Unaudited Information**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Empower, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the years then ended, the supplemental schedule as of December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 4. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for plan assets measured at fair value. There have been no changes in the valuation methodologies used from 2023 to 2024.

- The fair value of registered investment companies is determined based on their quoted closing market prices in active markets for identical investments and is classified as Level 1.
- The fair value of money market funds is determined based on the quoted closing market prices in active markets for identical instruments and is classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Guaranteed Investment Contract With Insurance Company**

The Plan holds an investment contract which meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting interest rate, which may not be less than 0%, is based on a formula agreed upon with the issuer. Such interest rates are reviewed at least annually for resetting. The contract cannot be terminated before the scheduled maturity date. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

**Note 6. Income Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8. Party-in-Interest Transactions**

Certain Plan investments are managed by Empower, the Custodian, or its affiliates. Empower also receives administrative expenses from the Plan. Therefore, these transactions qualify as party-in-interest transactions.
