We have performed audits of the financial statements of KPA Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of KPA Services, LLC 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2002 and most recently amended effective January 1, 2021. The Plan is available to all employees 18 years or older and excludes leased employees, union employees, and employees hired for special projects. Eligible participants can enter the Plan on the first day of the month immediately following or coinciding with their date of hire. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The board of directors of KPA Services, LLC (the "Company") administers the Plan. Ascensus Trust Company (Ascensus) serves as trustee and manages plan assets. Ascensus, LLC is the recordkeeper for the Plan. Ascensus offers plan participants a variety of investment options at the direction of the participants.

Note 2 - Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Valuation of Investments and Income Recognition

Investments are recorded at fair value, as reported to the Plan by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's retirement plan committee determines the Plan's valuation policy utilizing information provided by the investment advisers and the monitoring of the performance of the Plan's investment funds. See Note 5 for discussion of fair value measurements.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

Note 2 - Significant Accounting Policies (Continued)

Contributions

Participants may make before-tax and after-tax Roth contributions up to 100 percent of their annual eligible compensation, as limited by the IRS, which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions.

The Plan has an automatic deferral provision of 3 percent of the participant's eligible compensation unless otherwise directed, with scheduled increases on the first day of each plan year for the second, third, and fourth plan year to a deferral rate of 4 percent, 5 percent, and 6 percent, respectively.

The Plan is operating pursuant to the safe harbor provisions of the Internal Revenue Code. The Company will contribute safe harbor matching contributions in the amount equal up to 3 percent of eligible compensation, plus 50 percent up to 5 percent of eligible compensation. The safe harbor matching contributions are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. Safe harbor contributions totaled \$1,696,459 for the plan year ended December 31, 2024. The Plan also provides for discretionary matching contributions and profit-sharing contributions for all eligible participants. The Company did not elect to make any discretionary matching or profit-sharing contributions during 2024.

Participant's Accounts

Each participant's account is credited or charged with the participant's contributions and withdrawals, as applicable, and an allocation of the Company's contributions, plan earnings or losses, forfeitures, and plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the Plan. The benefit to which a participant is entitled is the vested portion of the participant's account.

Vesting

Note 2 - Significant Accounting Policies (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of two notes outstanding at any given time. The notes are secured by the balances in the participants' accounts and bear interest at rates that range from 4.25 to 9.50 percent, which are commensurate with local prevailing rates determined by the plan administrator at note origination, and mature at various dates through September 2029. Notes have a maximum term of five years. Principal and interest are paid ratably through payroll deductions. Participant notes are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's note becomes due in full. Notes in the amount of \$1,360 were deemed a distribution during 2024.

Payment of Benefits

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump sum or partial payment in the amount equal to the participant's vested account balance. Benefits are recorded when paid.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. The Plan allows in-plan Roth conversions. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or less to be automatically rolled out of the Plan into a qualified IRA. The IRS has required minimum distributions once a participant reaches age 73 during the previous plan year and is no longer employed by the Company.

Participant Termination and Forfeitures

If at the time of termination of employment the participant is not 100 percent vested, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to pay plan expenses or reduce future employer contributions. There was no forfeiture balance at December 31, 2024 or 2023, and no forfeitures were used during the year ended December 31, 2024.

Related Party and Party-in-interest Transactions

The Plan provides for participant notes, which are party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 10, 2025, which is the date the financial statements were available to be issued.

Note 3 - Plan Merger

During 2023, the Company purchased the membership interests of ComplyNet, LLC. Effective July 2, 2024, the ComplyNet 401(k) Plan and Trust was merged with the Plan. Accordingly, assets of \$739,601 were transferred into the Plan in 2024.

Note 4 - Certified Information

Ascensus holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus, LLC, on behalf of Ascensus Trust Company.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual funds, the money market fund, and interest-bearing cash are valued at quoted prices reported in active markets.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 7 - Plan Administration and Operating Expenses

The Company provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to provisions of ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.
