Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Seneca-Cayuga Tribe 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of fiduciary net position as of December 31, 2024 and 2023, and the related statement of changes in fiduciary net position for the year ended December 31, 2024, and the related notes to the financial statements.

Responsibilities of Management for the Financial Statements

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Seneca-Cayuga Tribe 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all non-union employees of the Seneca-Cayuga Nation (the Nation) who have completed one year of service, as defined, that are eligible to participate, provided they are at least 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may contribute a percentage of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. The Nation provides a Safe Harbor Matching Contribution equal to 100% of Elective Deferrals up to 4% of Compensation. The Nation may elect to make a discretionary contribution in an amount to be determined at the end of the Plan year. There were no discretionary contributions made to the Plan during 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts – Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon as well as employer discretionary contributions and earnings.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, subject to limitations described in the plan document. A participant is allowed two outstanding loans at a time. The loans are secured by the balance in the participant's vested account balance. The maximum loan repayment period is five years unless the loan is for purchase of a residence, in which case the period may be up to 15 years. Loans are payable at least quarterly through payroll withholdings at an interest rate equal to Wall Street Journal prime rate. As of December 31, 2024, the rates of interest range from 3.25 percent to 8.5 percent with various maturities through November 2029.

Payment of Benefits – On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) will automatically be paid a single lump sum if the vested account has a balance of \$5,000 or less. If the Plan's vested amount has exceeded \$5,000, several installment options are available to a participant. In addition, hardship distributions are permitted if certain criteria are met.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan have been prepared in accordance with U.S. generally accepted accounting principles (US. GAAP) as applied to governmental units. The Governmental Accounting Standards Board (GASB) is the accepted standards setting body for establishing governmental accounting and financial reporting principles. The Plan utilizes the basis of accounting applicable financial reporting framework used by tribal entities which meet the definition of a government.

The Plan financial statements are reported using the economic resources measurement focus and the accrual basis of accounting.

Estimates – The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation – The investments are reported at fair value, as certified by the Plan's custodian, John Hancock Life Insurance Company (U.S.A.) (John Hancock). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Notes Receivable from Participants - The participant loans are valued at their outstanding balances, which approximate fair value.

Income Recognition – Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis and interest income from notes receivable from participants is recognized when paid, primarily monthly. Net appreciation includes interest, dividends, and gains and losses on investments bought and sold as well as held during the year. The components of investment earning are not separate out as required by GAAP because the custodian does not provide the separate information. However, management does not believe that this GAAP departure is material to the financial statements.

Payment of Benefits – Benefits are recorded when approved or deemed a distribution.

Administrative Expenses – The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Sponsor. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

Subsequent Events

Subsequent events have been evaluated through the date of the auditor's report. This is the date the financial statements were available to be issued.

Fair Value Measurements

GASB provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation Methodologies:

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts - The Plan has investments in participation units held in pooled separate accounts through sub-accounts of John Hancock. The underlying securities in pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company denotes readily determinable fair value. These pooled separate accounts are classified in Level 1 in the fair value hierarchy.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the net asset value of the pooled separate accounts, and consequently, the fair value of the Plan's investments.

Fair Value Measurements (Continued)

Guaranteed interest accounts – The Plan holds guaranteed interest accounts with John Hancock. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest accounts promise contract value for a benefit event (termination, death, disability and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus the guaranteed interest accounts are considered non-benefit responsive. Fair market value is the amount that would be received were the funds to be withdrawn or transferred within the Plan prior to maturity. The guaranteed interest accounts are classified in Level 1 in the fair value hierarchy.

NOTE 5 – INVESTMENTS

Investment securities are exposed to various risks that can affect the value of the Plan's investments such as interest rate risk, custodial credit risk, and concentration of credit risk. The Plan invests in registered investment companies (mutual funds). Mutual fund holdings in equity securities respond to such factors as economic conditions, individual company earnings performance, and market liquidity, while holdings in debt securities are particularly sensitive to credit risk and change in interest rates.

Interest rate risk

Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed-rate security and adversely affect the selling price of the security prior to maturity. The price of a debt security typically moves in the opposite direction of the change in interest rates. As of December 31, 2024, the Plan had the following investments subject to interest rate risk:

NOTE 6 – PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and cash and cash equivalents managed by John Hancock. John Hancock is the plan custodian, as defined by the Plan. Johnson Rouse & Associates, PLLP is the third party administrator. Therefore, transactions with John Hancock are considered to be party-in-interest transactions.

The Plan also has notes receivable from participants, which also qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Nation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Nation may determine.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment Securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the Statement of Fiduciary Net Position.

NOTE 9 – TAX STATUS

The Seneca-Cayuga Tribe 401(k) Profit Sharing Plan is a prototype standardized profit sharing plan. The Internal Revenue Service has issued an opinion letter to the prototype sponsor dated March 31, 2014, stating the prototype plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has not requested a determination letter from the Internal Revenue Service. The Seneca-Cayuga Tribe 401(k) Profit Sharing Plan has adopted only standardized provisions of the prototype plan.

The Plan is subject to routine audits by taxing jurisdictions. In general, the Plan's returns are subject to examination by federal tax authorities for a period of three years beginning with the later of the due date of the return or the date they are filed. There are currently no examinations in progress.
