## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
New Berlin Plastics 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of New Berlin Plastics 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The New Berlin Plastics 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 4, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - New Berlin Plastics, Inc. is the plan administrator, sponsor and employer. Three officers of the employer are the trustees of the plan. Blue Chip Retirement Plans, Inc. is the plan's third party administrator that maintains plan records and performs various compliance tests as tax counsel. Osaic Wealth, Inc. is the plan's investment advisor. Empower Trust Company, LLC holds custody of the plan's mutual fund investments. Empower Annuity Insurance Company of America holds custody of the plan's guaranteed portfolio investment. Empower Retirement, LLC maintains participant records and is the brand name which refers to the products and services provided by the Empower entities discussed above, collectively referred to as "Empower".

**Investments** - The plan administrator determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the prospectuses and investment account summaries for more information. Earnings on investments bought, sold and held during the years are reflected in the accompanying statements of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the funds or applicable exchange. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

The methodology for calculating the interest crediting rate is based on the prevailing market conditions and earnings of medium-long term investments compared to a minimum interest crediting rate, as more fully described in the plan's contract with Empower. The interest crediting rate is reset quarterly. The average yield earned by the fund was 1.41% in 2024 and 1.23% in 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor may request a full distribution at any time. In the event the plan requests an immediate lump sum distribution, a market value adjustment is calculated or the plan may request the distribution in installments over a period of 12 months at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that might limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was established on November 1, 1989 as a defined contribution plan with 401(k) salary deferral arrangements. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible to participate in the plan once they have completed six months of service and reached 21 years of age. An employee can enter the plan on the first day of the calendar quarter following completion of the eligibility requirements.

**Contributions** - Contributions are recorded in the year in which the plan eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). New employees are automatically enrolled in the plan after reaching eligibility and have 3% of compensation withheld as deferral contributions (auto-enroll). Auto-enrolled employees' percentage of compensation withheld increases by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation. The plan also permits Roth elective deferral contributions.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer safe harbor matching contributions, made bi-weekly to coincide with the employer's payroll, equal to 100% of the first 1% of employee compensation plus 50% of employee compensation that exceeds 1% up to 6%, with annual true-up contributions, which were made in 2024 and 2023.
- d. Employer matching contributions may be made at the employer's discretion. No such employer matching contributions were made in 2024 or 2023.
- e. Employer non-elective contributions may be made at the employer's discretion. No such employer non-elective contributions were made in 2024 or 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions, and an allocation of the employer's contribution. Participants are allowed to change their investment options daily and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, rollover contributions, and related earnings. Participants become 100% vested in the employer safe harbor matching contributions and related earnings after completion of their second year of service. Participants become 20% vested in the employer discretionary contributions and related earnings after completion of their second year of service. The participants then vest at a 20% rate for each year thereafter. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Distributions are made in the form of a single lump sum or installment payments. In addition, hardship withdrawals are permitted under certain circumstances and in-service withdrawals can commence upon attaining the age of 59½.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan processing service fees and nonparticipant directed charges for service, administrative, audit and investment advisory fees. Certain nonparticipant directed charges were paid via forfeitures. The remaining nonparticipant directed charges were allocated to participants on an account value basis.

**Forfeitures** - Forfeited non-vested employer contributions may be used to pay certain plan administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions were \$6,000 in 2024 and \$10,000 in 2023. Forfeitures used to pay administrative expenses were \$10,000 in 2024 and 2023. Unapplied forfeitures were \$7,000 and \$19,000 as of December 31, 2024 and 2023.

**Notes receivable from participants** - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may only have two loans outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence, in which case the maximum term is 10 years. As of December 31, 2024, the notes receivable from participants had various repayment schedules through December 2029 with interest rates ranging from 8.75% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### **3. PARTY-IN-INTEREST TRANSACTIONS**

Empower holds custody of the plan's investment assets and also manages the guaranteed portfolio investment. As such, transactions between Empower and the plan qualify as party-in-interest transactions. Empower receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds. Certain revenues received by Empower from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and Empower). Such service credits received by the plan are used by the plan to pay advisory services and other plan fees. There are also certain other plan expenses that Empower charges that are paid by the plan directly. Direct fees paid by the plan to Empower were \$36,000 in 2024 and \$31,000 in 2023.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **4. TERMINATION OF PLAN**

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

### **5. INCOME TAX STATUS**

The plan adopted a CCH Incorporated non-standardized pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
