**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1: Description of the Plan**

The following description of Candid Color Systems, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

***General***

The Plan is a defined contribution plan sponsored by Candid Color Systems, Inc. (the Company) for the benefit of its employees and their beneficiaries. Related employers who also participate in the Plan include TSS Photography, LLC and Glamour Shots Licensing, Inc. The purpose of the Plan is to enable participants and their beneficiaries to share in the Company's profits and to encourage the loyalty and continuity of service of the participants. An employee becomes eligible for both participation in the Plan and for the company matching contribution upon attaining the age of 21 and completing 180 days of service. The participant is able to enter the Plan on the first day of the following month thereafter. A participant becomes eligible to receive a profit-sharing contribution on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or following the date upon the completion of one year of service and attaining the age of 21. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Empower Retirement refers to the products and services offered in the retirement markets by Empower Annuity Insurance Company of America ("EAICA"), formerly known as Great-West Life & Annuity Insurance Company ("GWL&A"). Empower Trust Company, LLC is a subsidiary of EAICA and is the custodian of the Plan's assets. The Plan administrator is Definiti, LLC.

***Contributions***

The Plan allows participants to make voluntary before-tax salary deferral contributions, through payroll deductions, to separately invested funds in accordance with Section 401(k) of the Internal Revenue Code ("IRC"). If certain requirements of IRC Section 401(k) are not met in Plan operation, the salary deferral agreements of participants may, on a nondiscriminatory and uniform basis, be amended or revoked to preserve the qualified status of the Plan.

Participants may elect to contribute through the Roth 401(k) contribution option on an after-tax basis. The Roth 401(k) contributions qualify for matching contributions and are otherwise subject to the same combined dollar limits applicable to pre-tax contributions.

Eligible participants may make annual contributions to the Plan through a salary deferral election up to 100% of eligible compensation. Employee rollover contributions are also permitted. The Company may make discretionary contributions (matching and profit-sharing contributions) to all eligible participants' accounts. In May 2022, the Company elected to begin providing eligible participants with matching contributions. The Company made a matching contribution of \$102,881 for the year ended December 31, 2024. Contributions are subject to certain limitations. Forfeitures are used to either pay administrative expenses or reduce future discretionary contributions.

***Participant Investment Account Options***

Investment account options include various types of investment securities offered by the Plan. Each participant has the option of directing his or her contributions into any of these investment securities and may change their allocations daily.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's discretionary contributions (if any) and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. The Plan provides for participant vesting of 20% after two years of service, increasing by 20% each year thereafter until 100% vesting is reached after the sixth year of service. The non-vested balance is forfeited upon termination of service.

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Only one outstanding loan at a time is allowed per participant. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repaid over a period not to exceed five years (except for loans for the purchase of a principal residence which can be repaid over a period not to exceed 15 years) through payroll withholdings. The interest rate on a new loan is 2% over the Prime Rate as published in the Wall Street Journal on the first business day of the month that the loan is originated.

***Payment of Benefits***

Upon termination of service due to retirement, death or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or installment payments over a period not to exceed the life expectancy of the participant.

A participant may also elect to receive an in-service distribution in regards to their rollover contributions accounts and after-tax deferral contributions accounts at any time subject to possible administrative limitations on the frequency and actual timing of such distributions.

***Forfeited Accounts***

Forfeitures consist of unvested company contributions in participants' accounts at the conclusion of their participation in the Plan. Forfeitures are held in the Plan and are used to pay administrative expenses or reduce future Company contributions. At December 31, 2024 and 2023, there were \$25,160 and \$24,476, respectively, in forfeited non-vested accounts.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investments Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is based on quoted market prices when available; mutual funds are valued at the net asset value practical expedient (NAVPE). Contract value represents contributions plus interest, less withdrawals and administrative expenses.

Investment transactions are recorded on a trade-date basis. Interest is recognized on the accrual basis, dividends on the ex-dividend date, and net appreciation (depreciation) includes realized and unrealized gains and losses.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Net Appreciation in Fair Value of Investments***

Net appreciation in fair value of investments, as recorded in the accompanying statements of changes in net assets available for benefits, includes changes in the fair value of investments acquired, sold, or held during the year.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion. Direct expenses paid to service providers during the years ended December 31, 2024 and 2023 were \$73,880 and \$71,608, respectively.

**Note 3: Certification of Plan Trustees**

The Plan Administrator has elected the annual reporting method permitted under 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement Services (Empower) has certified the completeness and accuracy of the following information for the years ended December 31, 2024 and 2023, as included in the accompanying financial statements and supplemental schedule:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not audit the certified information, except to compare it to the related disclosures in the financial statements and supplemental schedule.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Empower Trust Company.

**Note 4: Fair Value of Plan Assets**

FASB ASC Topic 820, Fair Value Measurement ("ASC Topic 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual Funds (Level 1):* Valued at the net asset value (NAV) of shares held by the Plan at year-end, based on quoted prices on nationally recognized securities exchanges. Mutual funds held by the Plan are open-end funds registered with the Securities and Exchange Commission, required to publish their daily NAV and transact at that price. These funds are deemed to be actively traded. Self-directed brokerage accounts primarily consist of mutual funds and common stocks valued on the basis of readily determinable market prices.

*Fixed Annuities (Level 2):* Valued at contract value, which represents contributions plus credited interest, less participant withdrawals and applicable administrative expenses. Contract value approximates fair value and is based on observable inputs other than quoted market prices, such as interest crediting rates and administrative provisions.

*Variable Annuities (Level 2):* Valued at the NAV of the underlying investment options at year-end. NAV is determined by the insurance carrier based on the fair value of the underlying assets, less liabilities, divided by the number of outstanding units. These are classified as Level 2 when based on observable market inputs or measured using the NAV practical expedient when redemption is at NAV.

*Collective Trusts (NAV Practical Expedient):* Valued at the net asset value (NAV) per unit as determined by the trustee at year-end. NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund, less any liabilities. This practical expedient is not applied when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan were to initiate a full redemption of its interest in a collective trust, the investment advisor reserves the right to temporarily delay withdrawal in order to allow securities liquidations to be executed in an orderly manner.

***Recurring Measurements***

The Plan's investments (including gains and losses on investments purchased and sold, as well as held during the year) appreciated in value by \$1,245,556 and \$1,221,743 during the years ended December 31, 2024 and 2023, respectively.

**Note 5: Investment Contract with Empower Annuity Insurance**

The Plan participates in a fully benefit-responsive investment contract with Empower Annuity Insurance in the form of a fixed annuity contract. Contributions are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported by Empower Annuity Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. No reserves are held against contract value for credit risk or otherwise.

Certain events may limit the Plan's ability to transact at contract value with the issuer. Such events include:

1. Amendments to the plan documents (including complete or partial plan termination or merger with another plan);
2. Changes to the Plan's restrictions on competing investment options or deletion of equity wash provisions;
3. Bankruptcy of the plan sponsor or other sponsor events (for example, divestitures or spin-offs of a subsidiary) causing a significant withdrawal from the Plan; or
4. Failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not consider the occurrence of any such event, which would limit the Plan's ability to transact at contract value, to be probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6: Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan holds investments in the EI Fixed Account – Series Class III, a fixed annuity contract issued by Empower Annuity Insurance Company of America. Empower Retirement Services serves as the administrator, and transactions involving this investment qualify as party-in-interest transactions under ERISA.

The Company provides certain administrative services to the Plan at no cost.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for plan benefits.

**Note 8: Tax Status**

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Empower Trust Company, LLC, previously known as Great-West Trust Company, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**Note 9: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

**Note 11: SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan documents accordingly. Certain provisions became effective in 2024. There is no material impact to the Plan's 2024 financial statements.

**Note 12: Subsequent Events**

Subsequent events have been evaluated through August 14, 2025, the date the financial statements were available to be issued. No subsequent events were noted that would require disclosure or modification to the financial statements.
