Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Westmoreland Mechanical Testing and Research Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Westmoreland Mechanical Testing and Research Profit Sharing Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Effective December 1, 1979, Westmoreland Mechanical Testing and Research Profit Sharing Plan (the Company) and plan sponsor adopted the Plan. The Plan is a defined contribution plan covering all eligible employees of the Company. An employee may enter the Plan on the first day of January or July coincident with or next following the date on which the employee meets the eligibility requirement of the completion of one year of service and is at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute to the Plan under a voluntary salary reduction arrangement up to the maximum allowed by the Internal Revenue Service. In addition, participants age 50 and over may make additional contributions as allowed under the Internal Revenue Code.

For each plan year, the employer makes safe-harbor matching contributions. The employer will contribute \$1.00 to the Plan for the participant's benefit for each \$1.00 of voluntary salary reduction made to the Plan, up to 4% of the participant's annual compensation. In addition, each year the employer may elect to make discretionary matching contributions.

Non-matching employer contributions (profit sharing) can also be made at the Company's discretion. Non-matching employer contributions are allocated among eligible participants in proportion to compensation in excess of the taxable wage base. No discretionary non-matching or profit sharing contributions were made by the Company for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer's contributions, investment earnings (losses), and charged with withdrawals, if any, and investment fees and expenses.

Vesting

Participants are immediately vested in their voluntary contributions and safe-harbor matching contributions plus actual earnings thereon. Vesting in the remainder of their account balances is based on years of continuous service. A participant is 100% vested after six years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions made on their behalf through investment funds administered by the Plan trustee. Participants may change their investment options directly with the trustee.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Participant Loans

A participant may obtain a loan if they have met the Plan's eligibility requirements. The loans are secured by the balance in the Participant's account and bear interest at a fixed rate determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, a participant will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and use assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The Common Collective Trusts uses unit values to perform daily account valuations.

Benefits

Benefits are recorded when paid.

Forfeitures

These accounts can be used to reduce the future employer contributions or to pay administrative fees in accordance with Plan provisions. In 2024 and 2023, \$0 and \$3,288 respectively of the forfeitures were applied to the Plan expenses.

Administrative Fees

During 2024 and 2023, the Company paid all additional administrative charges except as noted above. Investment fees and commissions are paid by the Plan.

Subsequent Events

Subsequent events were evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 input would only be used when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

The fair value of the investments in Registered Investment Companies is based on the quoted net asset values of the shares as reported by the fund. The funds held by the Plan are open-ended funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The funds held by the Plan are considered to be actively traded.

The Net Asset Value (NAV) is the practical expedient for measurement purposes for valuation purposes for Common/Collective Trusts.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 5 - TAX STATUS

The Internal Revenue Service has stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended and restated to comply with several recent legislative actions since adopting the prototype. However, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan's tax returns are subject to examination by regulatory agencies generally for three years after filed.

NOTE 8 - EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants totaling \$0 and \$39,994 for the years ending December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as accounts payable. The Plan distributed the excess contributions as required.
