## Notes to Financial Statements

December 31, 2024 and 2023

**(1) Description of Plan:**

The following brief description of the Fingerpaint Marketing, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan was established by Fingerpaint Marketing, Inc. (the “Company”) on February 8, 2008 as a defined contribution retirement plan covering substantially all employees of the Company. The Plan is subject to the provisions of ERISA.

The Plan was amended effective January 1, 2020 to be a safe-harbor plan, and was also amended on the same date to include 1798, LLC as a designated employer within the controlled group.

The plan was amended August 1, 2021 to include Leaderboard Branding, LLC and Splice Agency, LLC as designated employers within the controlled group.

The plan was amended and restated effective February 18, 2022 for the Cycle 3 restatement and other legislative and regulatory changes.

The plan was amended January 1, 2023 to include MedThink, LLC as a designated employer within the controlled group.

The plan was amended October 1, 2024 to change the automatic enrollment percentage from 3% to 5%.

Eligibility – Generally, all non-union, US resident employees (excluding interns) of the Company who have attained age 21 are eligible to participate in the Plan immediately upon being hired.

Contributions – Eligible employees may contribute between 1% and 90% of their annual eligible compensation on a pre-tax basis and after-tax (Roth) basis, or a combination of both, as defined by the Plan, subject to Internal Revenue Service limitations. Participants who are age 50 or older may elect to defer additional amounts called “catch-up” contributions. Rollover contributions from another qualified retirement plan or special individual retirement plan are permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will make safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of the eligible participants’ compensation contributed to the Plan. The Company made \$3,355,459 and \$3,147,690 in matching contributions in 2024 and 2023, respectively.

Automatic Enrollment – Upon hire, employees are given a salary deferral agreement to elect to make elective deferrals into the Plan or to decline enrollment. If the agreement is not received once the employee becomes eligible to participate, the employee will have 5% automatically withheld and contributed into a default investment fund selected by the Company as a pre-tax contribution. A notice will be provided prior to the first automatic contribution.

Participant Accounts – Accounts are participant directed. Account balances are tracked in units and the value is updated with the daily market price. As of any business day, accounts are charged or credited with earnings (dividends, capital gains, expenses, and market fluctuations) as well as account activity such as contributions, loans, distributions, and hardships.

### Notes to Financial Statements, continued

**(1) Description of Plan, continued:**

Vesting – Participants are immediately vested in their voluntary contributions and the employer matching contributions, including earnings or losses thereon.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their account balance. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account. The interest rates for 2024 and 2023 ranged from 5.25% to 10.50% for both years. Principal and interest are paid ratably through weekly payroll deductions.

Withdrawal Privileges – Prior to termination, a participant may withdraw all or any portion of his vested account, excluding earnings on elective deferrals, in the event of undue financial hardship. The participant's request for a withdrawal shall include his statement and documentation proving that such a hardship exists and explain its nature. To qualify as a financial hardship withdrawal it must be determined that the withdrawal is to meet an immediate and financial need of the participant and the amount of the withdrawal is not reasonably available from other sources of the participant. Hardship withdrawals are limited to the following: financial needs arising on account of a college education, purchase of a principal residence, major medical expenses, prevention of eviction or foreclosure, burial or funeral expenses, and damage to a principal residence due to fire, storm or other casualty. The Plan Administrator has established uniform, nondiscriminatory guidelines to use in determining if such a condition of undue financial hardship exists. The Plan Administrator's determination shall be final. The participant has no legal or equitable right to such a withdrawal unless the immediate and financial need as defined has been demonstrated.

Withdrawal Provisions – The Plan also provides for in-service distributions for participants that have attained age 59 ½. Such participants will be entitled to receive a distribution of all or a portion of their vested contributions.

Payment of Benefits – Upon termination of service, disability, death or retirement, participants may elect to receive a lump sum or installments equal to the value of their accounts. Upon termination of service, the participants may also elect to roll over the funds into an IRA or to another employer's tax qualified plan. If the participant's account balance exceeds \$5,000 (excluding any rollover contributions plus earnings) he or she may also elect to receive installments or defer receiving payments until age 70 ½. If the participants account balance is between \$1,000 and \$5,000 and they do not elect to receive a lump-sum or a direct rollover, the balance will automatically be rolled over into an IRA established by an IRA provider selected by the Company. If the participants account balance is \$1,000 or less and they do not elect to receive a lump-sum or a direct rollover, the balances will automatically be cashed out in the form of a lump-sum.

Administrative Services – The Plan states that costs incurred in administering the Plan may be paid by the Company, but if not paid by the Company when due, the costs shall be paid from the assets of the Plan. Administrative fees for loan and distribution processing are charged to the participant. The administrative fees paid from the assets of the Plan amounted to \$214,979 and \$197,943 in 2024 and 2023, respectively.

Forfeitures – Forfeitures of participants' non-vested account balances shall become available for payment of administrative expenses or to reduce employer contributions.

#### **(2) Summary of Significant Accounting Policies:**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value, except for common collective trust funds. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to common collective trust funds because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants – Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Use of Estimates – The preparation of the Plan’s financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for common collective trust funds, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 – Fair Value Measurements below for discussion of fair value. Notes receivable from participants are valued at cost, which approximates fair value.

Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Security transactions are recorded on a trade-date basis. Gains or losses on sales of securities are based on average cost.

The Plan presents in the statements of changes in net assets available for plan benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Benefit Payment Recognition – Benefits are recorded when paid.

Date of Management Review – Subsequent events were evaluated through September 2, 2025, which is the date the financial statements were available to be issued.

#### **(3) Fair Value Measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued at the NAV of the underlying securities. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, and can be redeemed on a daily basis.

*Collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**(5) Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all amounts credited to the accounts of the participants shall vest and become non-forfeitable. The employer shall direct the Trustee to make or commence distribution to, or on behalf of, each participant the value of his or her account balance in the Plan.

**(6) Tax Status:**

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**(7) Related Party and Party-In-Interest Transactions:**

Plan investments are managed by Principal Trust Company, the Trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Notes receivable from participants totaling \$385,914 and \$277,475 at December 31, 2024 and 2023, respectively, also qualify as party-in-interest transactions.

**(8) Plan Mergers:**

Effective January 1, 2023, the MedThink, LLC 401(k) Profit Sharing Plan merged into the Plan. Plan assets were transferred to the trustee of the Plan subsequent to the plan merger.
