Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the accompanying financial statements of Gunderlin, Ltd. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Gunderlin, Ltd. Opinion

Modified Cash Basis

1. Description of Plan

The following description of the Gunderlin Ltd., Inc. (“the Company”) Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering all full-time employees of the Company who have attained one year of service and are age 21 or older. Date of eligible participation occurs immediately upon meeting all eligibility requirements.

The Plan was established on December 1, 1977, under Section 401(k) of the Internal Revenue Code, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to 90% of their compensation, as defined in the Plan, subject to a maximum of \$23,000 for the year ended 2024. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

In addition to the Company’s matching contributions, the Company may make an annual discretionary contribution, as determined by the Board of Directors of the Company. Discretionary contributions are allocated at the end of the calendar year to participants employed at the end of the year and to participants who have retired, died, or became disabled during the year. Such allocations are based on the proportion that each participant’s basic compensation bears to the total basic compensation for all participants.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon as well as the Company’s matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary contributions is based on years of continuous service. A participant is 100% vested after six years of credited service for the Company’s discretionary contributions plus actual earnings thereon.

Notes Receivable from Participants.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

The loans are secured by the balance in the participant’s account and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Investment Options. Upon enrollment in the Plan, a participant may direct their contributions into any of the investment options offered under the terms of the investment contract.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum payment paid directly to the participant or rolled over to an IRA, a partial “ad-hoc” distribution, or installment distributions but only with respect to the participant’s required minimum distributions. In the event of death or total and permanent disability, a participant’s account becomes fully vested.

1. Description of Plan (Cont'd.)

The non-vested portion of a terminated participant's account is forfeited and allocated to the employer contribution account of all participants who have not had a one-year break in service during the Plan year and who are employees as of the end of the Plan year. The forfeited amounts are allocated to a participant's account based on the proportion that each participant's basic compensation bears to the total basic compensation of all active participants. In addition, a participant can elect to receive all or part of their vested account at any time after reaching the age of 59 ½ or if the participant rolled over funds into this Plan from another qualified retirement plan.

Administrative Services. The Company pays some of the administrative expenses on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements are prepared using the modified cash basis of accounting. Contributions and interest income are recognized when collected and administrative expenses and benefits are recognized when paid.

Investment contracts held by a defined contribution plan are required to be reported at fair value. The Statement of Net Assets Available for Plan Benefits presents the fair value of the investment contracts. The Statement of Changes in Net Assets Available for Plan Benefits is prepared on a contract value basis.

Estimates. The plan administrator uses estimates and assumptions in preparing those financial statements in accordance with the modified cash basis of accounting. Those estimates and assumptions affect the reported amounts and disclosures. Actual results could vary from the estimates that were used.

Investment Valuation and Income Recognition. Investments are reported at fair value, with the exception of fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements.

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Forfeited Accounts. At December 31, 2024, there was \$50,508 in forfeited non-vested accounts. These accounts can be used to reduce future employer contributions and fees. Subsequent to year end the entire amount of \$50,508 was used to reduce employer matching contributions.

Subsequent Events. The Company has evaluated subsequent events through September 8, 2025, the date these financial statements were available to be issued.

3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

4. Income Tax Status

The Plan has adopted a prototype “standardized” plan and the prototype sponsor has received a determination letter from the Internal Revenue Service indicating that the Plan is a qualified plan meeting the requirements of applicable sections of the Internal Revenue Code. Accordingly, plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Service.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

5. Party-In-Interest Transactions:

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain Plan investments are shares of mutual funds managed by Mutual of Omaha Life Insurance Company. Mutual of Omaha is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Participant loans held by the Plan also reflect party-in-interest transactions (related party transactions).

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits and the Statement of Changes in Net Assets Available for Plan Benefits. The Company manages the Plan’s credit risk by offering participants diversified investment options.

7. Information Prepared and Certified by the Trustee

Mutual of Omaha Life Insurance Company, the Trustee, holds all of the Plan’s investment assets and executes transactions in the assets.

9. Fair Value Measurements

The applicable guidance provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the applicable guidance are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Common / Collective Trusts: Valued at the quoted net asset value of shares held by the Plan at year end.

Registered Investment Companies: Valued at the closing price reported in the active market in which the fund is traded.
