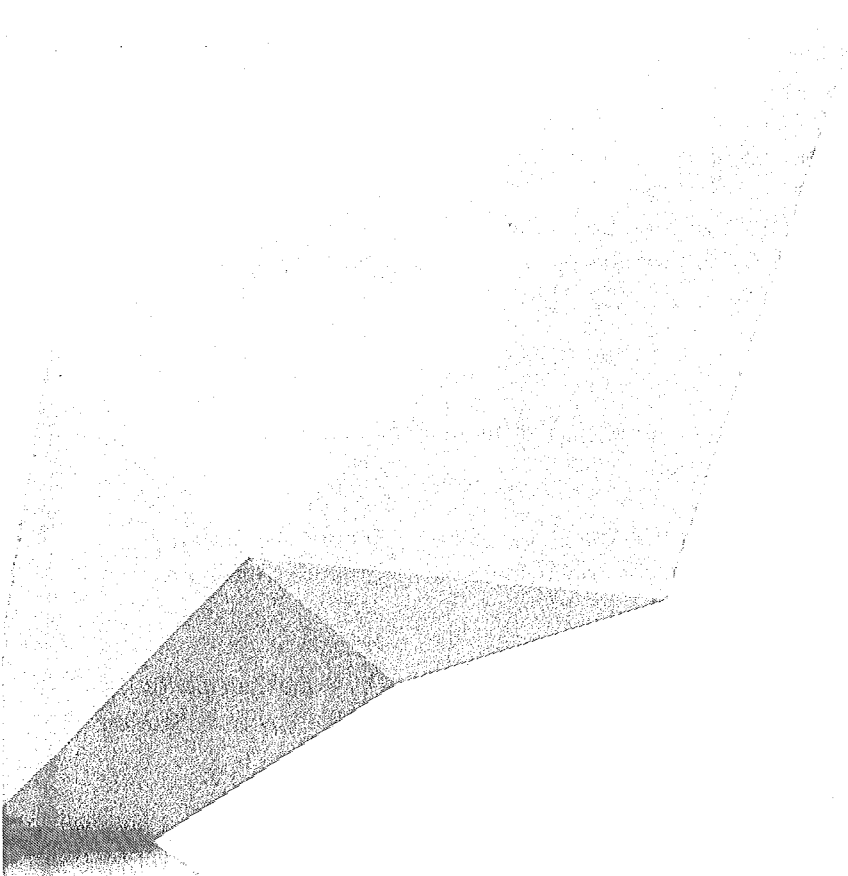

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Granite State Glass 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Granite State Glass 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Granite State Glass 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Granite State Glass 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Granite State Glass 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

Note 1: Description of Plan

The following description of the Granite State Glass 401(k) Plan is intended to provide general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Granite State Glass 401(k) Plan (the Plan), is a defined contribution plan that was adopted in 1998. The Plan covers all eligible employees of Marbucco Corp., d/b/a Granite State Glass (the Employer and Plan Sponsor), who elect to participate and have completed ninety days of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participating employees are allowed to make contributions, through salary deferrals, as defined by the Plan, up to an amount not to exceed the limits imposed by law. In addition, participants age 50 and over are allowed to make catch-up contributions, subject to limits imposed by law. Newly eligible participants are automatically enrolled in the Plan at 4%, unless they elect otherwise. The Plan also accepts participant rollovers from other qualified retirement plans.

The Plan is a safe harbor plan whereby the employer shall make matching contributions in an amount equal to 100% of elective deferral contributions that are not over 4% of compensation. The employer made safe harbor matching contributions of \$689,667 and \$637,268 for the years ended December 31, 2024 and 2023, respectively. The Plan also allows for additional employer discretionary matching contributions and profit-sharing contributions. There were no additional discretionary matching contributions or profit-sharing contributions made by the employer during 2023. Profit sharing contributions totaling \$1,000,000 related to the Plan year ending December 31, 2023, were deposited in 2024. Profit sharing contributions totaling \$1,000,000 related to the Plan year ending December 31, 2024, were deposited in 2025.

Participant Accounts

Each participant's account is credited with participant deferrals, rollovers and employer matching contributions and allocations of the employer's profit-sharing contribution, if applicable, and plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Benefits

Vested benefits may be distributed upon termination of employment, retirement, death or permanent disability. Distributions may be made in one lump-sum payment, partial payments or in installment payments, as defined in the Plan document. A participant may also request a withdrawal, subject to limitations, upon attainment of age 59½, or if the participant is suffering from hardship and meets the criteria specified in the Plan.

Note 1: Description of Plan (Continued)

Vesting and Benefits (Continued)

The portion of participants' accounts consisting of salary deferrals, rollover contributions, employer safe harbor matching contributions, and actual earnings, thereon, are 100% vested immediately. Vesting for employer discretionary matching and profit-sharing contributions are subject to a graded vesting schedule at a rate of 20% after two years of service, as defined, with vesting percentages increasing thereafter until 100% vesting is achieved after six years of service. A year of vesting service is defined as 500 hours of service per year. A participant who is an employee on or after the date they reach normal retirement age or is an employee on the date they die or become disabled, as defined, shall be 100% vested.

The amount of forfeitures attributable to employer discretionary matching and profit-sharing contributions, if any, which have not become vested are applied to reduce future employer contributions to the Plan and plan expenses or allocated to participants' accounts. At December 31, 2024, forfeited nonvested accounts totaled \$23,577. At December 31, 2023, there were no significant forfeited nonvested accounts.

Investment Options

Plan participants may select their investments from various investment options made available under the Plan. Plan contributions are invested based upon these selected options.

Notes Receivable From Participants

Participants may borrow from their Plan accounts. The minimum permitted loan is \$1,000 and the maximum permitted loan is the lesser of \$50,000 or one-half of the current value of the participant's vested interest in the Plan. Loans must be repaid, with interest, over a period not to exceed five years unless for the purchase of a principal residence, in which case, the loan must be repaid within a reasonable amount of time not to exceed 30 years. Effective March 1, 2019, the Plan adopted an amendment which no longer allows the extension of the repayment period beyond five years. Participants are allowed two loans outstanding from the Plan at a time. Loans are secured by participant balances and bear interest at 2% above the prime rate, as defined, determined at the time of borrowing. Interest rates ranged from 5.25% to 10.50% on loans outstanding as of December 31, 2024 and 2023. Principal and interest are paid ratably through weekly payroll deductions.

Plan Termination

While the employer has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions of ERISA. In the event of termination of the Plan, all participants shall become 100% vested in employer discretionary matching and profit sharing contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, certain revenues and the related assets are recognized when received rather than when earned, and certain expenses and the related liabilities are recognized when paid rather than when the obligation is incurred. That basis differs from accounting principles generally accepted in the United States of America primarily because the Plan has not recognized contributions receivable and the related effect on the statements of changes in net assets available for benefits. The modified cash basis of accounting is an acceptable method of reporting under Department of Labor regulations.

Use of Estimates

Management uses estimates and assumptions in preparing the financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions in net assets during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract). Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on the settlement-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains or losses on investments bought and sold, as well as held during the year.

The fully benefit-responsive investment contract is reported at contract value, which is the amount the participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are treated as benefit payments based upon the terms of the Plan document.

Note 2: Summary of Significant Accounting Policies (Continued)

Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefits are reflected as a deduction in net assets available for benefits when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 11, 2025, which is the date the financial statements were available to be issued.

Note 3: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan invests in a traditional, fully benefit-responsive guaranteed investment contract with Principal Trust Company, as custodian of the group annuity contract, which was issued by the Principal Life Insurance Company. The Principal Fixed Income Guaranteed Option (PFIGO) is a single group annuity contract with a fixed rate of interest. Principal Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract (GIC) is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed semiannually for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal Life Insurance Company including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Principal Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

Note 4: Fair Value Measurements

The fair value of the Plan's investments is determined using a hierarchy that prioritizes the inputs to valuation techniques. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for identical or similar assets in inactive markets, quoted prices for similar assets in active markets, observable inputs other than quoted prices or inputs that are derived principally from or corroborated by observable market data by correlation or other means; and Level 3 inputs consist of inputs to the valuation methodology that are unobservable and significant to the fair value measurement and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts and Pooled Separate Accounts: Valued at the NAV of the shares of the trusts or accounts held by the Plan at year end. The NAV is based on the fair value of the underlying investments of the trust or accounts less its liabilities. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Note 5: Information Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian of the Plan.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved profit sharing plan document with an Internal Revenue Service (IRS) notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter, however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Party-In-Interest Transactions

Certain investments of the Plan are in shares of common/collective trusts, pooled separate accounts, and a guaranteed investment contract that are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian of the Plan's investments and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. The Plan also has arrangements with various service providers, which also qualify as party-in-interest transactions under ERISA. In addition, the Plan has notes receivable from participants that qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
