### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The National Football League Capital Accumulation Plan – Baltimore Ravens, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The National Football League Capital Accumulation Plan – Baltimore Ravens's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. **NOTE 1 PLAN DESCRIPTION**

The following description of The National Football League Capital Accumulation Plan – Baltimore Ravens (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan, which became effective April 1, 1987 and subsequently restated effective July 1, 2025, is a defined contribution plan covering eligible nonplayer employees of the Partnership. Nonplayer employees who are not eligible to participate in the Plan include those classified as Game Day employees and interns, employees subject to a collective bargaining agreement, leased employees, and independent contractors.

Employees covered under the Plan are eligible to participate on the 30<sup>th</sup> day after completion of their first hour of service as an eligible employee. Unless employees elect a specific contribution percentage or opt out of participation in the Plan, they will be automatically enrolled to contribute 3% of their eligible compensation beginning 60 days following completion of the aforementioned first hour of service.

The Plan is administered by employees of the Partnership and is subject to the provisions of ERISA.

**Contributions**

Each year participants may contribute up to 100% of annual compensation but no more than \$23,000 and \$22,500 for the Plan years ended December 31, 2024 and 2023, respectively, in accordance with Internal Revenue Service (IRS) limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make additional contributions not to exceed a total of \$30,500 and \$30,000 in the aggregate as set forth by the IRS for the Plan years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Partnership makes matching contributions to the Plan equal to 50% of the participant’s pre-tax contribution up to the lesser of 2.5% of the participant’s eligible compensation or \$3,750 annually. The Partnership executes the matching contributions on a semi-monthly basis. For the Plan years ended December 31, 2024 and 2023, the Partnership’s matching contribution was \$768,839 and \$695,718, respectively.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Partnership's matching contributions, and allocations of Plan earnings or losses. Allocations are based on each individual participant's respective investment account balances throughout the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Accounts are participant directed.

**Vesting**

Participants are immediately 100% vested in amounts attributable to their salary deferrals and the Partnership's matching contributions plus actual earnings or losses thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50% for loans outstanding as of December 31, 2024 and 2023. These rates are commensurate with the prime rate as published in The Wall Street Journal on the first business day of the month in which the loan application is received and remain fixed for the term of the loan. Principal and interest is paid ratably through payroll deductions over the term of the loan which ranges from one to five years unless the proceeds are used for the purchase of a primary residence, in which case, the maximum loan repayment term is 10 years. Loan balances may be prepaid in full at any time prior to the end of the term with no prepayment penalty.

A participant may have no more than one outstanding loan at any time and may not apply for a new loan until at least 12 months after the previously repaid loan had been approved. If a participant fails to make a payment when due or his/her employment is terminated for any reason with an outstanding loan, the balance must be repaid in full at that time. Failure to do so in a timely manner will result in the loan balance being treated as a distribution, subject to income taxes and penalties.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant's account balance is available for distribution, as defined by the Plan. The Plan also allows for in-service withdrawals for hardships (subject to certain qualifications) and participants who have reached age 59½. Distributions can be made in the form of full or partial lump sum cash payments. If a terminating participant's vested account balance does not exceed \$1,000, the Plan will distribute the benefit in a lump sum as soon as administratively practicable. At all times, participants may withdraw all or a portion of their rollover contributions, subject to certain tax withholdings and early withdrawal penalties.

Participants who have terminated employment and not elected a distribution of their balance prior to attaining age 70½ must begin receiving annual minimal distributions of their account balance.

**NOTE 2 SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates in Preparing Financial Statements**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

**Contributions**

Contributions from participants and Partnership contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Partnership and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 2 SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Trust Agreement**

The Plan is a member in the NFL Trust. The NFL Trust, which qualifies as a common/collective trust, was established and is maintained for the collective investments of contributions by plans of the National Football League member clubs and other National Football League entities. The assets of the NFL Trust are maintained by PNC Bank (PNC), as of December 31, 2024 and 2023. The NFL Trust has multiple investment funds. Participants may direct their contributions into any of the NFL Trust's investment funds.

**Subsequent Events**

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income from notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by PNC Bank, National Association, the qualified institution of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/Collective Trusts:* Valued at the net asset value (NAV) of units of the fund held by the Plan, based on the fair value of the underlying investments of the fund. NAV is used as a practical expedient to estimate fair value.

*Money Market Fund:* Valued at the NAV of shares held by the Plan as of year-end as quoted in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value for certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Partnership has the right to suspend or terminate the Plan subject to the provisions of ERISA.

**NOTE 6 TAX STATUS**

The IRS has determined and informed the Partnership by a letter dated December 6, 2016, that the Plan and related NFL Trust are designed in accordance with appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of common/collective trusts and a money market fund managed by PNC. PNC is the qualified institution, as defined by the Plan; therefore, these transactions are deemed to be party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

Effective January 1, 2025, employees of the Baltimore Football Stadium Company LLC (dba Relentless Events) will be covered by the Plan. Employees of Baltimore Football Stadium Company LLC (dba Relentless Events) are eligible to participate as soon as practicable following, but in no event later than 30 days after the completion of 500 hours of service in a 12 month period. Prior service with Baltimore Football Stadium Company LLC will be included when determining eligibility. Employees of Baltimore Football Stadium Company LLC (dba Relentless Events) will receive a matching contribution equal to 100% of the first 6% of eligible compensation that a participant contributes to the Plan.

In addition, effective January 1, 2025, the Plan will allow for Roth contributions into the Plan. Effective January 1, 2025, unless employees elect a specific contribution percentage or opt out of participation in the Plan, they will be automatically enrolled to contribute 5% of their eligible compensation beginning 30 days following completion of the aforementioned first hour of service.

Effective July 1, 2025, the Plan will no longer be a member in the NFL Trust and the Plan name was changed to Baltimore Ravens 401(k) Plan. Effective July 1, 2025, residents of Puerto Rico will not be eligible to participate in the Plan. Effective July 1, 2025, the Partnership will make matching contributions to the Plan up to the lesser of 100% of the first 5% of eligible compensation that a participant contributes to the Plan or \$3,750 annually. Employees of the Baltimore Football Stadium Company LLC (dba Relentless Events) will receive a matching contribution equal to 100% of the first 6% of eligible compensation that a participant contributes to the Plan. Effective July 1, 2025, the interest rate on loans is 1% over the prime rate published in the Wall Street Journal on the first business day of the month the loan is originated. Finally, effective July 1, 2025, if a terminating participant's vested account balance does not exceed \$1,000, the Plan will distribute the benefit in a lump sum as soon as administratively practicable. If the balance of the terminated participant is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.
