NOTE A – DESCRIPTION OF THE PLAN

The following description of the E.G.O. North America, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of the Company who have completed three months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may elect to defer a portion of compensation, as defined in the Plan, up to the maximum amount determined by current laws and regulations. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Company makes a Safe Harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. The Company makes additional contributions to the Plan at its sole discretion. An employee must complete a year of service and be actively employed on the last day of the Plan year to share in this discretionary contribution. No discretionary contributions were made for Plan years ended December 31, 2024 or December 31, 2023, respectively. Contributions are subject to certain annual limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The accounts are participant directed.

Vesting. Participants are immediately vested in their contributions and the Company's Safe Harbor matching contribution plus actual earnings thereon. Prior to October 1, 2024, a participant was 100% vested in the Company's discretionary contribution plus actual earnings thereon after six years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years. The Administrator may permit a longer repayment period if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The loan interest rate is set by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Participant loans are valued at the unpaid principal balance plus accrued interest. Participant loans outstanding totaled \$255,716 at December 31, 2024 and \$391,868 at December 31, 2023 and are presented in the statement of net assets available for benefits as notes receivable from participants.

Payment of Benefits. On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service withdrawals at age 59 ½ as well as withdrawals in the event of financial hardship under certain conditions. At age 70 ½, 72 or 73 (depending on when a participant was born) and separated from service, a portion of the balance will be required to be distributed each year.

Forfeited Accounts. Participants who leave the Plan may forfeit certain amounts. Forfeitures of employer contributions will occur based on unvested amounts and are used by the plan to reduce future employer contributions. There was \$3,956 in unallocated forfeitures as of December 31, 2024.

NOTE A – DESCRIPTION OF THE PLAN (Continued)

Safe Harbor Plan. Effective January 1, 2011, the Plan qualified for the “Safe Harbor” provisions offered in Section 401(k) and Section 401(m) of the Internal Revenue Code of 1986 and is no longer subject to non-discrimination testing.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition. The Plan’s investments are stated at fair value with the exception of the fully benefit-responsive investment contract, which is carried at contract value. The Plan holds investments in pooled separate accounts with underlying mutual fund investments and a stable value fund investment. These investments are measured by the unit value (similar to mutual fund NAV calculation), which is based on the observable net asset value of the underlying investment for the mutual fund investments and based on the price of the underlying investment received from the fund manager for the stable value fund.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits, the net appreciation/(depreciation) of the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation/(depreciation) on those investments.

Payment of Benefits. Benefits are recorded when paid

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses.

Use of Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Refer to Note B for the valuation methods used to fair value Plan Assets.

The Pooled Separate Accounts are recorded at the NAV (or its equivalent). The NAV reported by the underlying fund approximates the fair value of the investment. These investments are redeemable with the fund at NAV. Plan participant transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on these funds. There are no unfunded commitments at December 31, 2024 and 2023.

NOTE D – INVESTMENTS REPORTED AT CONTRACT VALUE

The John Hancock Stable Value fund is a group annuity contract. Contributions to the contract are held in pooled separate accounts that invests primarily in benefit responsive contracts issued by state regulated insurance companies and banks, including but not limited to John Hancock Life & Health Insurance Company. Each insurance company either contractually guarantees or obtains contractual guarantees from third parties insuring against the loss of principal deposited into the Fund and providing that individual participant withdrawals will be paid at book value. However, if the book value of the Fund exceeds the market value of underlying securities, the stabilizing agreements provide that the payment of certain withdrawals may be delayed for up to 12 months unless the plan or the participant requesting the withdrawal elects to accept such payment subject to a market value adjustment. Certain events would limit the ability of the Plan to transact at contract value with John Hancock Life & Health Insurance

Company, including: (i) termination of the Plan's interest by the Plan Administrator with less than twelve months' notice, (ii) additional investment options established that constitute a competing fund, or (iii) withdrawals and transfers of amounts held under the contract due to a Plan Administrator event including, but not limited to, a total or partial plan termination, merger, spin-off, lay-off, early retirement incentive program, sale or closing of all or part of the Plan sponsor's operations, bankruptcy or receivership. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE E – SPONSOR PAID EXPENSES

All administration and investment advisory fees of the plan are paid from investment income of the plan. During the years ended December 31, 2024 and 2023, the Plan's Sponsor paid audit fees on its behalf of approximately \$16,000 and \$11,000, respectively.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE G – INFORMATION CERTIFIED

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations of Reporting and Disclosure under the Employee Retirement Income Security Act 1974. Accordingly, John Hancock Life Insurance Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate in accordance with DOL regulations.

NOTE H – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

NOTE I – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE J – TAX STATUS

The Plan was amended and restated by adopting a volume submitter 401(K)/Profit Sharing Plan through My Benefits, LLC. The volume submitter plan has received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the plan is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States of America. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE K – PARTIAL PLAN TERMINATION

Due to increasing high cost of labor and benefits, the Company ceased manufacturing operations in the United States and moved its manufacturing lines to Mexico. Effective October 1, 2024, the Plan experienced a “Partial Plan Termination” as a result of the plant closure and subsequent layoffs. A partial plan termination occurs when greater than 20% of all participants are terminated during the year due to layoffs or other employer action. As a result of this partial plan termination designation, all remaining participants are now 100% vested in all of their employer accounts subject to vesting under the Plan document.

NOTE L – SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through September 15, 2025 the date the financial statements were available to be issued.
