INDEPENDENT AUDITORS' REPORT

To the Investment Committee of the
Anthony Wade, Inc. dba Stephen Wade Auto Center 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Anthony Wade, Inc. dba Stephen Wade Auto Center 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS**

(1) Description of the Plan

The following description of the Anthony Wade, Inc. dba Stephen Wade Auto Center 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

- A. **General** – The Plan, which began on January 1, 2006, is a defined contribution plan covering all eligible employees of Anthony Wade, Inc. dba Stephen Wade Auto Center and related employers (the “Company” or “Plan sponsor”), as defined in the Plan document. The Plan is designed to qualify under Sections 401(a) and 401(k) of the Internal Revenue Code (the “IRC”) as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Investment Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The Plan has arranged for Fidelity Management Trust Company (“Fidelity” or “Trustee”) to serve as Trustee, and Fidelity Workplace Services, LLC (the “recordkeeper”), to provide record keeping services for the Plan.

Effective July 2024, the Plan was amended to reduce the eligibility service requirements to receive employer match contributions for employees hired on or after July 1, 2024 from one year and 1,000 hours of service to two months of service. Concurrent with this amendment, the vesting schedule was changed from a 5-year graduated schedule to a 6-year graduated schedule for employees hired on or after July 1, 2024. All eligible employees hired prior to July 1, 2024 will continue to be subject to the 5-year graduated schedule.

- B. **Contributions** – Eligible employees may participate in the Plan upon reaching age 21 and completing two months of service. Participants are automatically enrolled with a 2% pre-tax deferral contribution, unless the employee elects a different deferral percentage or not to participate in the Plan. Entrance to the Plan occurs on the first day of each month after eligibility requirements have been met. Each year, participants may elect to contribute up to 90% of their annual eligible earnings on a pre-tax basis, plus catch-up contributions, subject to the maximum amount allowable by the Internal Revenue Service (“IRS”) (\$23,000 for participants to age 50 and \$30,500 for participants over 50 years of age for the year ended December 31, 2024). Participants may also make post-tax (ROTH) contributions and contribute amounts representing distributions from other tax qualified retirement plans. Discretionary employer matching contributions are made each pay period by the Company for active participants if the employee meets the eligibility requirements as described in Plan documents. The amount is discretionary and was based on a match of 50% of the participant’s elective deferral up to 2% of the participant’s eligible earnings for the year ended December 31, 2024.
- C. **Participant investment account options** – The Plan currently offers various collective investment trusts and registered investment companies as well as a money market account as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Unless limited by restrictions imposed by individual investment options and subject to redemption fees, participants may change their investment options on a daily basis.
- D. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, discretionary employer matching contribution, and an allocation of the Plan’s earnings and losses, which include administrative expenses. Allocations are based on participants’ earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

- E. **Vesting** – Participants are immediately vested in their voluntary contributions, earnings thereon, and rollover contributions. Participants hired prior to July 1, 2024 vest in discretionary employer matching contributions as follows:

Participants also become 100% vested when the participant reaches normal retirement age (65), incurs a disability as defined by the Plan, or upon death.

- F. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance with terms from 1 year up to 5 years. Notes related to the purchase of a primary residence are allowed to have terms longer than 5 years. The notes are secured by the balance in the participant’s account and bear interest at the prevailing market rate, determined using the prime rate, plus 1%. As of December 31, 2024, the interest rates for all outstanding notes receivable ranged from 3.50% to 9.50%. Effective June 1, 2023, principal and interest payments are paid ratably through monthly ACH transfers directly to Fidelity. Prior to the June 2023 amendment, principal and interest were paid ratably through semi-monthly payroll deductions. Loan payoffs may be made directly by the participant without penalty.
- G. **Payment of benefits** – Participants may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Benefit payments are made in a lump sum distribution or rollover contributions to another plan. Participants who terminate employment with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Participants who terminate employment with an account balance of less than \$5,000, but more than \$1,000 may receive an automatic direct rollover of their account balance into an Individual Retirement Account. Participants who terminate with a balance of greater than \$5,000 are not subject to these automatic distribution provisions.
- H. **Forfeited accounts** – As of December 31, 2024 and 2023, forfeited non-vested accounts in the Plan totaled \$4,447 and \$46,542, respectively. Forfeited non-vested accounts are used to offset employer contributions and administrative expenses. During the year ended December 31, 2024, \$55,775 of forfeited non-vested amounts were used to offset discretionary employer matching contributions and \$26,686 of forfeited non-vested amounts were used to offset administrative expenses.

(2) Summary of significant accounting policies

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

(2) Summary of significant accounting policies (continued)

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions – Contributions from Plan participants and the associated discretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred.

Payments of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to investment advisory services and trustee/record keeping fees are included in administrative expenses. Other investment related expenses are included in net appreciation in fair value of investments.

(3) Information prepared and certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate with respect to investments and notes receivable from participants:

- Investments at fair value
- Notes receivable from participants
- Interest income from notes receivable from participants
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

(4) Fair value measurements

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification Topic 820 (“ASC 820”), *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective investment trusts: Valued at the net asset value (“NAV”) of units of the collective investment trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable value collective investment trust: A stable value fund that is composed primarily of fully benefit-responsible investment contracts is valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Registered investment companies: Valued at the daily closing price as reported by the registered investment companies. The funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Money market account: Valued at the daily closing price as reported by the account. The money market account held by the Plan is an open-ended mutual fund that is registered with the Securities and Exchange Commission. This account is required to publish its daily NAV and to transact at that price. The money market account held by the Plan is deemed to be actively traded.

(b) The stable value collective investment trust consists of the Morley Stable Value Fund, which is generally redeemed on a daily basis. Withdrawals, other than for benefit payments and participant transfers to noncompeting options require a 12 month advance written notice. The Trustee, in its discretion, may process redemptions in cash as soon as practicable, but payments are not required to be made until after the actual settlement date with respect to investments sold to raise cash for redemption. In addition, such payments may be delayed if the Trustee determines it cannot reasonably make such payment due to reasons beyond its control. Additionally, there are no unfunded commitments.

(5) Related party and party-in-interest transactions

Certain investments of the Plan are managed by Fidelity Management Trust Company. Fidelity is the Plan's Trustee and recordkeeper, and therefore, the transactions are considered exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. As described in Note 2, certain other administrative expenses are paid from Plan assets directly to the recordkeeper and other parties-in-interest and qualify as exempt party-in interest transactions. Administrative expenses paid from Plan assets directly to parties-in-interest totaled \$135,676 for the year ended December 31, 2024.

(6) Plan termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer matching contributions.

(7) Tax status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic, tariffs, or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, two of the Plan's investments individually represented approximately 15% of the Plan's investments, respectively.

(9) Delinquent participant contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During the year ended December 31, 2023, employee contributions totaling \$652, were not remitted to the Plan until after the required time period. The Company remitted to the Plan lost earnings related to delinquent contributions of \$652 in September 2024.

(10) Other employer contributions receivable

During the years ended December 31, 2024 and 2023, the Plan determined that qualified non-elective contributions would be made by the Plan sponsor to certain participant accounts in order to correct missed deferral opportunities related to auto enrollment during the years ended December 31, 2024 and 2023 as an other employer contribution receivable. The other employer contribution receivables, net of forfeitures applied, as of December 31, 2024 and 2023, were \$10,919 and \$20,421, respectively. The corrections were contributed to the Plan by the Plan sponsor in August 2025 and August 2024, respectively.

(11) Subsequent events

Effective February 3, 2025, the Plan documents were amended to reduce the eligibility age requirements for employee contributions from age 21 to age 18. This amendment did not change eligibility requirements for employer contributions.

The Plan has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.
