### 1. Description of Plan

The following brief description of Victor Treatment Centers 403(b) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a 403(b) tax-deferred annuity plan covering all employees of Victor Treatment Centers, Inc., (“VTC”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). VTC is the plan sponsor and serves as the plan administrator.

#### Contributions

Participants may contribute a percentage of their annual compensation, as defined in the Plan, up to the maximum limit as permitted by the Internal Revenue Code. In addition, participants qualifying for age-based provisions may contribute additional catch-up deferrals. Participants may also contribute amounts representing distributions from other eligible retirement plans. There is no age or service requirement to make salary reduction contributions.

Effective July 1, 1992 a participant is eligible to receive an enhanced safe harbor employer matching contribution and a non-elective, discretionary contribution, who is at least 21 years of age and has completed one year or 1,000 hours of service. The employer matching contribution is a fixed amount equal to 100% of the participant’s salary deferral but not to exceed 4% of the participant’s compensation is considered for the match excluding catch-up contributions. Non-elective discretionary contributions, made at the employer’s sole discretion, do not require participant participation in salary deferrals and is limited to 6% of plan year compensation.

Participants may elect to contribute a portion of their eligible compensation to the Plan each year. Contributions are subject to regulatory limitations. Participants who have attained age 50 before the end of the Plan year or have 15 years of services with a qualified organization are eligible to make catch-up contributions.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

### 1. Description of Plan, continued

#### Payments of Benefits

In general, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the fair value of the participant's account balance.

### 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

#### Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

#### Investments

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned, and related fees are recorded as administrative expenses when incurred.

#### Payments of Benefits

Benefits are recorded when paid.

#### Forfeitures

Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures may pay reasonable plan expenses first then pay employer matching contributions. Employer contributions are fully vested as soon as they are made. Forfeited non-vested accounts totaled \$0 at December 31, 2024 and 2023. No forfeitures were utilized during either plan year.

### 2. Summary of Significant Accounting Policies, continued

#### **Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

#### **Subsequent Events**

Management has evaluated subsequent events through September 18, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

A composite crediting rate contractually guaranteed by Principal Life is credited to account balances. The net crediting rate is after the deduction of 0.00%\* for fees for administrative and recordkeeping services provided to the plan. Currently, this net crediting rate is a 1.65% effective annual rate, until November 30, 2025. The rate will be reset December 1, 2025, and semiannually thereafter. Termination of a Party's Interest is subject to either a 12-month advance notice or a 5% surrender charge calculated using the 12-month average value of the Party's Interest in the contract. The authorized plan representative chooses the termination provision for the liquidation. Notice to terminate can be revoked for 90 days, after which, notice is irrevocable. Refer to the contract or plan description for a full explanation of investment details.

### 7. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$34,697.

The Plan's investment options include funds managed by Principal or its affiliates. As custodian and recordkeeper, Principal's transactions qualify as exempt parties-in-interest transactions.

### 8. Plan Termination

Although it has not expressed any intent to do so, VTC has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA.

### 9. Tax Status

The Plan is designed to operate as a standardized prototype style that provides tax-exempt status under appropriate sections of the Internal Revenue Code. The plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
