**Note 1: Description of the Plan**

The following description of the Ahtna 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was formed on January 1, 1990 and was restated effective August 24, 2021. The Plan is a defined contribution plan sponsored by Ahtna, Inc. and Subsidiaries (the Company or Employer) which covers all eligible employees and consists of a salary deferral, an employer discretionary matching contribution, and an employer discretionary nonelective contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (Secure 2.0 Act)

On December 29, 2022, the SECURE 2.0 Act was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Key provisions that may affect plan participants currently and/or in the future include increasing the age for Required Minimum Distributions and provisions relating to catch-up contributions. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required. The deadline for adopting plan amendments has been extended, most recently to no later than December 31, 2026.

Custodian and Administration of the Plan

The custodian and trustee of the Plan is Empower Trust Company, LLC. The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of participating employers, except for collective bargaining, government contract, prevailing wage, and leased employees, are eligible to participate in the Plan after attaining 19 years of age without any service requirements. In order to share in the employer's nonelective contribution, employees must be either employed on the last day of the Plan year or must be credited with at least 501 hours of service during the Plan year. Participants enter into the Plan the first day of the month coinciding with or next following the date when they became eligible for the Plan.

**Note 1: Description of the Plan (Continued)**

Contributions

Each year, eligible employees may defer up to 75% of plan year compensation, as defined in the Plan document. In addition, participants may elect to designate all or part of elective contributions as Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All contributions are subject to annual Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

This Plan also contains an automatic enrollment provision, whereby eligible employees are automatically enrolled in the Plan with a 3% deferral rate. The automatic deferral increases by 1% of eligible compensation each year up to a maximum of 10% of eligible compensation. All eligible employees are subject to automatic enrollment and may choose to decline participation in the Plan or change their deferral percentage. Automatically enrolled employees may withdraw such contributions (and earnings attributable thereto) within 90 days after the first default salary deferral is made, regardless of any other withdrawal restriction under the Plan. Employee contributions are invested in accordance with the default investment alternatives established under the Plan. The employee has the ability to change his or her investment allocation to other funds.

The Employer may make a discretionary matching contribution equal to a uniform percentage or dollar amount of participant's elective deferrals each plan year. For the plan year ended December 31, 2024, the employer discretionary matching contributions equaled 100% of participant deferrals up to 3% of eligible compensation.

In addition, the Employer may make a discretionary nonelective contribution. Discretionary nonelective contributions and forfeitures, if applicable, shall be allocated as of the plan year using annual compensation, as defined in the Plan, for the plan year. Each participant's allocation shall be an amount equal to the discretionary nonelective contribution multiplied by the ratio of such participant's annual compensation to the sum of annual compensation of all participants. Contributions are subject to certain limitations. There were no discretionary nonelective contributions made during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer's matching contributions, as well as allocations of the Employer's nondiscretionary contribution (if any) and plan earnings. Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note 1: Description of the Plan (Continued)**

Vesting

Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. After each year of service, a participant is credited with one-third of their total vesting percentage. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans terms do not extend over five years unless it is used to acquire a principal residence. The loans are secured by the balance in the participant's account. The interest is based on the prime interest rate plus 1%, determined at the time a loan is taken from the Plan. The Plan administrator periodically examines the rates such lenders are using. Once a loan is granted, the interest rate on that loan will not change. Principal and interest are paid through payroll deductions.

Benefit Payments

Upon termination of service for any reason including due to death, disability, or retirement, the Plan permits the participant, or his or her beneficiary, to receive benefits under the Plan. Benefits may be distributed in a single lump sum or partial withdrawals. In the event the participant's vested account balance is less than \$5,000 and the participant makes no election, a single lump sum payment will be distributed or rolled over to an Individual Retirement Account for the benefit of a participant, without the participant's consent. In service withdrawals upon attainment of age 59 ½ and financial hardship withdrawals are permitted, as defined in the Plan agreement.

Forfeited Accounts

Forfeitures occur when participants terminate employment before becoming 100% vested with respect to their Employer contributions. Forfeitures may be used to reduce Employer contributions or pay for Plan expenses. As of December 31, 2024 and 2023, the total unallocated forfeitures were \$51,879 and \$119,928, respectively. During the year ended December 31, 2024, the Plan paid \$33,313 in fees from the forfeiture balance and \$112,827 were used to reduce Employer contributions.

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions are distributed in accordance with IRC Sections 401(m) and 401(k).

Administrative Expenses

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts including loan, withdrawal fees, Plan administrative fees, and investment management fees. Certain investment expenses, which are charged within investments, are presented net of the appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024, were paid by the Company and are excluded from these financial statements.

**Note 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices from similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) to transact at that price. The mutual funds held by the Plan are deemed actively traded.

*Self-directed brokerage accounts:* The self-directed brokerage accounts consist of common stock and money market funds. The common stock is valued at the last reported sales price on the last business day of the year, and the money market funds are valued at the NAV that is quoted on an active market and is always valued at \$1.

*Stable Value Fund:* This investment is valued using the NAV, as a practical expedient for fair value, provided by the Plan's trustee. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This investment is a direct filing entity.

**Note 5: Tax Status**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan sponsored by Empower Retirement, LLC, which received a favorable opinion letter from the IRS dated November 14, 2022, which states that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently is being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine exams by taxing jurisdictions; however, there are currently no exams for any tax periods in progress.

**Note 6: Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of investments managed by Empower Trust Company, LLC, the custodian of the Plan. Therefore, investment transactions with the custodian qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination all account balances become fully vested and all remaining assets in the affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided by ERISA.

**Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Such investments are exposed to risks and uncertainties, such as interest rate risk, credit risk, market risk, economic changes, political unrest, regulatory changes, and foreign currency risk. The Plan's exposure to a concentration of risk is dependent upon funds selected by participants. The following table shows details on investments that represent a concentration of greater than 10% of the Plan's investments in either year:

**Note 9: Prohibited Transactions**

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the Employer's general assets. During the years ended December 31, 2024 and 2023, the Employer failed to remit \$36 and \$5,927, respectively, of contributions and/or loan repayments. Lost earnings are paid by the Employer, not from Plan assets. Lost earnings on the 2024 delayed remittances are scheduled to be remitted by the Employer in 2025. The lost earnings on the 2023 delayed remittances were remitted by the Employer in 2024. These transactions constitute prohibited transactions as defined by ERISA.

**Note 11: Subsequent Events**

Subsequent events have been evaluated through September 4, 2025, the date the financial statements were available to be issued.

Effective July 1, 2025, the Plan adopted an automatic enrollment feature for newly eligible participants. Under this provision, employees who become eligible to participate in the Plan will be automatically enrolled at a deferral rate of 3% of eligible compensation unless they affirmatively elect a different rate or opt out of participation. In addition, the Plan includes an automatic escalation feature whereby the deferral rate will increase by 1% annually, up to a maximum of 10% unless the participant elects otherwise.
