### **Opinion**

We have audited the accompanying financial statements of Multi-Union Security Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Multi-Union Security Trust Fund (the “Plan”) is a multiemployer welfare benefit plan providing hospital, medical, life and accidental death, dental care, mental health, prescription drug and vision care benefits to active participants on whose behalf employers contribute to the Plan in accordance with their collective bargaining agreement to provide specified benefits. Dependents of eligible active participants are also eligible for certain specified benefits. No retired participants are covered under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Contributions**

Contributions are reported on the financial statements on the accrual basis. Employer contributions are contributions made by employers on behalf of employees for months worked during the year. Participant self-payments are payments by participants for months of coverage during the year. Contributions received in advance of the month worked or the month of coverage are reported as deferred contribution revenue.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under an employer payroll compliance program.

**E. Investments**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**E. Investments (Continued)**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Exchange Traded Funds and Government Debt Securities:* The fair value is determined based on quoted prices in active markets on the valuation date (Level 1).

*Corporate Debt Securities:* The fair value is determined using a market-based model in which valuation consideration is given to yield or price of comparable securities, coupon rate, maturity, credit quality and dealer provided prices. (Level 2).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair values of investments were provided by the Plan's investment manager. Investment income, realized gains and losses on sale of investments and other investment income and expenses are reported on the accrual basis. Realized gains or losses from the sale or redemption of investments and unrealized appreciation or depreciation in the fair value of investments is reported as net appreciation of investments. Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis.

**F. Cash and Cash Equivalents**

Cash and cash equivalents consist of a checking account and a money market account and fund.

**G. Benefits**

Benefits reported on statements of changes in net assets available for benefits are segregated by premiums for eligible participants paid during the year (Premiums Paid) and the benefits claims for participant services paid during the year (Indemnity Claims Paid). Benefit obligations reported on statements of benefit obligations consist of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year and claims payable are claims incurred during the year, reported but unpaid. Statements of changes in benefit obligations reports the components of the changes in benefit obligations. No retired participants are covered under the Plan, therefore, no postretirement benefit obligations are reported on the financial statements.

**H. Other Income and Expenses**

Other income and expenses are reported on the accrual basis, except for nominal amounts of recurring monthly expenses.

**NOTE 3 - TAX-EXEMPT STATUS**

The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and from the state of California under Revenue and Taxation Code Section 23701i; therefore, no provision is made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognized a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Contribution rates in effect during the years are based upon amounts required to be contributed in accordance with collective bargaining agreements between participating unions and various employer groups.

**E. Self Payment Under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA)**

The Plan allows for continuation of coverage for eligible active participants as required under COBRA. Rates for COBRA continuation of coverage premiums are set by the Board of Trustees.

**F. Administration**

The Plan is administered by Pacific Federal, LLC. The monthly administration fee for 2024 and 2023 was as follows:

February 1, 2022 to January 31, 2023:	\$26.15 per participant
February 1, 2023 to January 31, 2024:	\$26.94 per participant
Effective February 1, 2024:	\$27.74 per participant

**G. Service Consulting**

Service consulting consists of consulting about the Plan and benefits, provided by PacFed Insurance Services, to participants at their place of employment. The monthly fee for 2024 and 2023 was as follows:

February 1, 2022 to January 31, 2023:	\$9.00 per participant
February 1, 2023 to January 31, 2024:	\$9.27 per participant
Effective February 1, 2024:	\$9.55 per participant

**NOTE 5 - CONCENTRATION OF CREDIT RISK**

The Plan maintains cash accounts at financial institutions, which exceeded the Federal Deposit Insurance Corporation Limit of \$250,000 per legal entity. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances. The uninsured balance at December 31, 2024 was \$564,786.

**NOTE 6 - CONCENTRATION OF EMPLOYER CONTRIBUTIONS**

Employer contributions from three significant employers for 2024 and 2023 totaled \$15,197,093 and \$14,171,042, respectively, representing 76% and 76% of total 2024 and 2023 employer contributions, respectively.

**NOTE 7 - OPTIONS RIDER PLAN**

Options Rider is a plan that is designed to provide certain participants with additional flexibility with their selection of outpatient services. It provides these participants and their dependents the opportunity to receive selected outpatient services from any physician, and also covers certain services that are not normally covered under the prepaid plan. Benefits are limited to outpatient services such as physician office visits. Specifically excluded are inpatient services, major surgical procedures, and maternity care in any setting. The maximum benefits are \$5,000 to each covered family member per calendar year.

Due to the risk associated with investment securities and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the financial statements.

**NOTE 10 - PLAN TERMINATION**

Although there is no intent to terminate the Plan, in the event of termination, the Declaration of Trust provides that any assets remaining in the Plan shall be used solely for the continuance of health and welfare benefits to participants, beneficiaries and employees and eligible members of their families in a fair, equitable basis until such assets have been exhausted.
