### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of EPIC CPF 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of EPIC CPF 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the EPIC CPF 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of Epic Enterprises, Inc. (EPIC) and CPF, Inc. (CPF) (the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (the IRC).

**Eligibility**

Employees of the Companies, excluding union employees, nonresident aliens and seasonal employees who work less than 1,000 hours, are eligible to participate in the deferral and match components of the Plan upon reaching the age of 18 and completing two months of service. The Plan has automatic enrollment provisions with an initial pre-tax deferral contribution of 6% for eligible employees. The employee can enter the Plan immediately after satisfying eligibility requirements.

**Participant Contributions**

Participants may contribute a portion of eligible pre-tax annual compensation to the Plan, subject to dollar limits set by federal law. Participants may also contribute a portion of eligible after-tax annual compensation as Roth contributions to the Plan, subject to dollar limits set by federal law. Furthermore, Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (participant rollovers). Additionally, participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

**Employer Contributions**

The Companies may make a discretionary matching contribution equal to a uniform percentage of the participant's salary deferrals. The Companies elected to match 100% of the participant's contributions up to 5% of the participant's compensation.

The Companies may also make a discretionary profit sharing contribution for its employees. The Companies' contribution for any year is allocated among the participants who are eligible to participate in the Plan, have six months of service as of the entry date for discretionary profit sharing contributions and are still employed on the last day of the year, unless retirement occurs during the year, whether or not actively participating in the Plan. The entry date for discretionary profit sharing contributions is the first day of each Plan year and the first day of the seventh month of each Plan year after completing eligibility requirements. The pre-determined discretionary profit sharing contribution, if any, for each company is allocated based on each participant's eligible compensation divided by the total eligible compensation for the respective company in the Plan. The Companies elected not to make a discretionary profit sharing contribution for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, earnings (losses), the Companies' discretionary matching contribution and an allocation of any Companies' discretionary profit sharing contribution and charged with an allocation of expenses. Allocations of the profit sharing contribution are based on the participant's compensation as a percentage of total Plan compensation and allocations of expenses are done based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on the participant's risk tolerance. Participants in the Plan may direct contributions into any of the funds offered by the Plan, which are held at Fidelity Management Trust Company (Fidelity). These funds include a variety of investment options with various objectives and degrees of financial risk.

**Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Each participant vests in the Companies' discretionary matching and profit sharing contributions at a rate of 20% per year beginning in their second year of service and becoming fully vested in such contributions after completing six years of service.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from 1 to 5 years (or longer for the purchase of a primary residence). A participant is allowed one loan at a time. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. In the event of termination of employment, the entire outstanding loan balance is payable immediately, with the exception that if the termination is due to a corporate action, then the loan may be rolled into the participant's new employer's Plan, if allowed, within 60 days of termination.

**Payment of Benefits**

Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Active participants become 100% vested upon death or disability. Also, upon termination, if a participant's vested account is less than \$5,000, and the participant does not elect to receive the distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits (Continued)**

If the participant's balance is greater than \$1,000 but less than \$5,000, the Plan administrator is allowed to rollover the remaining balance into an IRA. In-service withdrawals are allowed upon attainment of age 59½ or upon financial hardship subject to Plan provisions.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan while others are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Forfeitures**

Forfeitures are retained in the Plan and can be used to reduce the Employers' discretionary contributions annually and to pay administrative expenses. During the year ended December 31, 2024, \$213,280 of forfeitures were used to reduce Employer discretionary contributions and there were no forfeitures used to pay administrative expenses. As of December 31, 2024 and 2023, forfeited accounts totaled \$321,807 and \$229,795, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administration to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investments, Investment Valuation, and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

**Investments, Investment Valuation, and Income Recognition (Continued)**

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefits Paid**

Benefits to participants are recorded when paid.

**Risk and Uncertainties**

The Plan invests in various mutual funds and common collective trusts. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Information presented on the accompanying statements and schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments at fair value, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Fidelity Management Trust Company, the qualified institution, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual Funds* – Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

*Common Collective Trusts* – The common collective trusts are valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the qualified institution as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Certain employees of the Companies who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 7 TAX STATUS**

The Companies have adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
