The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE A | DESCRIPTION OF PLAN**

The following description of the Buchheit, Inc. (the "Company") Employees' 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*1. General*

The Buchheit, Inc. Employees' 401(k) Retirement Plan, which became effective on January 1, 1973, and most recently restated on January 1, 2023, is a defined contribution plan. Employees of Buchheit, Inc. and related participating employers may defer compensation upon employment and are eligible for employer contributions after completing 1,000 hours of service during the Plan year. To share in employer contributions participants must be employed on the last day of the Plan year and have 1,000 hours of service during the Plan year. Participants share in matching and employer contributions regardless of service during the Plan year if terminated due to death, disability or reaching normal retirement age of 65. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions and Investment Options*

Each year, participants may contribute up to the maximum amount determined by law, as defined in the Plan, on a pre-tax or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company contributes a matching contribution of 50 percent of the first six (6) percent of base compensation that a participant contributes to the Plan during the Plan year. This match excludes catch-up contributions. Discretionary amounts may be contributed at the option of the Company's board of directors. The matching contributions were \$293,218 and \$299,325 for 2024 and 2023, respectively. The discretionary contributions were \$0 and \$0 for 2024 and 2023, respectively and were allocated based on participant eligible compensation as a percentage of total eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan offers various mutual funds, money market funds and a fixed interest annuity as investment options for participants. Contributions are subject to certain Internal Revenue Code limitations.

**NOTE A | DESCRIPTION OF PLAN**

*3. Participant Accounts and Allocations*

Each participant's account is credited with the participant's contribution, the employer's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*4. Vesting*

Participants are 100% vested in their deferral contributions and Company matching contributions plus actual earnings thereon. Participants are 100% vested in Company discretionary contributions plus related earnings after six years of credited service.

*5. Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at current rates. Principal and interest are paid ratably through payroll deductions.

*6. Payment of Benefits*

On termination of service due to death, disability, retirement or termination, the participant can receive a distribution of their vested account balance. If a participant's account balance is greater than \$5,000, the participant may elect to defer payment until a later date. The Plan also allows for in service distributions at age 59½ and hardship distributions from certain accounts. Distributions may be paid in a lump sum payment, partial lump sums, installment payments or rolled over to an IRA or another retirement plan.

*7. Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,016 and \$15,720 respectively. These accounts may be used to reduce plan expenses or future employer contributions. In 2024 and 2023, no amounts were paid from forfeitures to reduce employer contributions or pay expenses of the Plan.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies applied in the preparation of these financial statements follows.

1. *Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

2. *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

3. *Investment Valuation and Income Recognition*

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value (Note E). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan deems all participant notes receivable to be fully collectable; therefore, no allowance for uncollectable accounts is required. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

5. *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

Expenses of maintaining the Plan are paid by the Plan and the participants.

7. *Subsequent Events*

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Plan trustee VALIC Trust Company Inc. (formerly known as AIG Federal Savings Bank) and the regulated insurance company The Variable Annuity Life Insurance Company (VALIC) except for comparing such information certified by the trustee and regulated insurance company to information included in the Plan's financial statements and supplemental schedules.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Funds*

Money market funds are valued based on an amortized cost valuation method designed to maintain a NAV of \$1 per share, which approximates fair value.

**NOTE E | GUARANTEED INVESTMENT CONTRACT**

The Plan has a fully benefit-responsive guaranteed investment contract with The Variable Annuity Life Insurance Company (VALIC). VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a monthly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**NOTE E | GUARANTEED INVESTMENT CONTRACT**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The following represents the total contract value of traditional investment contracts. No synthetic investment contracts were held by the Plan.

**NOTE F | RELATED PARTY TRANSACTIONS**

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Certain Plan investments are a fixed interest annuity contract managed by VALIC and shares of money market and mutual funds managed by VALIC Trust Company Inc. Both VALIC and VALIC Trust Company are members and wholly owned subsidiaries of Corebridge Financial Inc. which is a majority owned subsidiary of American International Group, Inc. (AIG). VALIC is a regulated insurance company and VALIC Trust Company Inc. is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party in interest transactions and are noted as such on the supplemental Schedule of Assets (Held at End of Year).

**NOTE G | PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE H | PLAN TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the U.S. Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Penalties and interest assessed by taxing authorities are included in the provision for income taxes, if applicable. There were no penalties and interest for 2024 and 2023. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE I | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
