Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of e4 Services, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

1. Description of the Plan

The following description of e4 Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description (SPD) for a more complete description of the Plan's provisions.

General

The Plan is defined contribution plan, established on January 1, 2006 and restated on January 1, 2021. The plan is sponsored by e4 Services, LLC (the Company and Employer). The Plan is designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), and the Internal Revenue Code (IRC).

Trustee and Administration of the Plan

The trustee of the Plan is Capital Bank and Trust Company (the Trustee) which is part of Capital Bank and Trust Company. The recordkeeper of the Plan is Ascensus (the Recordkeeper). The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The administration determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees of the Company who have completed at least three months of service, who are age 18 or older, and who have completed 250 hours of service are eligible to participate in the Plan.

Participant Contributions

Each year, eligible employees may contribute up to 92% of annual compensation, as defined in the Plan, not to exceed the limits as determined by the IRC, through payroll deductions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the Plan year may also contribute catch-up contributions not to exceed IRC limits.

Employer Contributions

The Company has elected to make a safe-harbor matching contribution of 100% of participant's elective deferrals up to 4% of eligible compensation. The Company made a safe-harbor matching contribution to the Plan, which totaled \$696,087 for the year ended December 31, 2024.

The Company may also make a non-elective discretionary contribution (profit-sharing contribution) to the Plan. Participants must have performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for the profit-sharing contribution. No non-elective discretionary contribution was made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and earnings or losses, and may be charged with certain administrative expenses. Plan earnings or losses are applied to a participant's account balance based on the investment experience of the funds held and the number of shares owned in each fund by the participant.

Vesting

Participants are immediately vested in their contributions and safe harbor contributions and actual earnings or losses thereon. Vesting in the employer's non-elective discretionary matching and profit sharing, if any, contributions is based on years of service as follows:

Upon death or disability, the participant (or their beneficiary in case of their death) becomes 100% vested in the Plan. Upon reaching normal retirement age of 65 years, the participant becomes 100% vested in the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,587 and \$9,581, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. Approximately \$5,393 of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024.

Payment of Benefits

The benefit to which a participant is entitled equals the value of the participant's vested interest in their account. Upon termination of service due to death, disability, severance, or retirement, a participant may elect to receive a lump-sum payment equal to the vested portion of their account. Additionally, participants are allowed to withdraw funds from the Plan upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Upon termination of employment, vested account balances of less than \$5,000 will be rolled over to an Individual Retirement Account if withdrawal of the funds is not initiated by the participant. Account balances less than \$1,000 are distributed to participants as a lump-sum distribution.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a menu of mutual fund options for investment.

Notes Receivable from Participants

Participants are allowed to borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only three loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate set by the Plan administrator, currently ranging from 4.25% to 9.50%. Any loan must be repaid within five years unless otherwise approved. Principal and interest are paid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various American Funds mutual funds managed by Capital Group. Such investments, in general, are exposed to various risks such as stock market fluctuations, interest rates, economic conditions, and world affairs. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by its investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Investments in the stable value account are considered fully benefit-responsive investments and, as such, are reported at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals. The stable value account is a group fixed annuity. See Note 4 for discussion on the stable value account.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in the fair value of investments includes the Plan's gains and losses for investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following is a description of the valuation methods and assumptions used by the Plan to estimate the fair value of its investments:

Mutual Funds - The fair value of mutual fund investments is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

4. Stable Value Account

The Plan holds a fully benefit-responsive investment contract with Capital Bank and Trust Company and offers this investment option to its participants. The balance in the Stable Value Account was \$397,724 and \$343,496 at December 31, 2024 and 2023, respectively. The guaranteed investment contract issuer is contractually obliged to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and was 2.78% and 2.95% at December 31, 2024 and 2023, respectively. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Capital Bank and Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

5. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

The Plan's independent accountants did not perform any auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants would become fully vested in their accounts.

7. Tax Status of the Plan

The Plan uses a pre-approved plan document sponsored by Ascensus LLC. Ascensus LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Related Party and Parties-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Capital Bank and Trust Company or their subsidiaries and affiliates. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

9. Transfer from Other Qualified Plan

Effective May 2, 2024, the CDM Enterprises Inc. 401(k) Profit Sharing Plan & Trust merged into the plan. The net assets of the CDM Enterprises Inc. 401(k) Profit Sharing Plan & Trust totaling \$769,718 were transferred.

10. Subsequent Events

The Plan administrator evaluated events or transactions that occurred after December 31, 2024 and through September 11, 2025, the date the financial statements were available to be issued.


