## INDEPENDENT AUDITOR'S REPORT

To the Plan Committee  
TPS, LLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of TPS, LLC 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

### TPS, LLC 401(k) Plan

#### **1 Description of Plan**

The following description of the TPS, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan, which began March 1, 2014, is a defined contribution plan covering all employees of TPS, LLC (the “Company”) who are not leased employees, non-resident aliens, union employees or interns. Effective April 1, 2022, interns who have completed more than 1,000 hours of service are eligible. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Committee. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the Plan was amended to update the definition of Plan compensation.

##### ***Eligibility:***

All employees of the Company, except interns and those groups noted above, are eligible to participate in the Plan with no age or service requirements.

##### ***Contributions:***

Employee Contributions - Participants may contribute pre-tax compensation by way of a salary deferral contribution or post-tax compensation, by way of a Roth elective deferral contribution, both as defined by the Plan. Participants must designate the amount of contributions to be made pre- and post-tax. Participants without an affirmative deferral election are automatically enrolled at a rate of 6% of their compensation. This percentage is automatically increased annually, every January 1, by an increment of 1%, not to exceed a maximum of 10% of compensation.

Safe Harbor Matching Contributions – The Company makes a safe harbor matching contribution equal to 100% of the participant's salary deferral contributions that are not in excess of 3% of the participant's compensation, plus 50% of the participant's salary deferral contributions that are in excess of 3% of the participant's compensation but that do not exceed 5% of the participant's compensation.

Employer Discretionary Contributions - The Company may also make a discretionary additional matching contribution on behalf of all participants eligible to make elective deferrals. The Company made no discretionary additional matching contributions during 2024 or 2023.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

#### 1 Description of Plan, Continued

##### *Contributions, Continued:*

Contributions from Plan participants and from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

##### *Participants' Accounts:*

Each participant's account is credited with the participant's elective contributions and the Company's safe harbor matching contribution and allocations of any discretionary additional matching contribution and Plan earnings/losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting:*

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are immediately 100% vested in the Company's employer safe harbor matching contributions and employer discretionary additional matching contributions.

##### *Notes Receivable from Participants:*

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at a rate equal to 1.5% over the prime interest rate. Principal and interest are paid ratably through payroll deductions.

##### *Payment of Benefits:*

The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed. Benefits are recorded when paid.

##### *Hardship Withdrawals:*

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

#### **1 Description of Plan, Continued**

##### *Investment Options:*

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options daily.

#### **2 Summary of Significant Accounting Policies**

##### *Basis of Accounting:*

The Plan's transactions are reported on the accrual basis of accounting.

##### *Valuation of Investments:*

Investments are stated at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the unallocated insurance contract, which is held in the general account of an insurance company, guarantees the return of principal plus compounded interest earned, over a period of time.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### *Use of Estimates:*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### *Administrative Fees:*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable and certain other recordkeeping fees not paid by the Plan are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

##### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

## 2 Summary of Significant Accounting Policies, Continued

### *Risks and Uncertainties:*

The Plan's investments include interests in pooled separate accounts and an unallocated insurance contract with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan. On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

## 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 4 Fair Value Measurements, Continued

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### ***Pooled Separate Accounts:***

The fair value of the pooled separate accounts is based on the net fair value of the underlying assets. The underlying investments include designated mutual funds, or in some cases, common collective investment trusts which are valued daily at their net asset values (“NAV”). The NAV is calculated based on the fair values of the underlying securities. The Plan invests in shares of the pooled separate accounts and not directly in shares of the open-end mutual funds themselves. The fair value is allocated among the contract holders based on a unit value, and as such, these fall into the Level 2 category of the valuation hierarchy.

Participant transactions (purchases and sales) may occur daily. The obligation to make benefit payments is the obligation of Voya, as deemed by the contract. To the extent the benefits paid to contract owners exceed their account values, Voya will contribute additional funds.

##### ***Unallocated Insurance Contract (Voya Fixed Account):***

The fair value of the unallocated insurance contract is based on the value of the underlying assets, which are held in the insurance company’s general account. The Voya Fixed Account is credited with declared rates of interest and is subject to a minimum rate described in the contract. The fair value is expressed in units. The unallocated insurance contract is not deemed to be fully benefit responsive and is classified in the Level 3 category of the valuation hierarchy. Participant transactions may occur daily, there are no liquidity provisions and there are no restrictions on redemptions.
