Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Brookwood Companies, Inc. Tax Favored Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Brookwood Companies, Inc. Tax Favored Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering qualifying employees of The Brookwood Companies, Inc. (the Employer or Plan Administrator) which is comprised of Brookwood Companies Incorporated, Kenyon Industries, Inc. d/b/a Brookwood Finishing, Inc., Brookwood Laminating, Inc. and Swan Dyeing & Printing Corp. The Employer has appointed four employees to serve as trustees and fiduciaries with the authority and responsibility to administer the Plan. The Trustees also engage an independent co-fiduciary to assist in the selection and monitoring of the Plan's investments.

Effective January 1, 2024, the Plan Administrator adopted a resolution to merge the Swan Dyeing & Printing Corp. 401(k) Plan into this Plan and on February 1, 2024, total assets of \$739,670 were transferred into the Plan as a result of the merger.

Certain employees of Kenyon Industries, Inc. are not eligible to participate in the Plan because they receive retirement benefits as a result of a collective bargaining agreement between the Employer and employee union representatives. All other employees are eligible to participate in the Plan as of the first day of the calendar month following the completion of three months of service with the Employer and the attainment of age 19.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute any percentage of their annual pretax eligible compensation to the Plan, so long as those contributions do not exceed annual limitations set by the Internal Revenue Code (IRC). Participants may designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Plan includes an automatic enrollment provision whereby all newly eligible employees are enrolled in the Plan unless they affirmatively elect not to participate in the Plan. An initial pre-tax deferral election of 5% will be made for newly eligible employees with automatic annual increases of 1% for all contributing employees until a deferral rate of 10% is reached.

The Employer matching contribution is a discretionary contribution equal to a percentage of the eligible participant's elective deferrals in an amount determined annually by the Board of Directors. For the year ended December 31, 2024, the Employer matched 50% of participants' elective deferrals up to 6% of eligible compensation.

The Employer may also make a discretionary profit-sharing contribution as determined by its Board of Directors, subject to limits imposed by federal law. To be eligible for the Employer's discretionary profit-sharing contribution, participants must complete at least 1,000 hours of service in the Plan year and must be employed on the last day of the Plan year. These contributions will be allocated to participants in the ratio that each eligible participant's compensation bears to the total compensation paid to all eligible participants for the contribution period. No discretionary profit-sharing contributions were made during the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions, Plan earnings and losses and investment expenses. The allocations of earnings and losses are performed based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions, and accrued earnings thereon. Participants become fully vested in the Employer discretionary matching contributions, discretionary profit-sharing contributions and the annual allocation of Plan earnings on those contributions after five years of service. Participants are partially vested in the Employer discretionary matching contributions as follows: 20% after 1 year, 40% after 2 years, 60% after 3 years, 80% after 4 years, and 100% after 5 years. Each participant shall be 100% vested in their Employer discretionary matching contribution account upon death, disability or attainment of early retirement age while still employed.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms range from one to five years (or 10 years for the purchase of a primary residence). Notes are secured by the vested balance in the participant's account and bear interest at the prevailing commercial rate for loans of similar types. Principal and interest is paid ratably through payroll deductions. Participants can only have one note outstanding at any given time.

Payment of Benefits

Upon retirement, death, disability or termination of service, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of his or her account. The Plan provides for mandatory distributions to participants upon reaching age 73 or for participants who separate from service with account balances less than \$1,000 and who have not made a distribution election, in which case the Plan Administrator may, after proper notification, distribute the non-forfeited balance in accordance with the Plan document. Terminated participants whose vested balances are greater than \$1,000 but less than \$7,000 are to be rolled over into an individual retirement account designated by the Plan Administrator.

Upon reaching age 59½, participants may elect to withdraw all or a portion of their account balance while still employed by the Employer.

The Plan also permits qualified birth or adoption distributions, whereby a participant may receive a distribution up to \$5,000 during the one-year period beginning on the date on which the participant's child is born or on which the legal adoption by the participant of an eligible adoptee is finalized.

Effective January 1, 2024, the Plan adopted certain provisions of the SECURE Act 2.0. The adoptions consisted of treatment of Roth accounts for pre-death required minimum distributions and increased limits for involuntary automatic rollovers for small account balances and distributions from \$5,000 to \$7,000.

Hardship Withdrawals

A hardship withdrawal may be authorized by the Employer in an amount up to 100% of the participant's vested account balance.

Forfeitures

Participants in the Plan who leave the employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeitures first may be used to reduce future Employer matching contributions or to pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,980 and \$4,730, respectively. During the year ended December 31, 2024, forfeited non-vested amounts of \$23,935 were used to reduce Employer matching contributions.

Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for amounts allocated to the insurance company general account investment, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Contract value represents investments at cost plus accrued interest income less amounts withdrawn to pay benefits. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document.

Excess Contributions Refundable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants in the subsequent year.

Contributions

Participant contributions are recorded weekly or bi-weekly when the Employer remits the payroll deductions for investment into the Plan. Employer matching and profit-sharing contributions are recorded weekly or bi-weekly when the Employer remits the contributions for investment into the Plan, if applicable.

Payment of Benefits

Benefits are recorded when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid by the Employer, unless the Employer directs that such expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held two investments and one investment that accounted for approximately 22% and 11% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Money Market Fund: The carrying amount of the money market fund is deemed to be valued at deposit amount plus accrued interest, as determined according to stated terms.

Pooled Separate Accounts: Valued using the net asset value (NAV) provided by the administrator of the fund based on the valuation of the underlying investments. NAV is used as a practical expedient to estimate fair value. The pooled sperate accounts have a daily redemption frequency and no redemption notice period.

4. Investment Contract with Insurance Company

The Plan has entered into an investment contract (Fixed Account) with Voya Retirement Insurance and Annuity Company (Voya). Amounts held in connection with this contract may be held in Voya's general account or separate accounts, which invest in mutual funds advised by Voya, mutual funds sub-advised by third parties, mutual funds managed by external mutual fund companies or invested directly in securities.

Contributions allocated to the Fixed Account are invested in the general account of, and are guaranteed by, Voya. All other contributions allocated to any investment fund become part of separate accounts and are maintained separately from the general assets of Voya. The value of these contracts included in the financial statements, as reported to the Plan by Voya, is equal to the sum of the contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

The contract value of funds allocated to the traditional general account investment with Voya at December 31, 2024 and 2023 was \$2,760,283 and \$3,264,824, respectively. The crediting interest rate was 2.50% and 2.13% for the years ended December 31, 2024 and 2023, respectively. Withdrawals from this investment for other than the payment of benefits may be subject to a market value adjustment and a surrender charge and the ability to move funds out of this investment may be restricted by Voya.

The guarantee of values provided for investments made with Voya under the Plan's investment contract is based on the financial strength and claims-paying ability of Voya.

5. Income Tax Status

The Plan is an adoption of a volume submitter plan which received an advisory letter from the IRS on June 30, 2020. The Plan was amended subsequent to receiving the advisory letter. However, the Plan Administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Summary of Financial Data Certified by the Custodian

The following is a summary of financial information and data certified by the custodian, Voya:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for Employer contributions receivable, participant notes receivable and excess contributions refundable.

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided on the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024, except for participant notes receivable.

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Voya, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payment to Voya for administrative services of \$54,765 for the year ended December 31, 2024. In addition, participant notes receivable qualify as party-in-interest transactions. Four employees serve as trustees of the Plan.

9. Subsequent Events

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0, allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through August 6, 2025, which is the date these financial statements were available to be issued.
