INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee and Trustee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Advanced Roofing Retirement and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Advanced Roofing Retirement and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1. DESCRIPTION OF PLAN

The following description of the Advanced Roofing Retirement and Profit Sharing Plan (the Plan) provides only general information. For more comprehensive information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

General

The Plan was established effective January 1, 1994, for all eligible employees of Advanced Roofing, Inc (the Sponsor) and other members of the controlled group: Advanced Green Technologies, Inc, and Advanced Roofing of Central Florida, LLC. The Plan has been amended throughout the years to comply with tax legislation and was most recently restated effective July 17, 2023. The Plan is a defined contribution 401(k) savings and profit sharing plan. The Plan provides for contributions under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The retirement plan committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

In order to be eligible to participate in the Plan, an employee must have 500 hours of service during at least six months of the year, have one year of service, and be at least 18 years old. Employees with prior service with affiliates are also eligible to participate. Leased employees, union employees and residents of Puerto Rico are not eligible to participate.

Funding

Participants may contribute up to 100% of pretax annual eligible compensation, as defined by the Plan. According to the Internal Revenue Service (IRS) rules, the deferral may not exceed \$23,000 in 2024 and \$22,500 in 2023, respectively. Participants who have reached at least age 50 may contribute an additional \$7,500 during 2024 and 2023.

The Plan sponsor made a discretionary matching contribution equal to \$0.50 of each \$1.00 contributed by an eligible participant. The amount contributed was limited to the lesser of: (1) the actual participants contributions or (2) 6% of the participant's compensation. The Plan sponsor may also make discretionary profit sharing contributions to the Plan, subject to eligibility requirements as defined by the Plan. There were no profit sharing contributions made during the year ended December 31, 2024.

Participants may also rollover amounts representing distributions from other qualified benefit or contribution plans.

Participant Accounts

Each participant's account is credited with 1) employee contributions, 2) the employer's matching contribution and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is also charged with any distributions made to that participant.

Vesting

Participants are immediately vested in all salary deferral contributions. The employer's matching and profit sharing contributions have a six-year graded vesting schedule, whereby 20% is vested after year two, 40% is vested after year three, 60% is vested after year four, 80% is vested after year five, and 100% is vested after year six. An employee's vesting percentage increases to 100% upon death while employed with the Plan Sponsor.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms may range from 1 - 5 years unless the loans were for the purchase of a primary residence. The loans would be secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates provided by local lending institutions. Principal and interest would be paid ratably through biweekly payroll deductions. For the year ended December 31, 2024, the interest rate on notes receivable from participants ranged from 4.25% to 9.50% with various maturities through 2046. Participants had outstanding loan balances totaling \$578,800 and \$529,288 as of December 31, 2024 and 2023, respectively, and were recorded as notes receivable from participants in the accompanying statements of net assets available for benefits.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, subject to 20% withholding for income taxes, or as direct rollover to an individual retirement account or another employer's tax qualified plan. The Plan administrator may permit a participant to take partial distributions or installment distributions solely to the extent necessary to satisfy the IRS rules. A participant who terminates employment with a vested account balance exceeding \$5,000 may receive a distribution of his/her vested account balance within a reasonable period following the date the participant terminates employment. A participant who terminates employment with a vested account balance that does not exceed \$5,000 will receive a single lump-sum distribution without the election or request of the participant. The Plan also allows for in-service distributions of participant deferrals, upon attaining early retirement age of 55, subject to IRS limitations.

Forfeitures

Forfeitures of matching and profit sharing contributions, and excess aggregate contributions shall be used to fund employer's matching contributions. Forfeitures of \$24,821 were used by the Plan Sponsor for payment of employer contributions during the year ended December 31, 2024.

Termination

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk

Financial instruments which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments and receivables. The Plan invests in pooled separate accounts which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the excess contributions and related earnings in the year subsequent to when the excess contributions were received.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

Ameritas Life Insurance Corporation (Ameritas) held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ameritas has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally pooled separate accounts) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying pooled separate accounts and guaranteed insurance contract investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,012,104. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodology used for investments measured at fair value. There has been no change in the methodology used as of December 31, 2024.

Pooled separate accounts: Valued at annuity units based on the value of the participant’s share of the pooled separate account (NAV equivalent). Annuity units, as provided by the Custodian, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the pooled separate account less its liabilities.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. GUARANTEED INVESTMENT CONTRACT

The Plan holds a contract with Ameritas. The assets are invested in an account that is fully benefit-responsive and is reported as Ameritas Guaranteed Account in the Plan’s accounting records.

Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the Ameritas Guaranteed Account become part of Ameritas’s general account, and there are no particular segregated or identifiable assets ascribed to the Plan’s investment. Net deposits and interest credited become liabilities against Ameritas Life Insurance Corporation on the Plan’s behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Ameritas Life Insurance Corporation; there are no wrap contracts supporting the liquidity of the fund. The account is neither a mutual fund nor a bank product. Ameritas Life Insurance Corporation’s obligations are not insured by the FDIC or any other federal government agency. As of December 31, 2024 and 2023, the balance of the investment contract was \$1,043,859 and \$955,855, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Crediting rates for the Plan's Ameritas Guaranteed Account are set by Ameritas Life Insurance Corporation using a process similar to that used by banks or other insurance companies for similar products. Such interest rates are reviewed on a periodic basis.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. If the Plan Sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the Plan's account manager. Under no event may Ameritas Life Insurance Corporation terminate the contract and settle at an amount different from contract value. The average yield for the year ended December 31, 2024 was 3.15%.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ameritas, which is the record-keeper and custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Ameritas amounted to \$8,162 for the year ended December 31, 2024. The Plan Sponsor also paid certain administrative expenses of the Plan.

Notes receivable from participants were also considered party-in-interest transactions.

All of party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7. RELATED PARTIES

Advanced Roofing, Inc. is the Plan's employer and sponsor. They absorb virtually all administrative expenses of the Plan.

NOTE 8. INCOME TAX STATUS

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes no such positions have been taken.

NOTE 8. INCOME TAX STATUS (Continued)

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to 2021.

NOTE 9. PROHIBITED TRANSACTION

The Department of Labor's (DOL) regulation 29 CFR 2510.3-102 requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Company's general assets. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction, which must be separately reported to the DOL and may result in penalties to the Plan sponsor.

During 2024, the participant deferrals of four payroll files totaling \$146,062 (including loan payments of \$25,381) were not remitted timely to the Plan. Subsequent to the due date, but prior to the Plan's year-end, the sponsor remitted the contributions. Correction of interest and investment gain was subsequently remitted. These are shown as pending correction in the Schedule of Delinquent Participant Contributions.

NOTE 10. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.
