Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Jamestown Companies Retirement Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Jamestown Companies Retirement Plan & Trust (the “Plan”) provides only general information. Participants should refer to the plan document or summary plan description, both of which are available from the plan administrator, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Jamestown Metal Marine Sales, Inc. (the “Company”) for the benefit of its full-time employees who have completed at least three months of service, and are not excluded by any other provisions of the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Plan Administration

Reliance Trust Company (“Reliance”) served as the Plan’s trustee. Effective June 28, 2024, the Plan’s trustee changed from Reliance to Transamerica Trust Company (“Transamerica Trust”). Transamerica Financial Life Insurance Company (“Transamerica”) serves as the Plan’s recordkeeper for both 2024 and 2023.

Plan Amendments

Effective June 1, 2024, the Plan was amended to remove substantially equal installments as a form of distribution, permit qualified reservist distributions, set the home loan term to 30 years, set the loan interest rate to 1% above the prime interest rate, and accept direct rollovers and participant rollover contributions from IRAs.

Contributions

Participants may contribute any amount of their eligible compensation, as defined in the plan document, without exceeding limitations prescribed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan calls for automatic deferrals of employees’ eligible compensation upon reaching eligibility for participation in the Plan at a deferral rate of 2%, unless the employee affirmatively elects not to contribute or makes a different election. Additionally, participants age 50 or older, who are contributing to the Plan, are allowed to make catch-up contributions, as defined in the plan document. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may also make contributions to the Plan in the form of matching or profit sharing contributions for eligible participants who have completed at least one year of service. These contributions are determined annually and are made at the discretion of the Company’s management. Discretionary profit sharing contributions are allocated to each eligible participant’s account in the same proportion that compensation plus compensation in excess of the social security taxable wage base (“Excess Compensation”) bears to the total compensation plus Excess Compensation of all eligible participants, provided the total to be allocated for the year does not exceed 5.7% of total eligible compensation plus Excess Compensation. Any remaining Company contributions are then allocated in the proportion of the total compensation paid to the participant for that plan year bears to the total compensation paid to all eligible participants for the same year.

For purposes of determining eligibility for discretionary profit sharing contributions, participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year. The Company did not make any discretionary matching or profit sharing contributions applicable to the years ended December 31, 2024 and 2023.

All contributions made by the Plan’s participants and the Company are subject to certain limitations as prescribed by the Internal Revenue Code (the “Code”).



NOTE 1 – DESCRIPTION OF PLAN, CONTINUED

Participant Investment Account Options

The Plan currently offers various mutual funds, exchange traded funds, and a stable value fund (through a common collective trust) as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, if any, as well as allocations of the Company's profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The expense allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the Company's contributions are based on years of continuous service as follows:

Forfeited Accounts

Forfeited nonvested accounts are first used to pay the Plan's expenses, then may be used to reduce Company contributions, if any. Unused forfeitures at December 31, 2024 and 2023, and forfeited nonvested accounts for the years then ended were not significant.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate as published by the Wall Street Journal on the date of the note, plus 1%. All notes must be repaid to the Plan within five years, unless the funds are used for the purchase of the participant's primary residence in which case the repayment period may be longer. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, or qualifying under certain hardship rules as prescribed by the Internal Revenue Service ("IRS"), a participant is eligible to receive distributions from the Plan. Participants are also eligible for in-service distributions upon attaining 59 ½ years of age. Distributions greater than \$5,000 may be in the form of one lump-sum payment, an annuity, or a rollover into another qualified defined contribution or benefit plan or individual retirement account. Installment payments were an allowable form of distribution through May 31, 2024. Effective June 1, 2024, the Plan was amended to remove substantially equal installments as a form of distributions, except for required minimum distributions.



NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Capital gain dividends from the mutual fund investments, exchange traded funds, and common collective trust are reported as a component of interest and dividends.

Contributions

Contributions from Plan participants and Company contributions are recorded in the year in which the participant contributions are withheld from compensation and compensation is paid to the participant.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are expensed as incurred and are recorded as investment expenses, which are netted within net appreciation in fair value of investments on the statements of changes in net assets available for benefits. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and are not included on the statements of changes in net assets available for benefits. Other expenses, such as trustee, recordkeeping, investment advisory fees, and third party administrator fees are paid for by the Plan and are included in administrative expenses on the statements of changes in net assets available for benefits.



NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance (for the period January 1, 2023 through June 30, 2024), and Transamerica Trust (for the year ended December 31, 2024), the trustees of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividend income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.



NOTE 4 – FAIR VALUE MEASUREMENTS, CONTINUED

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (the “SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange Traded Funds

Valued at the market price as reported by the fund. Exchange traded funds held by the Plan are registered with the SEC. These funds allow intraday trading at market values derived from the underlying securities of the companies comprising the related index. The exchange traded funds held by the Plan are deemed to be actively traded.

Stable Value Common Collective Trust

A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the financial institution collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methodologies described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan’s management believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan’s assets were in the custody of Reliance and Transamerica Trust, the trustees, as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Transamerica is the Plan’s recordkeeper, and therefore, these transactions also qualify as party-in-interest. The Plan also utilizes Merrill (a wholly owned subsidiary of Bank of America) as an investment broker and advisor, and Florida Retirement Consultants serves as the Plan’s third-party administrator. Therefore, transactions with each of these entities also qualify as party-in-interest. Aggregate fees paid to these parties-in-interest during the years ended December 31, 2024 and 2023 amounted to \$97,727 and \$84,003, respectively. The Company directly pays all other expenses related to the Plan’s operations.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan’s termination, participants would become 100% vested in the Company’s contributions.

NOTE 7 – TAX STATUS

The Company has adopted a non-standardized pre-approved defined contribution plan provided by Florida Retirement Consultants. The IRS has issued an opinion letter to Florida Retirement Consultants dated June 30, 2020 stating that the non-standardized document is designed in accordance with the applicable sections of the Code. Although the Plan has been amended since the date of this letter and has not applied for or received its own determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits in progress for any tax periods.



NOTE 8 – RISKS, UNCERTAINTIES, AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

As of both December 31, 2024 and 2023, approximately 48% of the Plan's investments were invested in two funds.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

Certain line items reported on Schedule H for Form 5500 have been reclassified in the financial statements. These reclassifications have no impact on net assets available for benefits at December 31, 2024 and 2023 or changes in net assets available for benefits for the years then ended.

NOTE 10 – DELINQUENT PARTICIPANT CONTRIBUTIONS

Employers participating in defined contribution plans are required to remit participant contributions as soon as they can be reasonably segregated from the employer's general assets. Although all participant contributions have been remitted to the Plan, contributions aggregating \$15,743 were not timely remitted during the year ended December 31, 2024. The Company is in the process of calculating and remitting lost earnings applicable to these delinquent contributions.

NOTE 11 – SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
