## INDEPENDENT AUDITOR'S REPORT

### ***Opinion***

We have audited the financial statements of The Great Lakes Construction Co. and Related Companies Employee Stock Ownership Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### The Great Lakes Construction Co. and Related Companies Employee Stock Ownership Plan

#### 1 Description of Plan

The following description of The Great Lakes Construction Co. and Related Companies Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Great Lakes Construction Co. (the “Company”) established The Great Lakes Construction Co. and Related Companies Employee Stock Ownership Plan on September 15, 1980.

The Plan operates as a leveraged employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by the ESOP Committee comprised of five or more persons, including at least three non-management members of the Board of Directors of the Company and two Company management members, one of which is the Chief Executive Officer. ESOP committee members serve one-year terms.

On November 15, 2021, the Plan received financing through the Great Lakes Companies, Inc. in the form of a note payable in order to purchase 60,000 total shares of the Great Lakes Companies, Inc. stock. As the Plan makes each payment of principal and interest, an appropriate percentage of stock is allocated to eligible employees’ accounts in accordance with the applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares. The lender has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the years then ended present separately the assets and liabilities and changes therein pertaining to:

- (a) The accounts of employees with vested rights in allocated shares (“Allocated”) and
- (b) Shares not yet allocated to employees (“Unallocated”).

##### ***Eligibility:***

All employees of the Company, with the exception of college interns, are eligible to participate in the Plan. Employees whose employment is governed by a collective bargaining agreement and independent contractors are excluded from participation in the Plan. Participants who are not employed on the last day of the Plan year are generally not eligible for an allocation of Company contributions for such year.

##### ***Contributions:***

Each year, the Company may make discretionary contributions to the Plan solely at the discretion of the Company’s Board of Directors. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

NOTES TO FINANCIAL STATEMENTS

The Great Lakes Construction Co. and Related Companies Employee Stock Ownership Plan

**1 Description of Plan, Continued**

***Participants' Account:***

Each participant's account is credited with an allocation of the Company's discretionary contribution and Plan earnings and losses thereon. Contributions to the Plan are allocated to each eligible participant based upon the participant's eligible compensation for the Plan year, as defined by the Plan. Plan earnings or losses are allocated annually based on each participant's account balance.

***Diversifications:***

Any participant or former participant who has attained the age of 55 with at least 10 years of service/participation may diversify a portion of the assets in their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the Company stock allocated to their account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company stock in the participant's account at year-end.

***Vesting:***

Vesting in the participant's account balance is based on years of service. A participant is vested as follows:

Less than One Year	0%

Two Year but less than Three Years	40%
Three Year but less than Four Years	60%
Four Year but less than Five Years	80%
Five or More Years	100%

***Forfeitures:***

The non-vested portion of a terminated participant's account under the Plan shall constitute a forfeiture. Forfeitures are allocated to the accounts of active participants based on the same formula used to allocate Company contributions. During 2024 and 2023, approximately \$68,065 and \$22,706, respectively, were forfeited into the suspense account and redistributed to eligible participant accounts. The outstanding forfeiture balance was \$0 for both years.

#### *Payment of Benefits:*

Upon termination of service by reason of retirement, death or total and permanent disability, a participant may elect to receive a lump sum amount equal to the value of his or her account or annual installments over a future period not longer than the life of the participant or participant's beneficiary. Payment of benefits will be in the form of cash or Company stock, or both. A participant may designate that the entire payment be in the form of Company stock. If cash is required for distributions, the Company may make additional contributions or the Plan has the ability to obtain a loan collateralized by the Company stock.

If the participant's account balance is less than \$1,000, the Plan may make an automatic lump-sum distribution to the participant equal to the participant's vested interest in his or her account. The Plan requires the mandatory repurchase by the Company of terminated participants' holdings of the Company stock. The repurchase schedule is based on a participant's continuous years of service prior to termination. The repurchase period ranges from one lump-sum repurchase in the first year following separation to installment repurchases over a five-year period, as defined. The mandatory repurchase period begins on the last day of the Plan year following the Plan year in which a participant's termination occurs. Proceeds from the sale of Company stock for terminated participants that did not elect a distribution from the Plan are transferred into a Qualified Default Investment Account which is currently held in a mutual fund.

#### *Related Party and Parties-in-Interest:*

The Great Lakes Companies, Inc. stock is held by the ESOP and is a party-in-interest and related party to the Plan. In addition, the Plan has a number of service providers and these providers qualify as parties-in-interest under ERISA.

#### *Put Option:*

Under federal income tax regulations, Company stock that is held by a Plan and its participants and is not readily tradeable on an established market or subject to trading limitations, must include a put option. The put option provided by the Company allows participants and beneficiaries to require the Company to repurchase any shares distributed to them within a sixty-day period from the date of distribution at the most recent annual fair market value as reported by an independent third party appraiser. If the put option is not exercised within the initial sixty-day period, it may be exercised within an additional sixty-day period in the following Plan year. If the put option is not exercised in either period, the mandatory repurchase of terminated participants' holdings of Company stock will occur over a one to five-year period, as defined.

#### *Voting Rights:*

The Trustee, The Great Lakes Companies, Inc. ESOP Advisory Committee, votes on behalf of the Plan and is required to vote on behalf of the collective best interest of Plan participants and beneficiaries. Plan participants may vote directly on issues related to the merger, sale or liquidation of the Company.

### **2 Summary of Significant Accounting Policies**

#### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

#### ***Investment Valuation and Income Recognition:***

The Plan's investments are stated at fair value. Company common stock is valued by an independent third party appraiser.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

#### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### ***Administrative Fees:***

Substantially all administrative fees are paid by the Company.

#### ***Benefit Payments:***

Benefit payments are recorded when paid or stock is distributed.

#### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

#### ***Risks and Uncertainties:***

The Plan's investments include investments in mutual funds and employer stock. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

### 2 Summary of Significant Accounting Policies, Continued

#### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

### 3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

### 4 Investment in Company Stock

Plan investments are carried at fair market value and consist of voting common stock. The fair market value per share of the stock, as determined by an independent appraiser, was \$205.60 and \$172.50 at December 31, 2024 and 2023, respectively.

### 5 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices. This investment is classified within Level 1 of the valuation hierarchy.

#### ***Common Stock:***

The fair value of the Company common stock held by the plan is valued at fair value based upon an independent appraisal. These instruments are classified within Level 3 of the valuation hierarchy. This appraisal was based upon the market valuation method consistent with prior years. The appraiser took into account historical cash flow and net income, return on assets, return on equity, revenue multiples, EBIT multiples, EBITDA multiples, and public company comparables. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. The valuation process involves plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which the ESOP Committee, along with the Board of Directors, reviews in detail, discusses and approves. The results of this process are documented in minutes of the Plan.

### 5 Fair Value Measurements, Continued

*Common Stock, Continued:*

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, the Plan had purchases of assets using significant unobservable inputs of \$859,446 and \$277,274, respectively. In addition, the Plan had sales of assets using significant unobservable inputs of \$5,041,374 and \$6,578,648, respectively.

In 2024, there was \$86,496 of shares redeemed by the Company and transferred to the mutual fund.

### 6 Loan Payable

In 2021, the Plan entered into a \$7,665,000 term loan agreement with the Great Lakes Companies, Inc. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments.
