### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Association Member Benefits Advisors, LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the Association Member Benefits Advisors, LLC 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering eligible employees of Association Member Benefits Advisors, LLC (“AMBA”), AMBA Administrators, Inc., and AMBA Employment Corporation (collectively, the “Company” or the “Plan Sponsor”) who have one month of service and are age 21 and older. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

(b) Contributions

Each year, participants may contribute up to the maximum dollar amount determined by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan.

The Company provides a safe harbor matching contribution as follows: the Company matches participant deferrals at 100% of the first 1% of compensation, plus 50% of participant deferrals on the next 5% of compensation. Additional profit sharing amounts may be contributed at the discretion of the Company’s board of directors. During the years ended December 31, 2024 and 2023, the Company did not make additional profit sharing plan contributions to the Plan. Contributions are subject to certain IRS limitations.

(c) Participant Accounts

Each participant's account is credited with the participant’s contributions and the Company’s safe harbor matching contributions, as well as allocations of the Company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of the Plan (continued)

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Company safe-harbor matching contributions are 100% vested to the participant after two full years of service. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Full vesting in employer contributions also occurs upon death, total disability, or retirement at or after age sixty-five.

(e) Notes Receivable from Participants

Participants may borrow from the vested portion of their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan terms generally may not exceed five years. The loans are secured by the participant's account and bear interest at a rate determined by the plan administrator. The loan interest rates range from 4.25% to 9.5%. Principal and interest are paid ratably by payroll deductions.

(f) Forfeited Accounts

If a participant chooses to withdraw from the Plan before fully vesting in employer contributions, the unvested balance is forfeited and may be used by the Company to pay administrative expenses or reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$75,367 and \$50,327, respectively. Forfeitures amounting to \$50,606 were subsequently used to fund the employer match true-up amount at December 31, 2024. No forfeitures were utilized during 2023.

(g) Payment of Benefits

The Plan provides that distributions of amounts of \$7,000 or less be paid as a lump-sum. For account balances greater than \$7,000, on termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or various installment options over extended periods of time.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of investments held by the Plan and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Administrative Expenses

The plan document allows for the expenses of maintaining the Plan to be satisfied directly out of the Plan's assets. A portion of the administrative expenses of the Plan is paid by the Company. Also, certain transaction charges are paid by the participants involved. Investment related expenses are included in net appreciation in fair value of investments.

(f) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(g) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(3) Investments and Fair Value Measurements

The Plan invests in mutual funds and a collective investment trust. Investments are reported at fair value. The following methods and assumptions were used to estimate fair value:

- *Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U. S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Collective investment trust:* The collective investment trust indirectly holds investments in fully-benefit responsive investment contracts; therefore, the Plan's investment in the trust is reported at net asset value as a practical expedient to fair value. The objective of the trust is to reserve principal value while generating earnings at competitive rates. Participant transactions (purchases and sales) may occur daily and normally are transacted using the net asset value. If the Plan initiates a full redemption of the trust, the issuers reserve the right to require up to 30-day notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 and 2023.

(3) Investments and Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The financial information included in the Plan's financial statements, except for contributions receivables, notes receivable from participants, contributions, interest on notes receivable from participants, benefits paid to participants, and administrative expenses, has been derived from information certified as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(5) Tax Status

The Plan is using a non-standardized pre-approved profit sharing plan document. In a letter dated June 30, 2020, the Internal Revenue Service ("IRS") indicated the standardized form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code section 401(a). Although the Plan has been amended since receiving the acceptability letter, the Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Delinquent Participant Contributions

Effective December 23, 2022, a new custodian and record-keeper were appointed. The conversion initiated a black-out period from December 23, 2022 to January 16, 2023 whereby funds could not be applied to the participant selected funds with the new custodian. Participant contributions totaling \$97,030 were withheld from participants' wages on January 13, 2023, but based on instructions from the new custodian and recordkeeper, were not allowed to be remitted to the Plan until January 26, 2023, which was not within the timeframe required by the DOL under the plan asset rules. This constitutes a loan from the Plan to the Company. The Company remitted interest and related excise taxes totaling \$205 to the Plan in September 2024.

(9) Party-In-Interest Transactions

The Plan has not considered contributions to the Plan or benefits paid by the Plan to participants as party-in-interest transactions.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Association Member Benefits Advisors, LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental schedules, Schedule of Delinquent Participant Contributions for the Year Ended December 31, 2024 and Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has

been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the Association Member Benefits Advisors, LLC 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering eligible employees of Association Member Benefits Advisors, LLC (“AMBA”), AMBA Administrators, Inc., and AMBA Employment Corporation (collectively, the “Company” or the “Plan Sponsor”) who have one month of service and are age 21 and older. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

(b) Contributions

Each year, participants may contribute up to the maximum dollar amount determined by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan.

The Company provides a safe harbor matching contribution as follows: the Company matches participant deferrals at 100% of the first 1% of compensation, plus 50% of participant deferrals on the next 5% of compensation. Additional profit sharing amounts may be contributed at the discretion of the Company’s board of directors. During the years ended December 31, 2024 and 2023, the Company did not make additional profit sharing plan contributions to the Plan. Contributions are subject to certain IRS limitations.

(c) Participant Accounts

Each participant's account is credited with the participant’s contributions and the Company’s safe harbor matching contributions, as well as allocations of the Company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of the Plan (continued)

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Company safe-harbor matching contributions are 100% vested to the participant after two full years of service. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Full vesting in employer contributions also occurs upon death, total disability, or retirement at or after age sixty-five.

(e) Notes Receivable from Participants

Participants may borrow from the vested portion of their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan terms generally may not exceed five years. The loans are secured by the participant's account and bear interest at a rate determined by the plan administrator. The loan interest rates range from 4.25% to 9.5%. Principal and interest are paid ratably by payroll deductions.

(f) Forfeited Accounts

If a participant chooses to withdraw from the Plan before fully vesting in employer contributions, the unvested balance is forfeited and may be used by the Company to pay administrative expenses or reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$75,367 and \$50,327, respectively. Forfeitures amounting to \$50,606 were subsequently used to fund the employer match true-up amount at December 31, 2024. No forfeitures were utilized during 2023.

(g) Payment of Benefits

The Plan provides that distributions of amounts of \$7,000 or less be paid as a lump-sum. For account balances greater than \$7,000, on termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or various installment options over extended periods of time.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of investments held by the Plan and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Administrative Expenses

The plan document allows for the expenses of maintaining the Plan to be satisfied directly out of the Plan's assets. A portion of the administrative expenses of the Plan is paid by the Company. Also, certain transaction charges are paid by the participants involved. Investment related expenses are included in net appreciation in fair value of investments.

(f) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(g) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(3) Investments and Fair Value Measurements

The Plan invests in mutual funds and a collective investment trust. Investments are reported at fair value. The following methods and assumptions were used to estimate fair value:

- *Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U. S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Collective investment trust:* The collective investment trust indirectly holds investments in fully-benefit responsive investment contracts; therefore, the Plan's investment in the trust is reported at net asset value as a practical expedient to fair value. The objective of the trust is to reserve principal value while generating earnings at competitive rates. Participant transactions (purchases and sales) may occur daily and normally are transacted using the net asset value. If the Plan initiates a full redemption of the trust, the issuers reserve the right to require up to 30-day notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 and 2023.

(3) Investments and Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

(4) Information Certified by the Custodian

The financial information included in the Plan's financial statements, except for contributions receivables, notes receivable from participants, contributions, interest on notes receivable from participants, benefits paid to participants, and administrative expenses, has been derived from information certified as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(5) Tax Status

The Plan is using a non-standardized pre-approved profit sharing plan document. In a letter dated June 30, 2020, the Internal Revenue Service ("IRS") indicated the standardized form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code section 401(a). Although the Plan has been amended since receiving the acceptability letter, the Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Delinquent Participant Contributions

Effective December 23, 2022, a new custodian and record-keeper were appointed. The conversion initiated a black-out period from December 23, 2022 to January 16, 2023 whereby funds could not be applied to the participant selected funds with the new custodian. Participant contributions totaling \$97,030 were withheld from participants' wages on January 13, 2023, but based on instructions from the new custodian and recordkeeper, were not allowed to be remitted to the Plan until January 26, 2023, which was not within the timeframe required by the DOL under the plan asset rules. This constitutes a loan from the Plan to the Company. The Company remitted interest and related excise taxes totaling \$205 to the Plan in September 2024.

(9) Party-In-Interest Transactions

The Plan has not considered contributions to the Plan or benefits paid by the Plan to participants as party-in-interest transactions.
