Opinion

We have audited the financial statements of Insulators Local No. 2 Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Insulators Local No. 2 Annuity Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Insulators Local No. 2 Annuity Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. *General* - The Plan is a defined contribution plan covering all employees working under the jurisdiction of the Insulators Local Union No. 2, who are employed by an employer who is obligated, pursuant to a collective bargaining agreement or other written document, to make contributions on their behalf to the fund. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan's investments are participant directed.
2. *Contributions*. Under a collective bargaining agreement, participating employers contribute at the agreed rate per hour for each participant covered. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and common collective trusts as investment options for participants. Contributions are subject to certain limitations.
3. *Participant Accounts*. Each participant's account is credited with (a) the employer's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting*. Participants are 100 percent vested immediately.
5. *Payment of Benefits*. When a participant meets one of the conditions which precipitate payment, he may choose either a lump sum payment or one of several annuity options. There are also provisions for payment to designated beneficiaries if a participant dies before receiving the full amount in his account. Amounts due participants at any time are limited in total to the net assets of the Plan.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting** - The accounting records of the Fund are maintained on the accrual basis.

**Investment Valuation and Income Recognition** - Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits** - Benefits are recorded when paid.

**NOTE C - ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the organization's management to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE D - SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through August 20, 2025, the day the financial statements were approved and authorized for issue.

**NOTE E - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered Investment Companies - Mutual Funds* are valued at the net asset value of shares held by the plan at year end.

*Common Collective Trusts* - Valued at unit values provided by the respective trustees of those trusts based on the estimated fair value of the underlying investments held by the trust as determined by the trustees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F - PLAN TERMINATION**

Although it has not expressed an intent to do so, the Plan has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100 percent vested in their account balances.

**NOTE G - TAX STATUS**

The Internal Revenue Service has determined and informed the Plan by a letter dated April 20, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
