Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Texas Health 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of the Texas Health 401(k) Retirement Plan (the Plan) provides only general information. Reference should be made to the Plan document, as amended, for a more complete description of the Plan's provisions. The plan sponsor, Texas Health Resources, a Texas non-profit corporation, operates through its controlled affiliates a health care system with services and facilities throughout north central Texas.

General

The Plan is a defined contribution plan qualified under Section 401(k) of the Internal Revenue Code of 1986, as amended (the Code), covering all eligible employees of Texas Health Resources (the Plan Sponsor), and any adopting employers (collectively, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was effective January 1, 1998, and the investment of the assets is 100% participant-directed.

Administration

Fidelity Workplace Services LLC (Fidelity) provides recordkeeping and administrative services to the Plan Sponsor on behalf of the Plan and is an authorized agent of Fidelity Management Trust Company (the Custodian). SEI Trust Company serves as the trustee for the Investments in the Master Trust (Master Trust Trustee). The Custodian invests cash received and plan earnings, as directed by the participants, and makes distributions to participants. The Governance Committee, as appointed by the Board of Trustees, is the named fiduciary responsible for overall administration and operation of the Plan and is the trustee of the Plan.

Eligibility

All employees of the Employer are eligible to participate in the Plan as of the first day of the payroll period immediately following the employee's first day of service.

Participant Contributions

Participant before-tax and Roth 401(k) contributions are made each pay period based on eligible compensation. In general, participants may contribute from 1% to 100% of their eligible compensation, subject to federal legal limits. All contributions must be made in whole percentages (flat dollar amounts are not allowed). The annual participant contribution for 2024 and 2023 was limited to \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions. The annual catch-up contribution for 2024 and 2023 was limited to \$7,500. Under certain conditions, participants may be eligible to rollover distributions from a previous employer's 401(k) plan, 403(b) plan, or other qualified defined contribution plan, or conduit individual retirement account (IRA).

Employer Contributions

Each pay period, the Employer makes a matching contribution to the account of each participant who contributes at least 2% of eligible compensation. The Employer's matching contribution is the amount listed below, based on the participant's years of service, for every dollar the participant defers under the Plan up to the first 6% of the participant's eligible compensation. A participant's years of service for purposes of the employer matching contribution is increased as of the first day of the payroll period that includes the participant's anniversary date of employment. The employer matching contribution per dollar of participant contribution equals:

Years of Credited Service	Employer Contribution Amount
0.5 but less than 5	\$0.75
5 but less than 10	\$1.00
10 or more	\$1.25

Participant Accounts

Each participant's account is credited with the participant's contribution and rollovers (if any), employer's contribution, and allocated plan earnings or losses. Allocations are based on the proportion that their account balance bears to all participants' accounts in each investment fund. The participant's account is charged with any loan fees and brokerage account fees incurred by the Plan on their behalf. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The investing of participant account balances is self-directed by each participant among the available mutual and common collective funds or brokerage account selected by the trustee of the Plan. Participants may invest 50% of their total account balance in the brokerage account. All fees associated with the brokerage account are paid by the participating employees. Participants may modify or transfer investments between the designated mutual and common collective funds or brokerage account at any time during the year. If the participant fails to provide investment allocation directions, the participant's account is invested in the Plan's qualified default investment fund. The default is a series of target retirement date asset allocation common collective funds, JPMorgan Chase Bank (JPMorgan) SmartRetirement Funds, which most closely align with the participant's retirement age of 65.

Vesting

Participants are 100% vested in their before-tax contributions, Roth 401(k) contributions, rollover contributions (if any), and the earnings, net of expenses and losses, on these amounts. Participants become vested in the Employer's matching contributions and the earnings on those contributions based on their credited years of service as follows:

Years of Credited Service	Vesting in Match
Less than 2	None
2 but less than 3	25%
3 but less than 4	50%
4 but less than 5	75%
5 or more	100%

Participants become 100% vested in their account, regardless of years of service, in the event of normal retirement, disability, or death.

Notes Receivable from Participants

Participants may borrow money from the before-tax and Roth 401(k) participant contributions and rollovers in their account, subject to certain limits and requirements. The participant must borrow a minimum of \$1,000. The maximum a participant may borrow is the lesser of (1) 50% of the participant's before-tax contributions, Roth 401(k) contributions, and rollovers, including earnings, or (2) \$50,000, reduced by the participant's highest outstanding balance of loans from the Plan in the prior 12 months. The plan administrator establishes the interest rate on loans, and the interest paid on loans is fixed for the period of the loan. Currently, the interest rate is the prime interest rate as of the first of the month when the request is received plus 1%. At December 31, 2024, interest rates on participant loans, due through 2044, ranged from 4.25% to 9.50%. The loan is secured by the participant's remaining account balance. The repayment period available for loans depends on the reason for the loan. For a general-purpose loan, the participant can elect a repayment period up to five years. For a loan to purchase a principal residence, the participant can elect a repayment period of up to 20 years, and documentation of the purchase must be provided.

Payment of Benefits

Participants may receive a distribution from the Plan while an employee when they reach age 59 1/2 or later, or during a time of serious financial hardship. The Plan will pay a participant's vested account balance at normal retirement (age 65 or later), termination of employment, disability, or death. The participant's account will be valued on the day that the proper paperwork is received and processed by Fidelity. Payment is issued in a lump sum.

Forfeited Accounts

At December 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$284,291 and \$19,342, respectively. These accounts are used to reduce employer contributions. In 2024 and 2023, employer contributions were reduced by \$3,250,000 and \$2,294,000, respectively, from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Plan Expenses

The Plan incurred certain administrative fees, including brokerage fees, which are charged to the participant's account for which the fees were incurred. The Plan Sponsor paid certain other immaterial administrative expenses that otherwise would be paid by the Plan if not by the Plan Sponsor. The Plan has no liability to the Plan Sponsor for any such expenses paid on behalf of the Plan. Certain investment related expenses are presented as a reduction of investment income.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, if readily determinable, or at net asset value as a practical expedient to fair value if the fair value is not readily determinable. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investment securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents the net appreciation or depreciation in the fair market value of its investments, which includes realized gains and losses from sales of investments and unrealized gains and losses on investments held at year-end, in the accompanying statements of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

3. Financial Information Certified by the Custodian and Master Trust Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, investments, notes receivable from participants held at December 31, 2024 and 2023, investment income, interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, the information in Note 4 and Note 5, and the information included in the supplemental schedule as of December 31, 2024 were certified by the Custodian and Master Trust Trustee as being complete and accurate and were used in the preparation of the financial information included in the accompanying financial statements, notes to financial statements, and supplemental schedule.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used, or fair value inputs, that may require a transfer within the fair value hierarchy, for the years ended December 31, 2024 and 2023.

Corporate stocks held through the brokerage account: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective funds: Valued at the net asset value (NAV) of units of a collective trust as provided by the trust fund company. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

4. Fair Value Measurements, continued

The JPMorgan common collective funds seek high total return with a shift to current income and some capital appreciation over time as the fund approaches and passes the target retirement date. Generally, the asset allocation of each target date fund will change on an annual basis with the asset allocation becoming more conservative as the fund nears the target retirement date. There are no unfunded commitments, and participants may redeem the common collective funds on a daily basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments in Master Trust

A portion of the Plan's investments are held within the Texas Health Master Trust (Master Trust), which was established for the investment of assets of the Plan and several other Texas Health sponsored retirement plans as a capital preservation investment option. Each participating retirement plan has an undivided interest of the investments and other assets and liabilities of the Master Trust.

The value of the Plan's interest in the Master Trust is based on the beginning value of the Plan's interest in the trust, plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 96.0% and 95.5%, respectively. Total investment income (including net appreciation in the fair value of investments) of the Master Trust is allocated to the individual plans based upon the amount of time the Plan's assets were invested in the Master Trust.

The Master Trust holds a portfolio of investment contracts, which includes a guaranteed investment contract, a portfolio of separate account guaranteed investment contracts and synthetic guaranteed investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value within the Master Trust. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less withdrawals. The value of the Plan's investment represents its interest in the underlying assets and liabilities of the Master Trust.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

Separate account guaranteed investment contracts and synthetic guaranteed investment contracts are issued by insurance companies or other financial institutions, backed by a portfolio of bonds. The bond portfolio may be structured as a fixed income separate account or collective fund. The bond portfolio is either owned by the contract issuer and segregated in a separate account for the benefit of the Master Trust (separate account guaranteed investment contract) or owned directly by the Master Trust (synthetic guaranteed investment contract). The issuer guarantees that all qualified participant withdrawals will be at contract value and that the crediting rate applied will not be less than 0%. Crediting rates are typically reset quarterly to account for the difference between the contract value and the fair value of the underlying portfolio.

If the Master Trust defaults in its obligations under the contract (including the issuer's determination that the agreement constitutes a nonexempt prohibited transaction as defined under ERISA), and such default is not corrected within the time permitted by the contract, then the contract may be terminated by the issuer and the Master Trust will receive the fair value as of the date of termination. Each contract recognizes certain "events of default" which can invalidate the contracts' coverage. Among these are investments outside of the range of instruments which are permitted under the investment guidelines contained in the investment contract, fraudulent or other material misrepresentations made to the issuer, changes of control of the investment adviser not approved by the contract issuer, changes in certain key regulatory requirements, or failure of the Master Trust to be tax qualified.

The contracts also generally provide for withdrawals associated with certain events which are not in the ordinary course of Plan operations. These withdrawals are paid with a market value adjustment applied to the withdrawal as defined in the investment contract. Each contract issuer specifies the events which may trigger a market value adjustment; however, such events may include, but not be limited to, the following:

- material amendments to the Master Trust's structure or administration;
- complete or partial termination of the Master Trust, including a merger with another plan;
- the failure of the Master Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA;
- the redemption of all or a portion of the interests in the Plan at the direction of the plan sponsor, including withdrawals due to the removal of a specifically identifiable group of employees from coverage under the plan (such as a group layoff or early retirement incentive program), the closing or sale of a subsidiary, employing unit, or affiliate, the bankruptcy or insolvency of the plan sponsor, the merger of the plan with another plan, or the plan sponsor's establishment of another tax qualified defined contribution plan;
- any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the Master Trust;
- changes to competing investment options;
- the delivery of any communication to plan participants designed to influence a participant not to invest in the stable value option.

As of the date of this report, the occurrence of any such market value adjustment event is not probable.

6. Related-Party Transactions

Certain plan assets are invested in shares of mutual or common collective funds of the Custodian. These transactions, as well as notes receivable from participants, qualify as party-in-interest transactions, which are exempt from the "prohibited transactions" provisions of ERISA and the Code.

7. Plan Termination

While the Plan Sponsor has not expressed any intent to discontinue the Plan, the Plan may be terminated at any time by the resolution of the Plan Sponsor's board of trustees subject to the provisions of ERISA. Upon termination of the Plan, participants will become fully vested and receive the entire balance of their accounts.

8. Tax Status

The Internal Revenue Service (IRS) determined and informed the Plan Sponsor by a letter dated January 25, 2016 that the Plan was designed in accordance with applicable sections of the Code. The Plan Sponsor believes the Plan is currently being operated in compliance with the applicable requirements of the Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is not subject to IRS examinations for tax years 2021 and prior as the statute of limitations has expired.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term.

10. Subsequent Events

The Plan evaluated events subsequent to December 31, 2024 and through July 29, 2025, the date on which the financial statements were available to be issued.
