## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE A - DESCRIPTION OF PLAN

The following description of the Pilot Catastrophe Services, Inc. ("Company") 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company. For purposes of eligibility, there are no minimum service requirements for a participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to 100% of pretax or post-tax (Roth starting January 1, 2024) annual compensation, as defined in the Plan, up to annual IRS limits. Catch up contributions are allowed by the Plan up to federal limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a discretionary annual matching contribution of the employee's contributions up to a percentage of pay chosen by the employer. Matching contributions are based on deferral contributions made during the plan year for participants who are employed on the last day of the year. The employer contributions are paid on an annual basis during the current year for the prior year. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, administrative fees, and their Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant has investment authority over all funds in their account and are able to diversify their account among different funds with varying levels of risk.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Beginning January 1, 2001, a participant is 100% vested in the Company's contribution portion of their accounts plus actual earnings thereon after one year of credited service.

Payment of Benefits

On termination of service, a participant may elect to receive the vested interest in their account. The participant may choose among several payment options including the purchase of insurance contracts. Principal Financial Group distributes the participant's balance from the Plan and administers the payment as selected by the participant. Active participants may make withdrawals including hardship withdrawals of all or part of the participant's vested interest in their account as stated in the plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$744 and \$884, respectively. Forfeited non-vested accounts relate to employer contributions made for employee contributions that were refunded as corrective distributions. Forfeited accounts can be used to reduce future employer contributions or payments for administrative expenses. During 2024, \$795 in forfeitures were credited to employer contributions and \$0 were used to reduce administrative expenses. During 2023, \$43,321 in forfeitures were credited to employer contributions and \$5 were used to reduce administrative expenses.

Reclassification

For comparability, the 2023 figures may have been reclassified, where appropriate, to conform with the financial statement presentation used in 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees for member requested services related to distribution fees are charged directly to the Participant's account and are included in administrative fees. Effective February 1, 2017, trustee, record keeping, and investment related expenses are allocated directly to Plan participants and included in administrative fees. The revenue sharing arrangements are still in place with various funds and these costs are credited back to the participants and are reported as other income on the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

The Plan has evaluated events and transactions that occurred between December 31, 2024 and September 9, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE D - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE E - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)

All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee, Principal Financial Group. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

All of the net assets of the plan are participant directed within the Principal Financial Group selection of collective investment trusts, guaranteed interest contracts, or mutual funds.

The net appreciation in fair value of the investments, interest, dividends and other income for the year ended December 31, 2024, including a net appreciation of \$11,397,385 for investments measured by quoted prices in an active market.

NOTE F - FAIR VALUE MEASUREMENT

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level one inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level two inputs consist of observable inputs other than quoted prices for identical assets, and Level three inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level three inputs are used only when Level one or Level two inputs are not available.

Level One Fair Value Measurements

The fair value of mutual funds is based on the closing price reported on the active market on which the individual securities are traded. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair value of collective investment trusts (CIT) is the net asset value based on the contract value. The NAV for the CIT is not publicly quoted but is available to current investors when accessing their accounts. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date, providing a readily determinable fair value.

The following tables present the Plan's fair value hierarchy for the assets measured at fair value on a recurring basis at December 31, 2024 and 2023.

**NOTE G - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2019, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (Mass Mutual). Mass Mutual maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$14,426,334 and \$17,917,054, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Mass Mutual. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE H - RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of Principal Financial Group, the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions. Trustee fees paid during 2024 and 2023 amounted to \$308,964 and \$296,445, respectively. Administrative fees are charged directly to participant accounts.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE I - RISK, UNCERTAINTIES AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024, balances in the IShares S&P 500 Index Fund account for greater than 10% of the Plan's total invested assets. At December 31, 2023, balances in the IShares S&P 500 Index Fund and Mass Mutual Guaranteed Investment Contract account for greater than 10% of the Plan's total invested assets.

NOTE J - REFUNDS OF EXCESS CONTRIBUTIONS

Corrective distributions of \$542,614 and \$562,395 for the Plan years ended December 31, 2024 and 2023 included payments of \$542,614 and \$562,395 made to certain active participants during 2025 and 2024, respectively to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. The Plan distributed these excess contributions to the applicable participants prior to March 15 of each year. These amounts are also included in the Plan's Statements of Net Assets Available for Benefits as excess contributions payable at December 31, 2024 and 2023.
