Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DeLaval Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of the DeLaval Inc. Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of DeLaval Inc. (the Company) generally not subject to a collective bargaining agreement, with the exception of West Agro Inc., and Warehouse, Mail Order, Office, Technical and Professional Employee Union Local No. 743, who have 3 months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute a percentage of their annual compensation, as defined in the Plan, not to exceed certain Internal Revenue Service (IRS) limitations. Salary deferral contributions can be made as either pre-tax or Roth (after-tax) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company contribution consists of a discretionary matching contribution and a nonelective contribution. For the years ended December 31, 2024 and 2023, the Company made a discretionary matching contribution. The Company matched up to 50% of the first 6% deferred by the participant. For the years ended December 31, 2024 and 2023, the Company also made a nonelective contribution. The Company's nonelective contribution is an amount equal to 3% of compensation for each participant who has completed less than ten years of service. The nonelective contribution is increased to 4% of compensation for participants who have completed ten or more years of service.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions and nonelective contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

DELAVAL INC. RETIREMENT SAVINGS PLAN

Notes To Financial Statements (*Continued*)

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in a participant directed brokerage account or various investment options maintained by Fidelity Management Trust Company. Participants may change their investment options at any time.

Vesting

Participants are fully vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, 40% after three, 70% after four and 100% after five years. Participants who are 65 years of age or older are automatically 100% vested.

Forfeitures

Forfeitures of nonvested benefits are used to pay administrative expenses related to the operation of the Plan. Remaining forfeitures, if any, are used to reduce any Company contributions. Forfeitures which were utilized to pay Plan expenses for the Plan year ended December 31, 2024 and 2023 were \$39,433 and \$105,934, respectively. Forfeitures which were utilized to reduce Company contributions for the Plan year ended December 31, 2024 were \$552,495. There were no forfeitures utilized to reduce Company contributions for the Plan year ended December 31, 2023. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$152,602 and \$563,432, respectively.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loans are for a period not exceeding five years unless used to acquire a personal residence and bear interest at a reasonable fixed rate of interest based on prevailing market rates. Participants can have one loan outstanding at a time. Loans are secured by participants' vested account balances. At December 31, 2024, outstanding loans bear interest at rates ranging from 5.25% to 10.50%. Principal and interest are repaid through payroll withholdings, with maturity dates through February 2032.

Notes To Financial Statements (*Continued*)

Payment Of Benefits

The Plan provides for retirement at age 65. On termination of service or other distributable event with a vested account balance of \$1,000 or more, a participant may elect to receive a single cash distribution, a direct rollover distribution to an Individual Retirement Account (IRA) or new employer's eligible plan or 403(a) annuity, or a combination of a cash distribution and rollover. If the vested account balance is less than \$1,000, a participant receives a lump sum, unless the participant chooses a different payment option.

Hardship Withdrawals

A participant may make withdrawals from his or her participant deferral contributions account in the event of undue financial hardship, which includes payments for education expenses, medical or burial expenses, the purchase of a primary residence or delinquent mortgage payments, and for the repair of damage to the participant's principal residence as defined by the Plan Agreement.

Administrative Expenses

Costs of administering the Plan are generally paid by the Company. Other fees are paid by the Plan participants. In situations where recordkeeping revenue received in connection with plan services exceeds agreed-upon compensation, the Plan Administrator deposits amounts equal to such excess revenue in a suspense account in the Plan. These amounts are used to pay administrative expenses. At December 31, 2024 and 2023, the available revenues to offset expenses were \$60,470 and \$139,525, respectively.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are comprised of mutual funds.

Common/Collective Trust

Valued at the unit value or NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The common/collective trust held by the Plan is not required to be reported in the fair value hierarchy. The common/collective trust held by the Plan files an annual report on Form 5500 as a direct filing entity. The common/collective trust has no unfunded capital commitments, and this investment may be redeemed daily.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

5. Party In Interest Transactions

The Plan investments include mutual funds managed by an affiliate of the Trustee and, therefore, qualify as party in interest transactions allowable under ERISA. Fees incurred by the Plan for the investment management services are included in the net appreciation fair value of investments, as they are paid through revenue sharing.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions and are allowable under ERISA.

6. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Fidelity Management & Research Company (FMRC). FMRC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
