Report on the Audit of the Financial Statements

Opinion

We have performed an audit of the accompanying financial statements of Cement Masons and Plasterers 401K Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Cement Masons and Plasterers 401K Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

NOTE 1 DESCRIPTION OF PLAN

The following description of the Cement Masons and Plasterers 401K Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, which was formed on November 3, 2022, is a defined contribution multi employer plan covering eligible employees of employers under the collective bargaining agreement of Cement Masons & Plasterers Local 528 and its contractors. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan, determines appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility

Employees who are employed under a collective bargaining agreement between their employer and Cement Masons & Plasterers Local 528 are eligible to participate in the Plan.

Contributions

Each Employer must contribute monthly to the Plan for each of its participating employees. These contributions are determined by the Collective Bargaining Agreement between employers and Cement Masons and Plasterers Local 528 or a Special Agreement.

Participants may elect to make elective pre-tax contributions starting from the first payroll period in covered employment beginning on and after January 1, 2023, in increments of \$1 per hour, up to a maximum of \$8 per hour of their compensation. Participants who have attained age 50 or older are able to defer up to an additional \$2 per hour of compensation. Elective pre-tax contributions for a Plan year must not exceed the limit stated in the Internal Revenue Code (IRC) Section 402(g)(1)(b).

Limitations apply to any participant who has been part of other defined contribution plans maintained by an Employer. The total benefits payable under all such plans are considered as if they were payable under one plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer contribution based on hours worked, and an allocation of Plan earnings (or losses) and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants have an immediate and nonforfeitable right to their contributions and any associated earnings. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Benefit Payments

Payments from the Plan are made in the event of a participant's retirement, death, disability, or termination. Payments begin within a reasonable period following the receipt of the participant's or beneficiary's written application requesting benefits or the benefit commencement date requested. The participant may elect to receive an amount equal to the value of the participant's account in the form of a lump sum amount or periodic payments. The Plan allows for hardship distributions subject to Plan provisions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Employer Contributions Receivable

Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions are due from Employers as specified in the collective bargaining or participation agreement. In general, contributions are due on the 15th day of each month following the work month. Delinquent contributions and payroll audit findings are individually analyzed for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was insignificant.

Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

NOTE 3 FAIR VALUE OF INVESTMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Money Market Fund and Mutual Funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust – valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are held by Broadridge Matrix Trust Company. Broadridge Matrix Trust Company is the custodian as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 7 PLAN TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the IRC and, accordingly, the Plan's net investment income is exempt from income taxes. The Plan obtained a favorable determination letter from the IRS dated May 5, 2025, and the Plan Sponsor believes that the Plan, as amended, continues to qualify and operate as designed.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress.

NOTE 8 CONCENTRATION OF RISK

The Plan's assets consist primarily of financial instruments including cash equivalents. The financial instruments may subject the Plan to concentrations of risk as, from time to time, cash balances exceed amounts insured by the Federal Deposit Insurance Corporation, market value of securities are dependent on the ability of the issuer to honor its contractual commitments, and the investments are subject to changes in market values.

NOTE 9 LATE PARTICIPANT CONTRIBUTIONS

During the 2023 Plan year, certain participating Employers were late in remitting participant contributions to the Plan. According to Prohibited Transaction Exemption (PTE) 76-1, neither the failure of a participating Employer to make a contribution to the Plan when the contribution is due nor the failure of the Plan to collect such a delinquent contribution constitutes a prohibited transaction under Code Section 4975 if the Plan is making a systematic, reasonable, and diligent effort to collect delinquent contributions. The Plan has written procedures for the collection of delinquent contributions and assesses liquidating damages and interest in accordance with PTE 76-1. As such, the late participant contributions are not reported as a prohibited transaction. The total amount of known late participant contributions was \$-0- and \$21,513 for the years ended December 31 2024 and 2023, respectively.
