INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Resources Global Professionals 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Resources Global Professionals 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Resources Global Professionals 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan was established effective April 1, 1999 and is a contributory plan covering all eligible employees of Resources Connection, LLC d/b/a Resources Global Professionals and certain subsidiaries (collectively the "Employer") under Sections 401(a), 501(a), and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

Employees of certain companies acquired by the Employer are eligible to participate in the Plan upon employment. All other employees are eligible to participate upon the completion of three months of service. Leased employees are not eligible to participate in the Plan.

3. Contributions

Participants may elect to make pre-tax and/or after-tax Roth contributions from 1% to 75% of their compensation up to the maximum deferral limit per Section 402(g)(1) of the IRC. Additionally, the Plan provides an automatic contribution arrangement for internal employees, as defined, who meet the eligibility requirements; such eligible participants are automatically enrolled in the Plan at a deferral rate of 6%, unless the participant affirmatively elects a greater or lesser percentage (including zero). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to transfer amounts from their non-Roth account to their Roth account in accordance with Section 402A(c)(4) of the IRC.

The Employer may make a discretionary matching contribution to the Plan. During the year ended December 31, 2024, the Employer made matching contributions equal to 50% of the participant's deferred compensation up to 6% of compensation. Catch-up contributions are not subject to matching contributions. In addition, the Employer may make discretionary nonelective contributions to the Plan for participants employed on the last day of the year. There were no nonelective contributions made to the Plan during the year ended December 31, 2024.

4. Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer discretionary matching contribution, and allocations of the Employer discretionary nonelective contribution (if any), and plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Investment Options

Participants may elect to invest their accounts in any of the investment options offered by Fidelity Management Trust Company ("Fidelity"), as approved by the Employer. Participants may change their investment options daily. Participants not making an affirmative election will be automatically enrolled into the Plan's default Lifecycle Funds.

6. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000 (reduced by the highest outstanding loan balance during the previous twelve months). Loans are secured by the balance of the participant's account and are charged a reasonable rate of interest as determined by the plan administrator and is based on prevailing rates charged by other lending companies. Loans must be repaid within five years of the date of issuance or over a longer period (not to exceed 15 years) if the loan is for the purchase of a primary residence. Participants may not have more than two loans outstanding at any time, provided one loan is a general-purpose loan and one loan is a residential loan.

7. Benefit Payments

Upon termination of employment, a participant is entitled to receive his or her vested account balance in a lump sum or in partial payments. When a participant attains normal retirement age, incurs a disability, or dies while employed, the participant or the participant's beneficiary is entitled to 100% of the participant's account balance. Additionally, participants may receive distributions upon attaining age 59 ½ or for financial hardship if certain criteria are met. Account balances more than \$1,000 but less than \$7,000 will be automatically rolled over to an Individual Retirement Account.

8. Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to pay reasonable Plan expenses or to reduce future Employer contributions at the Employer's discretion. During the year ended December 31, 2024, forfeitures totaling \$762,710 were applied toward Employer contributions. Outstanding forfeitures available were \$88,423 and \$517,058 and are included in net assets available for benefits as of December 31, 2024 and 2023, respectively.

9. Vesting

Participant contributions and Employer nonelective contributions and actual earnings thereon are fully vested at all times. Employees of certain companies acquired by the Employer are 100% vested in all contributions. Vesting of the Employer matching contribution portion of accounts of all other participants is based upon the participant's years of service with the Employer as follows:

10. **Plan Termination**

Although it has not expressed such intent, the Employer reserves the right, at any time, to terminate the Plan by action of the Resources Global Professionals Retirement Plan Committee (“Retirement Plan Committee”), subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested and contributions to the Plan would cease. The assets of the Plan would be distributed to the participants based on each individual participant’s interest in the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. **Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. **Plan Administration**

The Employer is the plan sponsor and the Retirement Plan Committee is the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

3. **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

4. **Investment Valuation and Income Recognition**

The investments of the Plan are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the investment adviser and trustee. See Note D for discussion of fair value measurements.

4. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Payment of Benefits

Benefits are recorded when paid.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other participant specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation/depreciation of fair value of investments.

Certain funds generate revenue sharing credits to offset general administrative fees or allocated back to participants as a participant revenue credit. For the year ended December 31, 2024, administrative expenses totaled \$348,942 and revenue credits totaled \$133,950, which are netted in administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan) and New York Life Insurance Company (a custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Valued at cost plus interest.

Mutual funds: Valued at daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

Collective trust funds: Valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment in a group annuity contract with New York Life Insurance Company (“New York Life”) that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The following represents the traditional investment contract held by the Plan.

The traditional investment contract held by the Plan guarantees principal and accumulated interest. New York Life is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan and may not be less than zero. The contract value of the account represents the sum of contributions, interest, and dividends less participant withdrawal amounts and administrative expenses. The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include total or partial plan termination, or merger, bankruptcy of the plan sponsor or other plan sponsor events (for example, sale of the company, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. If termination of the contract occurs at the election of the Plan, payment is subject to a market value adjustment, unless a twelve-month advance notice is provided to New York Life. If termination of the contract occurs at the election of New York Life, payment is not subject to a market value adjustment.

No direct transfers to competing funds are allowed. Any transfers out of the contract must first go through a non-competing investment option and reside there for at least 90 days before transferring to a competing option. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the trustee and record-keeper of the Plan. New York Life is a custodian of the Plan. Plan investments, except for the New York Life Anchor Account, are managed and held by Fidelity. These transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

NOTE G - TAX STATUS

The Employer adopted a Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan") received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has been amended since receiving the latest opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature are handled by the administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE J - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended such that employees hired by Veracity Consulting Group, LLC (Veracity) (an acquired Company) on or after January 1, 2025 will be subject to the vesting schedule noted in Note A.9. and the three months of service requirement to be eligible to participate in the Plan. Veracity employees hired prior to January 1, 2025 continue to be 100% vested in their Employer matching contributions and were immediately eligible to participate in the Plan.

In addition, effective August 1, 2025, the Plan was amended to allow for any remaining forfeitures to be allocated to participants after being used to reduce Employer contributions and after paying Plan administrative expenses.

Plan management has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.
