NOTES TO FINANCIAL STATEMENTS

GNCO, Inc. 401(k) Retirement Plan

1 Description of Plan

The following description of the GNCO, Inc. 401(k) Retirement Plan, formerly known as the Towlift, Inc. Employees' Retirement and Savings Plan and Trust (referred to as the "Plan"), provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all eligible employees of GNCO, Inc. ("Company") and its subsidiaries including Towlift, Inc., Fleet Team, Inc., Eagle Mark 4 Equipment Company, and Eastbay Clarklift who have completed 90 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective April 1, 2024, the Plan allowed employees from Forklift Training Systems to participate in the Plan.

Effective January 1, 2023, the Plan was amended to allow employees from Intermountain Lift Truck of Salt Lake City, UT to participate in the Plan.

Effective April 1, 2023, the Plan was amended to allow employees from DMHS of Southern California and Faulkner Handling Solutions to participate in the Plan.

Contributions:

Salary Reduction Contributions - Elective deferral contributions must be a whole percentage of compensation and cannot be more than 100% of compensation; also, an automatic election of 5% for employee elective deferral contributions is initiated for newly eligible employees and active participants. Also, there is an auto escalation feature which raises 1% up to 10% maximum on January 1st of each year.

Employer Matching Contributions - The employer match for non-union employees is 25% of the first 6% of salary reduction contributions. For December 31, total matching contributions for non-union employees were \$653,386 (2024) and \$554,505 (2023). The employer match for union employees is contributed as specified by the union agreement. For December 31, total matching contributions were \$76,571 (2024) and \$81,992 (2023).

Profit Sharing Contributions - These contributions are at the discretion of the Board of Directors and are allocated to eligible participants who were employed by the Company as of the last day of the Plan year (December 31) and have W-2 earnings for that year. For December 31, total profit sharing contributions were \$0 (2024) and \$0 (2023).

GNCO, Inc. 401(k) Retirement Plan

1 Description of Plan, Continued

Contributions, Continued:

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer profit sharing contributions and earnings and losses thereon.

Vesting:

All participants are 100% vested in salary reduction. Participants are vested 20% per year for each year of vesting service credited to the employer profit sharing contributions. A "year of vesting service" means 12 consecutive months of service with the employer.

Effective April 1, 2023, the Plan was amended for employer matching contributions. Participants are vested 20% per year for each year of vesting service credited to the participant for employer matching contributions.

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested may be used to reduce future employer contributions or allocated to participant accounts, at the discretion of the employer. For the years ended December 31, the forfeiture account balance was \$1,548 (2024) and \$5,545 (2023).

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 reduced by any outstanding loan balance on the date the new loan is made, or 50% of their account balance. No more than two loans, before March 1, 2018, and one thereafter, shall be approved for any participant in a 12-month period. Loans are repaid through payroll deductions over a maximum term of five years. All loans will bear a reasonable rate of interest similar to what a bank or other professional lender would charge for making a loan in a similar circumstance. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Other Plan Provisions:

The Plan provides for early payment of benefits after reaching age 59-1/2.

Payment of Benefits:

Upon termination of service by reason of retirement, death or total and permanent disability, a participant may receive a lump sum amount equal to the value of his or her account.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities (mutual funds and pooled separate accounts) are reported at fair market value as of the balance sheet date. Fair market values of the mutual funds represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. Fair market values of the pooled separate accounts are based on the net fair value of the underlying assets. The fair value of the collective investment funds are based on the contract value of the fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Substantially all administrative fees are paid by the Plan.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2 Summary of Significant Accounting Policies Continued

Risks and Uncertainties:

The Plan's investments include investments in mutual funds, collective investment funds, and pooled separate accounts holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

5 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices. These fall into the Level 1 category of the valuation hierarchy.

Common Collective Trusts:

The fair value of the common collective trusts is based on the contract value of the fund (contract value approximates fair value). The fair value is expressed in units. The common collective trusts are valued based on NAV as the practical expedient, as they can be redeemed at their net asset value on their measurement date. The common collective trusts can be redeemed on a daily basis, and there are no unfunded commitments.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts:

The fair value of the pooled separate accounts is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. These fall into the Level 1 and Level 2 category of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value on a recurring basis as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.
