Independent Auditors' Report

To the Participants and Administrator of
Ocean House Management, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ocean House Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 – Plan description

The following brief description of the Ocean House Management, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information is provided within the Plan documents.

General

The Plan was established by Ocean House Management, LLC (the “Company”) effective January 1, 2011 for the benefit of its employees. The Weekapaug Inn and Restaurant, LLC (“Participating Employer”) which is an affiliated company began participating in the Plan effective March 31, 2012. The Participating Employer was acquired by the Company in 2025. The Plan is a defined contribution plan and is subject to the provisions of the Internal Revenue Code (“IRC”) and the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Ascensus Trust is the trustee of the Plan's assets.

Eligibility

The Plan covers all Company employees except for interns, as well as the employees of the Participating Employer who have completed six months of service, provided they have reached 21 years of age. As of December 31, 2024, the Plan was classified as a multiple-employer arrangement, as the Company and the Participating Employer were not under common control (collectively they are referred to as the “Sponsors”).

Contributions

Each year, subject to an overall maximum annual pre-tax contribution pursuant to Internal Revenue Service (“IRS”) regulations, participants may contribute a percentage of their compensation. Participants who are 50 and older may also be eligible for catch-up contributions. Rollover contributions from other qualified retirement plans are permitted.

The Sponsors contribute a safe harbor matching contribution equal to 100 percent of the first six percent of the participant’s salary deferral.

At its discretion, the Sponsors may make additional profit sharing contributions on behalf of eligible employees to the Plan for a plan year. To be eligible for a discretionary profit sharing contribution, an employee must be employed on the last day of the plan year and must have completed at least 1,000 hours of service during the plan year. There were no profit sharing contributions for 2024.

Participant accounts

Each participant’s account is credited with the participant’s contributions, the Sponsors matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Distribution of benefits

Upon termination of employment for any reason, including retirement, a participant's vested account is generally distributed either in a single lump-sum payment or in installments over a period of time. Participants who are still employed may withdraw their vested accounts upon attaining age 59-1/2. If the termination is before the normal or early retirement dates and is for a reason other than death or disability and the vested balance is \$1,000 or less, the entire balance will be distributed. For retired participants, the latest commencement date for distributions is April 1 of the calendar year following the year in which the participant attains age 73. A participant may request withdrawal from their account in the case of hardship as defined in the Plan document.

Vesting

Participants are immediately vested in their voluntary contributions and the Sponsors safe harbor matching contributions plus actual earnings thereon. Vesting in the Sponsors' discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service in their discretionary contributions.

A year of vesting service is a Plan year in which the participant has been credited with at least 1,000 hours of service.

Notes receivable from participants

Participants of the Plan may elect to borrow from their vested account balances a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is lower. Maximum loan amounts must be reduced by the participant's highest outstanding loan balance in the 12-month period before the date their loan is granted. The notes are secured by the balance in the participant's account and, as of December 31, 2024, bore an interest rate of 3.25% to 8.50%. Uncollectible notes receivable are charged to the participant's account. All notes must be repaid within five years, except for notes used to acquire a principal residence, which must be repaid within ten years. The interest rate charged on notes receivable from participants is equal to the prime rate plus 1% on the date the note is made.

Forfeited accounts

Non-vested forfeited participant accounts may be used to reduce any employer contribution or to pay eligible administrative expenses of the Plan.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan prepares its financial statements and supplemental schedule on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions and expenses are not recognized until received or paid, respectively.

Notes to Financial Statements

Accounting estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Administrative expenses

Certain costs of plan administration are absorbed by the Sponsors. Recordkeeping fees paid by participants are included in administrative expenses. Certain other investment related expenses are included in net appreciation or depreciation in fair value of investments.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the valuation policies utilizing information provided by the investment advisors and custodians. See the discussion under Fair Value Measurements for a description of valuation methodologies used for assets measured at fair value.

Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on sales of investments is based on average cost. The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statement of Changes in Net Assets Available for Benefits which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Interest income is recorded, as earned, on an accrual basis. Dividend income is recorded on the ex-dividend date.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan documents.

Payment of benefits

Benefits are recorded when paid.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Note 4 – Fair value of investments

The fair value measurements topic of the FASB Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the Net Asset Value (“NAV”) of shares held by the Plan at year end.

Cash equivalent represents an investment in a money market fund and is valued at the Net Asset Value (“NAV”) of shares held by the Plan at year end.

All of the Plan's investments for 2024 and 2023 are classified as Level 1, within the fair value hierarchy, at December 31.

Note 5 – Plan termination

The Plan was established with the expectation that it will continue indefinitely. The Plan may be terminated if the Sponsors decide to do so; however, the Sponsors have not expressed an intent to terminate the Plan. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 6 – Income tax status

The Plan has not obtained a private letter ruling or determination letter from the Internal Revenue Service stating that the plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). However, the Plan operates under a prototype plan sponsored by The Angell Pension Group, Inc. The prototype plan sponsor has obtained an opinion letter dated March 31, 2008, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examinations by Federal or State tax authorities. The plan administrator has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Related party transactions

Affiliates of the trustees manage investments and provide recordkeeping services to the Plan. These investments and the administrative fees associated with the recordkeeping services qualify as party-in-interests transactions. Notes receivable from participants are also considered party-in-interest transactions.

Note 8 – Risks and uncertainties

The Plan provides for various investment options which invest in stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, changes in the values of investment securities can occur in the near term and those changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 9 – Subsequent events

The Plan has evaluated subsequent events and transactions through September 19, 2025 the date the financial statements were available to be issued.

On May 9, 2025, Ocean House Management, LLC acquired the Weekapaug Inn and Restaurant, LLC, a participating employer in the Plan. Prior to the acquisition, the Plan was classified as a multi-employer arrangement, as the Company and the Participating Employer were not under common control. Management is evaluating the impact of this transaction on the Plan’s classification under ERISA and applicable accounting standards.
