### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Ryobi Die Casting (USA), Inc. Retirement and Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ryobi Die Casting (USA), Inc. Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## **Note 1. Description of the Plan**

The following description of Ryobi Die Casting (USA), Inc. Retirement and Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

### **General**

The Plan is a defined-contribution plan sponsored by Ryobi Die Casting (USA), Inc. (Company) for the benefit of its employees who are age 18 or older. Employees are eligible after one month of service. Collective bargaining employees and nonresident aliens are excluded from participation in the Plan. Employees must have one year of service in order to be eligible for Company non-elective contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) serves as trustee and recordkeeper of the Plan.

### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 95% of eligible compensation. Employee catch-up and rollover contributions are also permitted. Roth contributions are also permitted. The Company makes safe harbor matching contributions of 100% of employees' salary deferral amounts on the first 5% of employees' eligible compensation. The Plan allows for non-elective Company contributions, which are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

The Plan includes a qualified automatic contribution arrangement (QACA). The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant made an affirmative election otherwise. Annual automatic increase of 1% increase of the participant's deferral percentage up to 10% will occur each November 1st. Japanese national employees are not automatically enrolled.

### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately 100% vested in their voluntary contributions plus earnings thereon. For participants hired before January 1, 2022, the safe harbor Company matching contributions are immediately 100% vested. For those hired after January 1, 2022, the QACA safe harbor matching contributions received are 100% vested after two years of continuous service. Vesting in the Company's non-elective contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service in these contributions. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Company contributions.

***Payment of Benefits***

Upon termination of service, an employee may elect to receive a lump-sum amount equal to the value of his account. If his value is over a certain level, the participant may defer payment of benefits until a later date. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. Effective January 1, 2023, an employee may elect to receive installment payments as a withdrawal option.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$63,305 and \$4,600, respectively. These accounts will be used to reduce future employer contributions or pay the Plan's administrative expenses. Forfeitures of approximately \$1,842 and \$1,846 were used to pay expenses during 2024 and 2023, respectively. Forfeitures of approximately \$165,000 and \$180,000 were used to offset employer contributions in 2024 and 2023, respectively.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. Only one loan may be outstanding at any time.

All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Quoted market prices, if available, are used to value investments. Mutual funds and money market funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's interest in the common collective trust funds is valued based on information reported by the investment advisor using the audited financial statements of the collective trusts at year end, which approximates NAV. Self-directed investments are common stocks, mutual funds and a money market fund. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

The objective of the Fidelity Managed Income Portfolio (common collective trust) is to seek the preservation of capital, as well as to provide a competitive level of income over time consistent with the preservation of capital. Redemptions may be made daily and no restrictions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust custodial document sponsored by FMR, LLC. This prototype plan document has been filed with the appropriate agency. The Plan had not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the prototype document had a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. The Plan holds no Level 2 securities. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan holds no Level 3 securities.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. The Plan paid \$118,383 and \$107,097 of recordkeeping and advisory fees to Fidelity during 2024 and 2023, respectively. Investment advisory fees paid to ProCourse Fiduciary Advisors totaled \$32,000 during 2024 and 2023. The Company provides certain administrative services at no cost to the Plan.

Revenue account credits received during the years ended December 31, 2024 and 2023 totaled approximately \$16,000 and \$13,000, respectively, and these amounts were reallocated to the participant accounts.

**Note 8. Subsequent Events**

Effective May 1, 2025, automatic increase of the participant's deferral percentage will be 1% annually up to 15%, occurring each November 1st.

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.
