### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit on the 2024 Financial Statements

We have performed an audit of the financial statements of RiceTec, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### 1. DESCRIPTION OF THE PLAN

RiceTec, Inc. Retirement Savings Plan (“Plan”) is a qualified retirement plan adopted by RiceTec, Inc. (“Company”). The Plan was originally effective on March 1, 1991 to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was amended and restated effective on July 14, 2021 to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan’s provisions.

#### **Eligibility**

Full time employees are eligible to participate in the Plan on their date of hire. Part-time employees who complete at least 1,000 hours of service during an eligibility computation period will also enter the Plan on the next regular entry date. Entry dates are the first day of the month coinciding with or next following the date an employee satisfies the eligibility requirements.

#### **Contributions**

Participants may elect to reduce their compensation by a specific percentage or dollar amount and have the amount contributed to the Plan as an elective deferral not to exceed a dollar limit which is set by law. There are two types of elective deferrals: pre-tax deferrals and Roth deferrals. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may make additional catch-up contributions. The Plan includes an automatic deferral feature. Accordingly, the Company will automatically withhold 3% of a participant’s compensation each payroll period and contribute that amount to the Plan unless the participant makes a contrary election. The automatic deferral will increase by 1% each year until the amount withheld reaches 6% of a participant’s compensation. Participants may enter into a salary reduction agreement at any time to select an alternative deferral amount or to elect not to defer under the Plan. Participants are also permitted to deposit into the Plan distributions they have received from other plans and certain IRAs as rollover contributions.

The Plan is referred to as a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company will make a safe harbor matching contribution equal to 100% of a participant’s elective deferral that does not exceed 5% of their compensation.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are always 100% vested in all of their Plan accounts.

#### **Investment Options**

Participants direct the investment of their entire interest in the Plan into various investment securities offered by the Plan. The Plan currently offers mutual funds and a common/collective trust as investment options for participants. Participants may exchange or transfer money between investment securities at any time.

**Notes Receivable from Participants**

Only active participants may request a loan. The minimum loan amount that a participant may request is \$1,000 up to a maximum loan amount of \$50,000 reduced by the highest loan balance during the past 12 months, or 50% of their vested account balance, whichever is less. The loans are adequately secured and bear a reasonable rate of interest that is 1% over the prime rate published in the Wall Street Journal. Principal and interest payments are paid ratably through payroll deductions.

**Payment of Benefits**

Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan when they terminate employment with the Company. If the vested account balance exceeds \$5,000, a participant's consent is required. If the vested account balance does not exceed \$5,000, the Plan will distribute their account without their consent. If the amount of the distribution exceeds \$1,000 and the participant does not elect to either receive or roll over the distribution, the distribution will be directly rolled over to an IRA.

Participants may be entitled to receive an in-service distribution. Generally, a participant may receive a distribution from certain accounts prior to termination of employment if the participant has attained age 59½ or has incurred a financial hardship.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Other income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

**Benefits Paid to Participants**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by both Empower Annuity Insurance Company of America ("EAICA") and Empower Trust Company, LLC ("Empower Retirement"), qualified institutions.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Valued at NAV of units held. The NAV, as reported by EAICA, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the common/collective trust less its liability. This practical expedient is not used when it is determined to be probable that the common/collective trust will sell the investment for an amount different than the reported NAV.

**5. RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments may be managed by EAICA. Empower Retirement is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Notes receivable from participants also qualify as party in interest transactions.

Empower Retirement provides certain administrative services to the Plan and receives revenue from mutual fund service providers for services Empower Retirement provides to the funds. This revenue is used to offset certain amounts owed to Empower Retirement for administrative services to the Plan.

If the revenue received by Empower Retirement from such mutual fund service providers exceeds the amount owed, Empower Retirement remits the excess to the Plan. The excess amounts are held in a plan expense account. The Plan may make a payment to Empower Retirement for administrative expenses. At December 31, 2024 and 2023, the plan expense account totaled \$38,868 and \$63,864 respectively. Also, in 2024, administrative expenses were reduced by \$26,103 from the plan expense account.

**6. PLAN TERMINATION**

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan designed by Empower Retirement. Empower Retirement obtained its latest opinion letter on November 14, 2022 in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
