We have performed audits of the accompanying financial statements of Pantropic Power, Inc. Savings & Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1—Description of the Plan

The following description of the Pantropic Power, Inc. Savings & Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is subject to the provisions of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was established by Pantropic Power Inc. (the “Company” or “Employer”) as a profit sharing and 401(k) plan on January 1, 1987. The Plan was amended and restated in June 2024 to amend the treatment of participant loans upon the termination of employment of the borrowing participant.

*Administration of Plan Assets* – The Plan is administered by the Company. The Plan’s assets are maintained and administered by Equitable Financial Life Insurance Company (the “qualified institution”). The Plan’s recordkeeping services, and maintenance of participant account records are managed by the qualified institution. The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offering and monitors investment performance.

*Eligibility* – Full-time employees of the Company who have completed one year of service and are not excluded by certain provisions of the Plan document are eligible to participate in the Plan. The Plan provides for entry dates on January 1<sup>st</sup> and July 1<sup>st</sup>, following the satisfaction of the eligibility requirements.

*Related Employers* – Two entities that are affiliated with the Company have profit sharing plans for the benefit of their employees. Eligibility for participation and vesting for each of the plans includes service with the Company, and/or the two affiliates. If a participant terminates his or her employment with the Company, or either of the two affiliates, and is immediately employed by another affiliate, his or her account balance will be transferred to the related plan upon employment. During the year ended December 31, 2024, there were no transfers to this Plan from any of the affiliates of the Plan.

*Contributions* – Under Internal Revenue Code (“IRC”) Section 401(k), participants may contribute up to 100% of their compensation, subject to 2024 annual limits of \$23,000, and an additional \$7,500 for catch-up contribution for participants that are age 50 or older. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Employer and participant contributions are invested at the direction of the participant in various pooled separate accounts or a guaranteed interest option account. The Employer can make a discretionary matching contribution based on the employee elective contributions and compensation. During 2024, the Employer elected to match 100% of the first 1% of employee eligible compensation and 50% of the next 2% of employee eligible compensation. During 2024, matching contributions were approximately \$170,000. Additionally, the Employer may, at its discretion, make profit sharing contributions. During the year ended December 31, 2024, the Company made profit sharing contributions of approximately \$120,000.

*Participant Accounts* – Each participant account is credited with the participant’s contributions and allocations of (a) the Company’s contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Plan earnings or losses are allocated based on the participant’s elected investments. Allocations are based on either participant compensation or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Forfeitures* – Forfeitures are used to pay administrative expenses or to allocate among participants based on their respective compensation. The Plan had approximately \$5,000 and \$3,000 of forfeitures available at December 31, 2024 and 2023, respectively. Forfeitures of approximately \$3,000 were allocated among participants, as additional Employer contributions, during the year ended December 31, 2024.

**Note 1—Description of the Plan (continued)**

*Vesting* – If a participant leaves the Company for reasons other than normal retirement, total permanent disability, or death, the participant will be eligible to receive the vested percentage of the balance credited to the participant’s account. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting Percent</u>
1 year	5%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Participants are fully vested when they become disabled or deceased while still employed by the Company.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one loan outstanding at any time. The notes are secured by the balance in the participant’s account, and bear interest at prime rates plus 1%. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest are paid ratably through payroll deductions.

*Investment Options* – The Plan’s assets are held and managed by the qualified institution. The participants direct the investment of their account balance and may select from various investment options maintained by the qualified institution. Participants may change their investment option selections on any business day as defined by the Plan.

*Payment of Benefits* – Upon separation of service due to termination, death, disability, or when the participant attains normal retirement age, a participant or beneficiary may elect to receive a cash distribution equal to their vested account balance, as defined, as a 1) lump-sum payment, 2) monthly annuity payments, or 3) a combination of both.

*Plan Termination* – Although, it has not expressed any intent to do so, the Company reserves the right at any time to amend, modify, or terminate the Plan without the consent of any participant or beneficiary subject to the provisions of ERISA. In the event of such termination, the Plan provides that the participants shall become 100% vested in their accounts.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value of investments. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value. A fair value hierarchy exists which requires an entity to maximize the use of observable inputs when measuring fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

*Benefits Paid to Participants* – Benefits are recorded when processed and paid by the Plan.

*Administrative Expenses* – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

*Fair Value Measurements* – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

Three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. These investments measured using NAV practical expedient are exempt from classification under the fair value hierarchy.

**Note 2—Summary of significant accounting policies (continued)**

*Guaranteed Investment Option* – The value at any time will equal contributions and transfers to that option, plus interest, minus withdrawals and transfers out of the option and charges deducted as specified on the contract. The guaranteed interest accounts are not considered fully benefit-responsive and are valued at estimated fair value as determined by the Custodian of the Plan. The guaranteed interest option is classified within Level 2 of the valuation hierarchy because its value can be estimated using comparable market data.

The methods described above produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, other income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. Pooled separate accounts are measured at fair value using NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. As of December 31, 2024 and 2023, pooled separate accounts had no unfunded commitments, and redemptions are processed daily with a no notice period.

**Note 5—Party-in-interest transactions**

Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investment funds managed by the qualified institution; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid during the year for accounting and other services rendered by parties-in-interest totaling approximately \$38,000 for the year ended December 31, 2024, were based on customary and reasonable rates for such services. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. While these transactions qualify as party-in-interest activity, they are expressly exempted from the prohibited transaction rules (ERISA, Title I, Section 408(b)).

**Note 6—Income tax status**

The underlying non-standardized profit sharing plan has received a determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the written form of the underlying document is qualified under Section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The underlying non-standardized profit sharing plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8—Subsequent events**

*Plan Amendments* – Effective January 1, 2025, the Plan has been amended to include an automatic enrollment provision for eligible employees, with an automatic deferral contribution amount of 3% of eligible compensation. The Plan has also been amended to allow for after-tax Roth contributions effective January 1, 2025 for all eligible participants.

The Plan's management has evaluated events through August 27, 2025, the date the financial statements were available to be issued. No events, aside from those disclosed above have occurred subsequent to the date of the financial statements that would require adjustment to, or disclosure in, the financial statements.
