**1. Description of the Plan**

The following description of the Cascade Gasket & Manufacturing Co., Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of ERISA.

**General**

The Plan is a defined contribution plan covering eligible employees of Cascade Gasket & Manufacturing Co., Inc. (the “Company”) except for union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining and certain nonresident aliens who have no earned income from sources within the United States of America. The Company is the administrator of the Plan. The Company has appointed certain members of its management as trustees who are responsible for the management of the Plan. The trustees are responsible for oversight of the Plan, including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The trustees have appointed Voya Retirement Insurance and Annuity Company (“VRIAC”) as custodian of the Plan’s assets.

Employees are eligible to participate in the Plan upon satisfying the following conditions:

**Salary Deferrals.** Employees may begin making elective participant salary deferrals on the first day of the month coinciding with, or next following, the date upon which they satisfy completion of 90 days of service and attaining 21 years of age.

**Safe Harbor Matching Contributions.** Participants may be eligible to receive employer safe harbor matching contributions upon completion of one year of service and attaining 21 years of age. The Company remits safe harbor matching contributions equal to 100 percent of each eligible employee’s salary deferrals that do not exceed 4 percent of the respective employee’s annual compensation. Safe harbor matching contributions are 100 percent vested.

**Contributions**

Participants may elect to contribute up to 100 percent of their compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may also elect to make discretionary profit sharing contributions which are allocated among eligible participants based on proportionate compensation. Eligible participants are eligible to receive an allocation of any discretionary profit sharing contributions if they are employed on the last day of the plan year and have completed more than 1,000 hours of service during the plan year. The Company will determine the amount of the discretionary profit sharing contributions each year, if any. Participants direct the investment of their elective salary deferrals and their allocation of employer contributions into any of the investment options offered by the Plan. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions, and any employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the discretionary employer matching and profit sharing contributions portion of participant accounts is based on years of credited service subject to a six year vesting schedule. After completing two years of service, a participant vests at the rate of 20 percent per year and is 100 percent vested after six years of credited service. Participants will also be 100 percent vested if employed on or after the Plan's normal retirement age, or upon death or disability while employed by the Company.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are collateralized by the balance in the participant's account and bear interest at fixed rates that are determined at the issuance date of each loan by the plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's interest in his or her account or certain partial withdrawals. On termination of service for other reasons, if a participant's vested interest is less than \$5,000 the participant will receive the value of the vested interest in his or her account as a lump-sum distribution; however, if the participant's vested interest exceeds the \$5,000 threshold, the participant may elect to receive either a lump-sum distribution equal to the value of the participant's interest in his or her account or certain partial withdrawals.

**Forfeited Accounts**

At December 31, 2024, forfeited nonvested accounts held by the Plan totaled \$11,395. At December 31, 2023, no material forfeited nonvested accounts were held by the Plan. Forfeited accounts may be used to pay administrative expenses or reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$11,242 from forfeited nonvested accounts.

**2. Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced to zero and a corresponding benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

**3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Pooled separate accounts:** Pooled separate accounts are valued at the unit value as reported by the investment manager of the accounts each day the principal market is open. The fair value of investments in this category has been estimated by the investment manager using the net asset value of the underlying investments, which consist primarily of mutual funds, per unit of participation. The unit value of the Plan’s investments in

pooled separate accounts is not a publicly-quoted price in an active market. There are currently no significant redemption restrictions on these investments.

**Insurance company general accounts:** At December 31, 2024, insurance company general accounts consist of investments in the Voya Fixed Account (4450) investment option which is issued by Voya Retirement Insurance and Annuity Company with no maturity date. Participant-initiated transactions, including purchases and sales, are generally executed on a daily basis and may be subject to certain restrictions. Fair value for financial statement reporting purposes is deemed to equal contract value, or the amount due on demand, due to the short redemption restriction period and evergreen nature of the agreement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Insurance Company General Accounts**

**Voya Fixed Account (4450)**

Voya Retirement Insurance and Annuity Company maintains the Plan's accounts which are invested in the Voya Fixed Account (4450) investment option in its general account. The account is credited with earnings at a declared rate expressed as an annual effective yield as determined by VRIAC and charged for participant withdrawals and administrative expenses. VRIAC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Payment obligations and the fulfillment of any guarantees specified under this investment option are claims supported solely by the creditworthiness of VRIAC.

VRIAC reviews and resets the Voya Fixed Account (4450) investment option's interest crediting rate periodically. As of December 31, 2024, the minimum interest crediting rate was 1.00 percent.

**6. Related Party and Party-In-Interest Transactions**

Certain investments are managed by Voya Retirement Insurance and Annuity Company or affiliates. Voya Retirement Insurance and Annuity Company served as the Plan's investment custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment expenses are included in net appreciation in fair value of investments, as they are paid through fees charged at the investment level rather than direct payments remitted by the Plan. The Plan made direct payments for plan administration expenses totaling \$23,246 during the year ended December 31, 2024. The Company pays directly certain other fees related to the Plan's operations.

**7. Termination of Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

**8. Tax Status**

The Plan has adopted a volume submitter profit sharing plan agreement which the Internal Revenue Service has determined, by a letter dated June 30, 2020, is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the

organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. Delinquent Participant Contributions**

As reported on the supplemental schedule of (II) Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain employee contributions were not remitted to the Plan within the timeframe specified by the Department of Labor, therefore constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024 and 2023. The related lost earnings remittances due under applicable regulations to correct the 2023 delinquent participant contributions were pending payment as of December 31, 2023 and were remitted to the Plan during 2024. The related lost earnings remittances due under applicable regulations to correct the 2024 delinquent participant contributions were pending payment as of December 31, 2024.
