Basis for Opinion

Note 1 – Description of Plan

Araujo Bros. Plumbing & Heating, Inc. (the “Company”) established the Araujo Bros. Plumbing & Heating, Inc. Profit Sharing Plan (the “Plan”) effective January 1, 2000. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more comprehensive description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all employees of the Company, except leased employees, non-resident aliens, and residents of Puerto Rico, who have reached the age of 21 and completed 1,000 hours of service. The Plan is subject to provisions of ERISA.

Contributions – Each year, eligible participants may contribute up to the maximum amount allowed under Internal Revenue Service (“IRS”) limitations, as defined by the Plan. Participants may elect to start, increase, reduce or suspend contributions to the Plan effective as of each pay period. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants may designate a portion or all of their deferrals as Roth deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a qualified non-elective safe harbor matching contribution equal to 3% of eligible compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Company made qualified non-elective safe harbor match contributions totaling \$58,621. The Company may also provide a discretionary profit-sharing contribution equal to a minimum of 2% of eligible compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Company made discretionary profit-sharing contributions totaling \$593,843. The Company will make a prevailing wage contribution for each participant who performs an hour or more of service under a public contract subject to the Davis-Bacon Act. The contribution allocated will be dependent on the participant’s job classification and the hourly rate established by the applicable federal, state or municipal prevailing wage laws. During the year ended December 31, 2024, the Company made prevailing wage contributions totaling \$1,615,441. The Company may make additional discretionary match contributions and qualified non-elective contributions. During the year ended December 31, 2024, the Company did not make any additional contributions.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, (b) plan earnings (c) administrative expenses paid by the Plan. Allocations are based on participant earnings, deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions, Company’s safe harbor matching contributions, prevailing wage contributions and qualified non-elective contributions plus actual earnings thereon. The Company’s discretionary matching contributions and non-elective contributions made to each participant’s account are subject to vesting requirements.

Vesting – Continued – The Company’s discretionary matching contributions and non-elective contributions vest in accordance with the following schedule:

Less than two years	0%
At least two years but less than three years	20%
At least three years but less than four years	40%
At least four years but less than five years	60%
At least five years but less than six years	80%
Six years or more	100%

In the event of death, permanent disability, or retirement, a portion of the participant’s balance that is Company discretionary matching contributions and non-elective contributions account becomes fully vested.

Notes Receivable from Participants – Loans are not permitted by the Plan.

Payment of Benefits – The Plan allows benefits to be paid in the form of a lump-sum payment or installment payments. Upon termination for any reason, a participant may elect to receive a lump-sum payment or installment payments in the amount equal to the value of the participant’s vested interest in his or her account. If the participant has \$5,000 or more in their account, the participant may elect to maintain the account after separation from the Company. The Plan includes provisions that allow the plan administrator to distribute the balance of a participant’s account without consent, in either the form of cash if the balance of the participants vested account balance is less than \$1,000 or in an IRA account if the participants vested account balance is more than \$1,000 but does not exceed \$5,000. Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship. Hardship withdrawals are allowed to be distributed from all fully vested balances, except for the qualified non-elective and safe harbor contribution accounts.

Forfeited Accounts – A participant who leaves the Company forfeits any non-vested balances. The Plan may use such forfeitures to reduce future Company contributions or reallocated as Company contributions. The balance of the forfeited account was \$34,526 at December 31, 2024.

Note 2 – Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Investment Valuation and Income Recognition – Continued – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants’ account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through August 29, 2025 which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Certain information, including investments held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America (“Empower”), a qualified institution. The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Investment Contract with Empower

The Plan's guaranteed interest contract is a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a separate account used solely to satisfy the claims of the contract holder. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issues or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investments guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

Note 6 – Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Empower; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Plan made direct payments to the third party administrator of \$63,743, which was not covered by revenue sharing.

Empower provides certain administrative services to the Plan pursuant to a services agreement between the Company and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the services agreement, Empower remits the excess to the Plan on an annual basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During the year ended December 31, 2024, \$32,570 of investment fees and administrative expenses were covered by revenue sharing. This is included in other income in the accompanying statement of changes in net assets available for benefits.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their accounts.

Note 8 – Tax Status

The Plan has adopted a prototype plan which received an opinion letter dated June 30, 2020, that the prototype plan and related trust are acceptable under section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.



