Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mississippi Methodist Senior Services, Inc. 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subjected to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information and notes receivable from participants and related interest, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Mississippi Methodist Senior Services, Inc. 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is sponsored by Mississippi Methodist Senior Services, Inc. (the "Company") as a defined contribution, tax deferred 403(b) Retirement Plan, which provides retirement benefits for eligible employees. The Plan was established on October 1, 1995 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Benefits under the Plan are not insured under Title IV of ERISA because the insurance provisions do not apply to plans with individual accounts for each participant. The Plan is intended to comply with Section 404(c) of ERISA.

Contributions

All employees are eligible to elect to participate in the Plan on his or her first day of employment. After electing, an employee may contribute either a specific percentage or a dollar amount and have that amount contributed to the Plan on a pre-tax basis, up to the maximum allowable by the Internal Revenue Service ("IRS"). Participating employees may also make Roth contributions up to the maximum allowable by the IRS. The employer does not contribute anything to the Plan. The total elective deferrals in any calendar year may not exceed a certain dollar limit, which is subject to Internal Revenue Code ("IRC") limitations, as defined in the Plan Document. Employees who are age 50 or will attain age 50 before the end of a calendar year, may make additional "catch-up deferrals".

Participant Investment Account Options

Contributions to the Plan are invested into any of the investment funds available under the Plan provisions, in such proportions as the participants direct. Participants may change investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The Plan provides benefits based solely upon the amount contributed to the participant's account and any income, expenses, or gains and losses on investments, which may be allocated to such participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions plus earnings thereon.

Note 1. Continued

Payment of Benefits

Upon termination of service due to death or retirement or if the participant becomes disabled, a participant will receive a lump-sum amount equal to the value of his or her account. A participant may elect to receive a distribution of his rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan. Hardship distributions are also available from participants' elective deferral accounts, subject to regulatory requirements.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Participants may borrow from their account up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Loan terms range from one to five years, with the exception of the purchase of a primary residence. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrator Fees

All administrator expenses of maintaining the Plan are paid by the Plan.

Notes Receivable from Participants

The Plan held notes receivable from participants of approximately \$97,000 and \$50,000, at December 31, 2024, and 2023, respectively. In 2024, the interest rate on notes receivable from participants was 4.25 percent.

Note 3. Assets Certified and Provided by Trustee

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule of assets held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by American United Life Insurance Company ("AUL"), the trustee and custodian of the Plan. The contract value of the guaranteed investment contract was certified by AUL.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- *Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* – Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Annuity funds: Valued at the accumulated unit value of units held by the Plan at year-end, based upon the market value of its underlying investments, which are included as measured at net asset value ("NAV") practical expedient. There are no unfunded commitments. The redemption frequency is daily and no redemption notice is required.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets, other than the guaranteed investment contract (Note 5), are presented at NAV practical expedient; therefore, there are no assets to report in the fair value hierarchy.

Note 5. Guaranteed Investment Contracts

The Plan entered into an investment contract with American United Life Insurance Company ("AUL"). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event that would limit the Plan's ability to transact at contract value with participants is probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The value of the investment contract at December 31, 2024 and 2023, was approximately \$390,000 and \$360,000, respectively.

Note 6. Income Tax Status

The Plan has not requested a determination letter from the IRS to determine if the Plan is in compliance with the IRC and therefore, not subject to tax. However, the Plan was established as a standardized plan and management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, is a qualified plan.

Note 7. Plan Termination

The Plan was adopted with the intent of being permanent. Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If terminated, the value of each individual account will be distributed as described in the "Summary Plan Description" provided to each employee.

Note 8. Related-Party Transactions

The Plan uses AUL as the custodian of the Plan; therefore, any transactions between the two entities qualify as exempt party-in-interest transactions. The Plan paid administrative fees of approximately \$36,000 to AUL for the year ended December 31, 2024.

The Company provides certain administrative services at no cost to the Plan.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued and incorporated events considered significant within the consolidated financial statements.
