**Note 1: Description of the Plan**

The following description of the KanEquip, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of KanEquip, Inc. (the Company). Employees are eligible to participate after completing three months of service and attaining age 18. Part-time employees must reach 1,000 hours of service during a Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Employee Contributions**

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Employer Contributions**

The Company may make a matching contribution equal to a uniform percentage of the employee's salary deferral, which percentage is determined annually at the discretion of the Company's Board of Directors. During 2024 and 2023, the Company matched 25% of the deferral contributed by the participant, up to a maximum of 6% of the participant's compensation, which amounted to \$299,614 and \$285,487 respectively. The 2024 employer match was reduced by \$33,414 of forfeitures for a total deposit of \$266,200. The 2023 employer match was reduced by \$42,999 of forfeitures for a total deposit of \$242,489.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has elected to provide a discretionary contribution for 2024 and 2023 in the amount of \$648,012 and \$1,213,118 respectively. Forfeitures were not used to reduce the discretionary contribution in 2024 and 2023. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

**Participant Accounts**

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan provides vesting in the employer's contributions of 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. An employee who becomes disabled, dies, or reaches age 65 will become 100% vested in employer's contributions.

**Participant Loans**

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their cumulative employee deferrals (except for Roth deferrals) plus rollover contributions, whichever is less. Loans are permitted only for purposes outlined in the loan policy. The loans are secured by the balance in the participants' accounts and bear interest at a rate of Prime plus 1%. Loan repayments are made ratably through payroll deductions no less frequently than on a quarterly basis. Generally, the loan term may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term.

For the year ended December 31, 2024 and 2023, none of the loan balances were deemed to be in default.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the balance is less than \$5,000. For an account balance greater than \$5,000, the participant must authorize the benefit payment distribution. An in-service distribution may be made to a participant with disability or who has attained age 59 1/2. Hardship distributions are allowed on elective deferrals only. Roth distributions are also allowed.

**Forfeitures**

Forfeitures of company matching funds are used to reduce any employer contributions the following year. Amounts forfeited during the years ended December 31, 2024 and 2023 were \$56,887 and \$41,492, respectively. In 2024, the forfeited nonvested account was used to reduce employer contributions by \$33,414. During 2023, \$42,999 was used to reduce employer contributions and \$125 was used to reduce fees. The forfeiture account balances at December 31, 2024 and 2023 were \$66,355 and \$40,191, respectively.

**Note 2: Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of participants requesting distribution but not receiving it until the subsequent year.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants account. Other expense are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Investment Valuation and Income Recognition**

The Plan's investments are presented as determined and certified by Ameritas Life Insurance Corp. (the Custodian) as of the Plan year end. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investments in common stocks, corporate bonds, and publicly traded limited partnerships are valued at the closing price reported on the active market on which the individual securities are traded. Investments in unit investment trusts are valued at the closing price of the underlying assets. Net appreciation consists of both realized and unrealized appreciation (depreciation) on investments bought and sold as well as held by the Plan during the year.

Investment contracts are reported at contract value. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

**Pooled Separate Accounts and Money Market Funds**

Valued at net asset value (NAV) of the shares held by the Plan at year end and are classified in Level 1. These funds are considered open-end mutual funds, meaning the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAV's are received daily from fund managers, and managers stand ready to transact at these quoted amounts. Money market funds are a type of mutual fund or pooled separate account and share in the same valuation process.

**Stable Value Funds**

Valued at fair value and classified in Level 1. Fair value is calculated as the number of units in the account held on a particular date and multiplied by the unit value on that date, generally representing the value that would be paid out for participant-initiated or benefit withdrawals. John Hancock publishes the rates at which interest is paid on the stable value fund. Although the rates may change periodically, monthly or annualized rates are available. To determine the fair value, John Hancock compares the rates in effect as of December 31st to the rates on which the actual interest is determined and the fund is reported at the adjusted value.

**Note 4: Related Parties and Parties in Interest**

The Company absorbs some administrative expenses of the Plan, the cost of audit fees related to the Plan, and the cost of fidelity bonds. The Company provides administrative services on behalf of the Plan. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements. Also, certain Plan investments are shares of proprietary funds managed by the Custodian (or its affiliates). These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Company. Additional party-in-interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, administration fees paid to Tax Favored Benefits, Inc, and investment fees paid to the Custodian. These transactions qualify as exempt party-in-interest transactions.

**Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6: Tax Status**

The Plan Sponsor adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8: Reconciliation of Financial Statements to Form 5500**

The financial statement amounts reconcile with the annual Form 5500 filing to the Internal Revenue Service.

**Note 9: Information Prepared and Certified by Custodian (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian. The custodian certifying the investments was Ameritas Life Insurance Corporation for all of 2023 and 2024. The Plan changed custodians to John Hancock on December 17, 2024, John Hancock provided a certification that the information provided is complete and accurate as of December 31, 2024.

**Note 10: Investment Contracts**

Participants in the Plan had the option to invest in the Ameritas Guaranteed Account in 2023 and part of 2024. The account earns a declared interest rate for new deposits in each calendar quarter. Interest rate guarantees of the account are backed by assets held by the Ameritas general account. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account for new deposits each quarter. The contract value of funds held in the account generally represents principal plus accrued interest. The fair value of these funds reflects the relationship between credited rates earned by funds held in the account and current market rates. Fair value for the account is determined as the present value of future guaranteed account values and participant benefit withdrawals, assuming an annual benefit withdrawal rate of 9%. Present values are derived by discounting future guaranteed account values and benefit withdrawals by the appropriate market interest rates. Market interest rates are deemed to be the same rates to be credited to new issues of the same contract with like guarantees issued as of the date of the fair value determination. Certain events may limit the ability of the Plan Sponsor and/or Plan participants to transact at contract value with Ameritas. Examples of these events would include, but would not be limited to, premature termination of this contract and termination of the retirement plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds. Under no event may Ameritas terminate this contract and settle at an amount different from contract value.

**Guaranteed Investment Contract**

Guaranteed investment contracts are valued at contract value by the insurance company and are not required to be disclosed in fair value measurement hierarchy according to ASU 2015-12, thus are not included in the hierarchy table.
