Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bradford Child Care Services Employee Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. Plan Description

Bradford Child Care Services, Inc. (Company) is a non-profit corporation that operates child care centers in Pennsylvania and a school in West Virginia. On April 1, 2004, the Bradford Child Care Services Employee Retirement Plan (Plan), a contributory defined contribution pension plan, was established for the purpose of providing retirement benefits to all employees of Bradford Child Care Services, Inc.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The accompanying financial statements include only the activity and financial position of the Plan and are not intended to reflect the activities of the Company as a whole.

Contributions

Participants may contribute, pre-tax, a portion of their compensation from one percent up to a maximum allowable by the Plan document and in accordance with other limiting provisions of the Internal Revenue Code (IRC) and other applicable legal limits. Participants may designate contributions as Roth contributions as well. Such amounts shall be deducted from the participant's compensation each payroll period. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employer contributions made to the Plan are discretionary matching contributions. During 2024 and 2023, management elected to contribute a matching contribution totaling 50% of employee contributions, up to a maximum of 4% of the employee's total compensation.

Participants become eligible to make salary deferrals and receive employer matching contributions upon the attainment of age eighteen and the completion of three months of service.

Participant Accounts

Each participant's account is credited with (a) the participant's contributions; (b) the Company's matching contributions; (c) any participant rollovers; and (d) an allocation of Plan earnings and is decreased by any account distributions or losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as well as certain expenses that are directly attributable to the participant. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are always 100% vested in their elective salary deferrals, rollover contributions, transfers, and actual earnings thereon. Participants are also 100% vested in their account upon death, total and permanent disability, or attainment of the normal retirement age. Vesting in employer matching contributions is based on the years of service as follows:

Forfeitures represent participant account balances that are not vested upon the termination of an employee. Forfeited amounts can be applied to reduce employer contributions and pay plan expenses. During 2024 and 2023, \$16,959 and \$2,503, respectively, was forfeited from participant accounts. Forfeitures used to reduce employer contributions during 2024 and 2023 were \$16,987 and \$2,504, respectively. The balance of the forfeiture account at December 31, 2024 and 2023 was \$11.

Notes Receivable from Participants

Participants may borrow at any given time from their account under the terms of and for purposes specified in the Plan document. Participants may only have one outstanding loan at a time and their outstanding loan balance must not exceed \$50,000 or 50 percent of their

vested account balance, whichever is less. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest ranging between 4.25 – 9.50%. Interest rates are based on the Wall Street Journal published prime rate plus 1.0%. Outstanding notes receivable from participants were \$57,753 and \$48,481 as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan had excess contributions payable to participants of \$0 and \$3,980 as of December 31, 2024 and 2023.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any of the choices provided under the Plan. These are determined by the Plan sponsor, and participants may change their investment options daily.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Fees related to the administration of distributions and loans are charged directly to the participant's account and are included as administrative expenses on the statements of changes in net assets available for benefits.

Payment of Benefits

When employment terminates for any reason, distributions will be made in one lump-sum payment or the balance will be rolled over to an individual retirement account (IRA) in the name of that person. Participants with accumulated balances of \$5,000 or less at date of termination shall receive a mandatory distribution of their vested balance and shall forfeit any non-vested funds. Effective January 1, 2024, participants with accumulated balances of \$7,000 or less at date of termination shall receive a mandatory distribution of their vested balance and shall forfeit any non-vested funds. Benefit payments must begin when mandated by federal law.

The benefits provided under the Plan are not insured by the Pension Benefit Guaranty Corporation under the provisions of Title IV of ERISA. The Plan is a defined contribution individual account plan and not eligible for insurance coverage.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting. Delinquent participant loans are reclassified as distributions based upon the terms of the

Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefits are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of December 31, 2024 and 2023.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

Fair values for Level 1 investments are determined by reference to unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access. Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intent to do so, the Board of Directors of the Company has reserved the right to terminate or amend the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

5. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified. In addition, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

6. Information Certified by the Plan's Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as December 31, 2024 and 2023, and net (depreciation) appreciation in fair value of investments, and dividends and interest for the years ended December 31, 2024 and 2023, was obtained by

management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance), the custodian of the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party and Party-in-Interest Transactions

Investment advisory services for the Plan were provided by Mariner Wealth Advisors, LLC and RBC Capital Markets, LLC, during 2024 and 2023, respectively. Recordkeeping services were performed by ADP and investment management services were provided by Reliance for the years ended December 31, 2024 and 2023. Fees charged by individual mutual fund investments are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Fees for recordkeeping, administrative, investment management and advisory services incurred by the Plan are paid through direct payments. The direct payments for administrative expenses paid by the Plan to these parties for the years ended December 31, 2024 and 2023 were \$60,509 and \$52,144, respectively. The Company pays directly any other fees related to the Plan's operations.
