Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Crown Packaging Corp 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A – DESCRIPTION OF PLAN

The following description of the Crown Packaging Corp. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of Crown Packaging Corp., Crown Packaging/Texas, Inc. and Purchasing Consultants Corp. (Company) who have six months of service and are age 21 or older. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was established May 1, 1994. It was most recently restated August 1, 2023 and amended July 14, 2025 (See Note J).

2. Contributions

Each year participants may make pretax or after-tax Roth contributions of up to 60 percent annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, with automatic annual 1% increases up to 6%, and their contributions invested in a designated target fund (based on participant's age) until changed by the participant.

Matching contributions may be made at the discretion of the Company's board of directors. For 2024, an employer match of 55% of the first 6% of pretax compensation was made for eligible employees of Crown Packaging Corp., which amounted to approximately \$1,718,000.

Safe harbor contributions may be made at the discretion of the Company's board of directors. For 2024, an employee safe harbor contribution of 3.3% of eligible compensation was made for eligible employees of Crown Packaging/Texas, Inc. and Purchasing Consultants Corp., which amounted to approximately \$121,000.

Contributions are subject to certain IRS limitations.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching and safe harbor contributions, and Plan earnings. Participant accounts are charged with maintenance fees associated with specific transactions not paid by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant's account balance derived from Company matching contributions shall vest in accordance with a five-year graded schedule as follows:

5. Notes Receivable from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding balance of plan loans (if any) during the prior one-year period, or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates range from 4.25% to 10.50% for loans outstanding at December 31, 2024. Principal and interest is paid ratably through semi-monthly payroll deductions.

6. Payment of Benefits

In the case of normal retirement, retirement due to permanent disability, or termination of employment, participants may elect to receive the value of their vested plan benefits, in accordance with the provisions of the Plan, in a lump-sum distribution or in an alternative manner mutually agreed upon by the participant and the Plan administrator. In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested plan benefits in a lump-sum distribution or in an alternative manner mutually agreed upon by the beneficiary and the Plan administrator.

A participant may withdraw from the Plan that portion of their account resulting from their elective deferral in the event of undue financial hardship.

7. Forfeitures

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$27,910 and \$8,521, respectively. These accounts will be used to pay Plan administrative expenses. To the extent that forfeitures are not used to reduce administrative expenses under the Plan, forfeitures may be applied to reduce employer contributions. Forfeited nonvested accounts of \$30,000 were used to reduce employer match contributions for the plan year ended December 31, 2024.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows.

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Contributions

Contributions from Plan participants and the Company matching and safe harbor contributions are recorded in the year in which the employee contributions are withheld from compensation. The 2024 employer contributions of \$1,838,958 (gross, excluding \$30,000 of forfeited accounts applied) were received by the Plan in September 2025. The 2023 employer contributions of \$1,680,587 (gross, excluding \$20,000 of forfeited accounts applied) were received by the Plan in September 2024.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

6. Excess Contributions

Amounts paid to participants for contributions in excess of amounts allowed by the IRS are recorded as a reduction to contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

7. Payment of Benefits

Benefits are recorded when paid.

8. Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

9. Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

NOTE C – CONTRACT WITH INVESTMENT COMPANY

The Plan entered into an investment contract with Fidelity Workplace Services LLC. Fidelity maintains the contributions in mutual fund accounts. The accounts are credited with actual earnings on the underlying investments and charged for plan withdrawals. The mutual funds are included in the financial statements at fair values as reported to the Plan by Fidelity as of December 31, 2024 and 2023 (see Note G).

NOTE D – INFORMATION CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, Plan management has accepted the certification of Fidelity Management Trust Company as to the accuracy and completeness of the investment information included in the accompanying financial statements and supplemental schedule; and has instructed the Plan's independent accountants not to perform any auditing procedures with respect to such information. Accordingly, the following information was certified by Fidelity Management Trust Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024 and was not subject to any auditing procedures, except for comparing such information with the related information contained in the accompanying financial statements and schedule:

- Investments at fair value and notes receivable from participants as of December 31, 2024 and 2023, which are included in the statement of net assets available for benefits.
- Dividends, interest, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, which are included in the statement of changes in net assets available for benefits.
- Party-in-interest transactions for the year ended December 31, 2024, which are described in Note F.
- All information regarding assets held by the Plan at December 31, 2024, included in the Schedule of Assets (Held at End of Year).

NOTE E – TAX STATUS

The Plan, which is a Fidelity non-standardized pre-approved plan document, has not been submitted to the Internal Revenue Service for an individual determination; however, the non-standardized pre-approved plan document has received the favorable opinion of the Service dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and operates in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is currently not under audit by any taxing jurisdiction for any tax period.

NOTE F – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. At December 31, 2024 and 2023, these investments had a total aggregate fair market value of \$139,563,994 and \$118,180,569, respectively.

For the current fiscal year-end, Fidelity Management Trust Company was the Trustee of the Plan's assets and is considered a party-in-interest as defined by ERISA. As of December 31, 2024 and 2023, the investments managed by Fidelity Management Trust Company totaled \$144,567,757 and \$123,287,572, respectively.

Fidelity provides certain administrative services to the Plan pursuant to a service agreement between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the service agreement, Fidelity remits the excess to the Plan on a quarterly basis. These funds may be used to reimburse the employer for plan related expenses, to pay plan expenses directly, or may be allocated to eligible participant accounts. At December 31, 2024 the unused revenue credit amounted to \$212,000 and is invested in the Fidelity Federal Government Money Market Fund.

These transactions are allowable party-in-interest transactions under Section 408(b)(8) of the ERISA regulations.

NOTE G – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of shares held by the Plan at year end. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds, with fair values of \$144,567,757 and \$123,287,572 at December 31, 2024 and 2023, respectively, are valued within Level 1 of the fair value hierarchy.

NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – PLAN AMENDMENTS AND RECENT LEGISLATION

The Plan was amended effective January 1, 2025 to clarify the definition of compensation. The Plan was amended effective July 14, 2025 to increase the automatic enrollment deferral rate from 3% to 6% of eligible compensation, to increase annual automatic enrollment increases until deferrals reach a cap of 10%, and to allow partial withdrawals for terminated participants.

The SECURE 2.0 Act of 2022 was signed into law in December 2022 to increase retirement savings and improve retirement rules, among other provisions. As part of these provisions, the Plan added Roth contributions effective January 1, 2024. Formal Plan amendments required by the Act are generally not required to be made until the end of the first plan year beginning on or after January 1, 2026.
